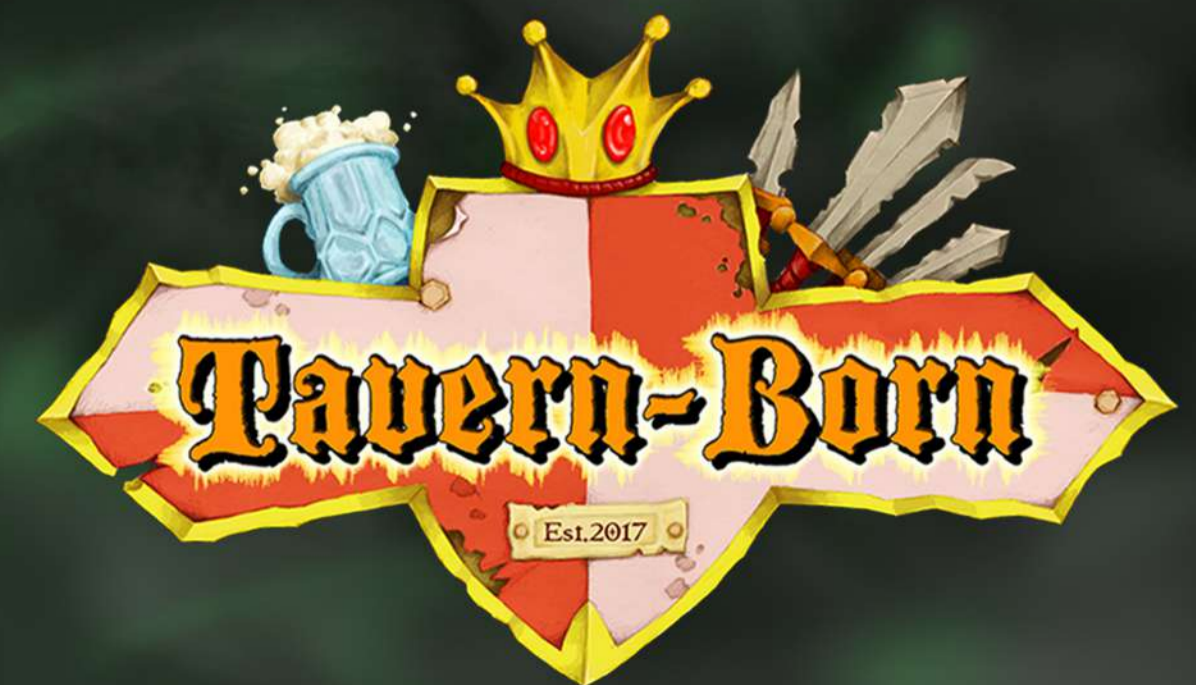

1. Products & Services

1.1 Hobgoblin-3D has developed a number of high quality, affordable 3D print blueprints for the table top games market and chooses to distribute them via their website, or via any 3rd party marketplaces, or retailers at their discretion. By purchasing files from Hobgoblin3D LTD, either directly from their website, via an authorised online market place, or any other retailer authorised by Hobgoblin 3D you are agreeing to the full terms of this agreement.

1.2 Licences. Subject to these terms of use, HOBGOBLIN-3D grants you a non-transferable, non-exclusive, licence to use the .stl files for your personal, non-commercial use.

1.3 Restrictions. Any License rights granted to you in these terms are subject to the following restrictions: (a) you shall not license, sell, rent, lease, transfer, assign, distribute, host, or otherwise commercially exploit the services or materials that you 3D print, 2D print, or manufacture by any other means under this license; (b) you shall not modify, duplicate, create derivative works of, disassemble, reverse compile or reverse engineer any part of the STL files; (c) you shall not access Hobgoblin 3D's services or STL files in order to build a similar or competitive service; and (d) except as expressly stated herein, no part of the services or files may be copied, reproduced, distributed, republished, downloaded, displayed, posted or transmitted in any form or by any means.

1.4 Modifications. Hobgoblin-3D reserves the right to modify, suspend, or discontinue the services, or products or any part thereof with or without due notice at their discretion. You agree that Hobgoblin-3D will not be liable to you or any 3rd party you represent for any discontinuance, suspension, alteration or modification of their services or products or any part thereof, except and if expressly stated in section 09

1.5 Modifications. In the event the .STL files are modified, duplicated, created derivative works of, disassembled, reverse compiled or reverse engineered Hobgoblin-3D would still retain all copyrights of the works and any income or monetary gain of any kind generated from such works would be owed to Hobgoblin-3D LTD in full.

2. Liability, Responsibility, Support.

2.1 Save for death and personal injury caused by Hobgoblin-3D's negligence, Hobgoblin-3D shall have no liability of any kind in any circumstances for any accidents, outcomes or instances that result in injury or death.

2.2 Hobgoblin-3D shall have no liability of any kind in any circumstances whatever to the customer, user or any party they represent in respect of their Software, hardware or Information. In particular, Hobgoblin-3D shall have no liability in any circumstances whatsoever for any data loss or corruption, or for any damage caused to Systems, 3D printers, data storage devices or computers owned by the customer, user or any parties they represent, and the customer, or user agrees that it has sole responsibility for protecting its data and Systems during evaluation of the Software, and that they have full authorisation to use such systems and equipment for the use of downloading, receiving, transferring, storing, exporting and printing the files.

2.3 Hobgoblin-3D has no onus of responsibility for providing support or guidance to the customer and they do so at their discretion. While every effort is made to ensure customer satisfaction, it is expected that the customer has a full working knowledge of their equipment and processes in regard to 3D printing, data management, data security, health and safety. The customer accepts that any advice given by Hobgoblin-3D is in an unofficial capacity and without any weight of authority. Hobgoblin-3D retains the right to refuse support on any of their services, files or products that have been adjusted from the intended state of use.

3. Prices & Payment

3.1 Hobgoblin-3D LTD aims to keep its prices competitively fair, and in line with customer expectations. On occasion Hobgoblin-3D may run promotional offers, discounts, competitions, and freemium content. Hobgoblin-3D reserves the right to refuse, cancel, terminate or suspend any promotional offers at their discretion and have no obligation to the customer to fulfil the terms of a given promotion, or to offer any monetary consolation for unclaimed, invalid or out of date promotional codes, coupons, tickets or any token of any kind relating to past, present or future promotions.

3.2 All payments to Hobgoblin-3D whether through their website, or via a 3rd party vendor or online retailer will be securely processed via paypal. Hobgoblin-3D retains the right to request alternative methods of payment, or to add/remove further payment alternatives to their channels, outlets and services at their discretion.

4. Guarantees & Warranties

4.1 Hobgoblin-3D offers no guarantee that their files will be optimised for every software system, 3D printer or alternative CNC manufacturing device. Every effort is made to test the files on as wide a user base as possible prior to release in order to ensure customer satisfaction. Hobgoblin-3D has no onus of responsibility to update their files to suit outdated or newer systems as technology progresses.

4.2 Hobgoblin-3D guarantees that all their work is 100% genuine, free from defects and professionally designed in house.

4.3 Hobgoblin-3D offers a 30 days returns policy in line with the consumer rights act 2015,. A further 2 weeks beyond the 30 days will be offered for replacement or repairs after which no further warranty will be provided.

5. Returns & Refunds

5.1 Hobgoblin-3D offers 30 days to reject a faulty item and get a refund on any of their digital products. Beyond the 30 days returns period the customer has a further 14 days where an offer will be made to repair or replace the item, if the attempt at a repair or replacement is unsuccessful, the consumer can then claim a refund or a price reduction if they wish to keep the product. Hobgoblin-3D retains the right to refuse a refund in the event of incompatible systems, it is the onus of the customer to ensure that they are purchasing items fit for purpose with their specific hardware.

5.2 In the event a refund is required the customer should contact Hobgoblin-3D via email prior to the end of the 30 days refund period. Evidence of the fault should be documented with screenshots of settings, errors or damages along with a copy of the faulty file, three forms of identification, a concise explanation of the fault, and contact details of the customer. Further evidence may be requested regarding operating systems, 3D printer read outs of errors encountered, or any further evidence which may help support a claim. Hobgoblin-3D retains the right to refuse a refund in the event of incorrect use and insufficient evidence to support the claim, or in the event that the files have been altered from their intended state upon time of purchase. Once a returns claim has been submitted it may take a further six weeks for a decision to be made. In the event that a refund is granted, the payment will be made to the paypal account of the customer, at which time they will be requested to return and delete all appropriate files from their system related to the product in question.

5.3 In the event that a customer is found to be abusing the returns policy Hobgoblin-3D retains the right to pursue the infringement in a court of law for the total amount of damages incurred plus legal costs. Hobgoblin-3D runs a trust based service with it's community, anyone found to be in discord with this trust will be denied access to Hobgoblin-3D's services and products permanently.
