

CONDITIONS OF SALE

1 INTERPRETATION

1.1

- (i) "RNA" means RNA Automation Limited (ii) "the Customer" means the party or parties with whom RNA contracts:
- (iii) "the Goods" means all or any part of the goods, materials, items or products supplied by RNA
 (iv) "Contract" means any contract between RNA and the Customer for the sale and purchase of the Goods
- (v) "the Price" means the price payable by the Customer under the Contract: and (v) "the Price" means the price payable by the Customer under the Contract: and (vi) reference to agreement by RNA shall mean agreement by RNA in writing under the hand either of one of its Directors or its Secretary or of someone authorised by RNA in writing to make such agreement on its behalf
- 1.2 These Conditions apply to and are deemed to be incorporated in every Contract and in the absence of agreement by RNA to the contrary shall be the sole and exclusive terms applicable to every Contract These Conditions and the Contract and the rights and duties of the parties shall be governed in all respects 1.3

- The marginal headings shall not affect the construction of these Conditions.
- 1.5 The Customer hereby acknowledges that the Customer has not contracted in reliance wholly or partly on any prior statement representation or promise made or information given by RNA.

2 SAMPLES

- The Customer shall promptly as and when requested by RNA from time to time a) provide RNA with full complete and accurate details of and information concerning the Customer's operations systems and processes and the purposes for which the Goods are required and the use to which they are intended to be put by the Customer and such further or other information as RNA shall require from time to time in connection with the performance of its obligations to the Customer under the Contract: and supply RNA with such samples of components and parts in connection with which the Goods may be

- RNA disclaims any liability for and shall be under no responsibility, obligation, liability or commitment whatsoever concerning the accuracy of all and any such details and information provided to it by the 2.2 Customer.
- Subject to contrary provision elsewhere in the Contract ownership of such samples shall vest in RNA: where 2.3 Subject to Contract provide receivance in the Contract ownership of such samples shall vess in TV-x, where however the Contract provides that ownership of such samples shall not vest in TN-X then a) RNA shall be under no liability whatsoever for loss, damage or deterioration of any such samples, and b) RNA shall nevertheless be entitled to retain such quantity thereof for such period as it shall decide and

3 SPECIFICATION

- Any service, recommendation, suggestion or advice provided by RNA concerning the Goods whether in technical literature, specifications, drawings. catalogues, price lists or advertising material or in response to specific enquiry is provided in good faith but RNA disclaims any liability therefor and shall not be liable for any loss or damage arising therefrom or from reliance thereon. 3.1
- Where the Goods are designed and/or manufactured and/or supplied by RNA to the Customer's specification RNA shall have no responsibility for or in respect of such specification or its suitability, adequacy, accuracy or otherwise which (as well as any other information supplied by the Customer in relation to the Goods) shall be the sole liability and responsibility of the Customer. 32
- RNA disclaims any liability for and the Customer shall indemnify RNA against all actions of any infringement (actual or alleged) of any patent, copyright, design or other intellectual property rights resulting from compliance with the Customers instructions or requirements express or implied. 3.3

PRICE 4

- RNA shall be entitled to adjust the Price in the event of variation in the cost to RNA of manufacturing and/or supplying the Goods or any part thereof occurring between the date of the Contract and the date of despatch of the Goods by RNA and directly or indered by or incurred or arising as the result of (i) any failure or delay on the part of the Customer in performing the Customers obligations under Condition

5 DELIVERY

- Time for delivery shall not be of the essence of the Contract: all delivery promises or forecasts whilst given in good faith are estimates only and RNA noes not undertake and shall in no event be liable to deliver within any specified period should any delay occur or any reason whatsoever 5.1
- Where the Contract provides for delivery by instalments each instalment shall be deemed to be supplied under a separate Contract and default or defect in the delivery of any one or more of such instalments shall not entitle the Customer to repudiate the Contract with regard to any other instalments remaining deliverable.

6 PACKING AND CARRIAGE

7 GUARANTEE

- Save and subject as mentioned in these Conditions or elsewhere in the Contract if any material or workmanship in any of the Goods shall be found to be defective RNA shall either rectify or replace Its Goods in question at the original place of delivery and in the condition originally specified or (if in RNA's opinion rectification or replacement shall be impractical) credit the Customer with the proportion of the Price attributable to those Goods provided they are returned to RNA and the claim is made in writing and admitted within 3 months from the date of the invoice, or, in the case of goods exported directly by RNA to a place outside UK, within 6 months from the date of the invoice. 71

INSURANCE AND PASSING OF TITLE 8

Although the Customer is at risk, and should insure from the moment of delivery of the Goods, all the Goods shall continue to belong to RNA unless and until the Customer has paid in full everything owed by the Customer to RNA on all accounts. Further, any goods which are held by the Customer at any time and which are derived from or include goods supplied by RNA shall, so long as the Customer owes money to RNA, be kept apart from other assets and upon that separation shall belong to RNA at law. If the Customer does not effect that separation RNA may do it on the Customer's behalf. Unless RNA gives the Customer notice to the contrary, the Customer may, on RNA's behalf, work on, or with or sell goods belonging to RNA even it the Customer has not paid RNA in full, but only in the ordinary course of the Customer's business, and so that all proceeds of said and property for life time being representing the process shall belong to RNA. The Customer will be accountable as a fiduciary to RNA may require the Customer to deliver them to RNA. 10 FORCE MAJEURE DEFAULT BY CUSTOMER AND INTEREST

- 10.1 If performance by RNA of the contract or any part thereof shall be hindered, prevented or delayed a) by any cause whatsoever beyond RNA's control and in particular (but not by way of limitation) by Act of God, war, armed hostilities, fire, flood drought, subsidence, accident, strike, lockout, combinations or workmen, epidemics, sabotage, civil commotion, any act or omission of, or any control, prohibitation or restriction imposed by and government (local or national) or defective or delayed delivery of any material, part or component: or
 - b) by any failure or omission on the part of the Customer of or in relation to the performance of the
 - by any failure or omission on the part of the Customer or or in relation to the performance of the Customer's obligations under Condition 2.1; or by any variation or alteration of the Goods to which RNA may have agreed at the Customer's request then and in any such case (without prejudice to any other remedy available to RNA) RNA shall be entitled to such further or extended time as shall be reasonable in the circumstances and shall be under no liability for any loss or damage thereby occasioned. - 10.2 Nothing in this Condition shall limit the generality of Condition 5 1
- 10.3 If the Customer shall (a) fail to make any payment under the Contract or fully to comply with any of the Customers other obligations thereunder on payment airay act of bankruptcy or make any arrangement or composition with creditors or (b) commit any act of bankruptcy or make any arrangement or amalgamation or reconstruction or have a receiver appointed of any part of its property or undertaking RNA shall be entitled without prejudice to its other rights and remedies) either to suspend further work or deliveries under the Contract, or to require payment in advance for all or any such work or deliveries, or to terminate the Contract forthwith
- Time of payment is of the essence and (in addition and without prejudice to RNA's other rights and remedies hereunder) if payment is not made when due the Customer shall pay RNA interest thereon at a rate 5% over the average base rates of the four major UK Clearing Banks or (if higher) over the official lending rate of the Country where the Customer's principal place of business is located. 10.4
- 10.5 No time or indulgence allowed by RNA shall prejudice any right or remedy which RNA may have hereunder
- The Customer agrees to make any payment due under the Contract or under any other account regardless of any right or set-off or Counter-claim which the Customer may assert. 10.6

11 TESTS

- 11.1 Upon completion of the Goods RNA may before their despatch give to the Customer not less than 7 days notice in writing that the Goods are ready and available for testing in the Customers presence and may specify a place in the UK where and a time and date when a test shall take place.
- 11.2 RNA shall at the appointed place date and time make such tests as it shall consider necessary and appropriate to demonstrate that the Goods comply with the Contract
- If the Customer shall fall to attend at the appointed place date and time RNA may make such tests in the absence of the Customer and the same shall be deemed to be conclusive,
- 11.4 RNA shall make and keep for a reasonable time thereafter notes to record the tests so made and their results
- 11.5 If as the result of such test the Goods shall be found not to comply with the Contract in any respect RNA shall carry out such further work on the Goods as maybe required within such time as shall be reasonable having regard to the nature and gravity of the problem so found.
- 11.6 Upon completion of such tests (and if 11.5 applies such further work) RNA shall be at liberty to deliver the goods in accordance with the Contract and any payments due thereunder on delivery shall be immediately payable by the Customer to RNA.
- 11.7 In the event that the customer fails to make the instalment payment after the Factory Acceptance Test (FAT) in accordance with the contract, or to arrange the shipment of the goods within 14 days from the FAT, then RNA reserves the right to charge demurrage at a rate of 2% of the contract value for every week, or part thereof that the goods remain unpaid for, or not shipped.

12 LIMIT OF LIABILITY

- 12.1 Drawings illustrations and descriptions and particulars of weights measurements ratings and performance figures and other information contained in RNA's catalogues, brochures, price lists and other advertising material whilst having been carefully prepared and put forward in good faith are intended for general guidance only and are not guaranteed; the Customer acknowledges that they do not constitute representations inducing the Contract and Ad ont of form part of the Contract hard and on to form part of the Contract hard hard in representations inducing memory of many such matters.
- 12.2 Save as expressly provided in these Conditions or elsewhere in the Contract RNA shall not be liable for any loss or damage, direct, indirect or consequential whether in contract or tor or otherwise of whatsoever nature or to whomsoever or whatsoever occasioned caused by or arising out of or through any defect in or failure of the Goods or their use or any act or omissions (negligent or otherwise) of RNA or its servants or agents in connection with the Goods or the supply thereof.
- 12.3 RNA shall not be liable for loss or damage to any property of the Customer in which the Goods maybe incorporated or with which or near or in which they maybe used.
- 12.4 RNA's liability for parts or components of the Goods not manufactured by it shall be limited to such warranties or guarantees (if any) as are given by the manufacturer to RNA. Save that RNA shall furnish details of such warranties or guarantee to the Customer and, where possible, use its reasonable endeavours to procure that the benefit thereof is available to the Customer. RNA shall be under no liability in respect thereof.

RNA shall not be responsible for any damage or any claim caused by arising from or attributable whether directly or indirectly to the mode of fixing, fitting or installating of the Goods, by the Customer or by the Customer's own contractor, unless such fixing, fitting and installation. or any of them, shall have been carried out by RNA or strictly in accordance with the instructions, recommendations and directions given by RNA, and the onus of obtaining details of such instructions recommendations and directions shall be upon the Customer. Nothing in the foregoing shall be constructed as imposing upon RNA any obligation (unless expressly assumed by RNA in the Contract) to arrange for the erection, installation or commissioning of the Goods or the construction of any foundations or other civil engineering works or for the installation of electrical wiring and cable work. 12.5
