
Injection Report September 2019

Updated with data from August




Injections for the month of August reached a new all-time high of 89,451 m3/d, up 1.5% from prior month. South Grande Prairie continues to comprise the majority share of the increase, as well as total volume, although there was a noteworthy spike in Southern Alberta injections. 7Gens has resumed disposing to levels unseen since the start of the year with a new record high of 7,730 m3/d for the month. Combined Gold Creek injections for the month total 27,620 m3/d more than offsetting the declines in other Northwest areas. Fox Creek has recovered much of its drop since November of last year with injections in August totalling 14,615 m3/d, bringing total Central region injections to 25,184 m3/d. BC continues to slide with a drop of 2,138 m3/d from prior month, largely attributed to a drop in injections by Encana and Whitecap. This, along with Canbriam's two disposal wells being taken offline in July, has resulted in a significant decline of roughly 1,600 m3/d in Wonowon area injections over the two month perod. South Alberta saw a spike in injections predominantly from one facility, Shell Caroline, with a new regional high of 9,409 m3/d.





With the exception of Catapult, most third party facilities have made declines relative to prior month. Most notable this month was Shell's injections at its Caroline Gas Plant which is currently being transferred to Pieridae Energy; the deal closes this month. The plant disposed 2,511 m3/d of water into it's 6-29 Leduc well, up from its year to date average of ~630 m3/d. We will be keeping an eye out for this one in October. 7Gens continues to push South Grand Prairie injections to new highs as their disposal combined with Pembina Kakwa River reached a new record of 8,865 m3/d. Velvet leaped more than 600 m3/d from prior month to 4,135 m3/d in September, in line with its upward trend earlier this year.





METHODOLOGY:


Areas were divided into four main regions: BC (RED), West (GOLD), Central (BLUE), and South (GREEN). Each region was further subdivided into areas taking into account market, facility location, and road access. The disposal wells included in this analysis were primarily selected based on the producing formation being the Montney/Duvernay but do include other sources (Spirit River, Charlie Lake, etc) that have a material affect on market dynamics for water handling. For the most part, wells that are considered part of an Enhanced Oil Recovery scheme are excluded from this analysis, with the exception of those that are disposing fluid produced from a separate formation.

DEFINITIONS:

'1st Party' volume refers to injections by facilities owned and operated by the producers themselves, whereas '3rd Party' refers to volume from facilities owned and operated by independent disposal/waste companies. 'Facilities' listed in the following charts are either batteries or waste plants that may be tied to more than one disposal well.
