## 1. ORGANIZATION

LiveWorld Incorporated (the "Company") was incorporated in California on April 10, 1996 and reincorporated in Delaware in July 1999. In April 1999 the Company changed its name from LiveWorld Productions to Talk City, Inc. On May 8, 2001, the Company changed its name from Talk City, Inc. to LiveWorld, Inc. The Company's principal business is social customer experience which through a combination of software and human services enable brands to deepen customer relationships through conversations that support their marketing, service, and insight goals. The Company's services and software products include: Conversation Management SaaS platform, adverse events management for the pharma industry, moderation \& engagement services to protect and enhance brands, social customer service to increase customer satisfaction, social listening and analytics, strategy, and media.

## 2. INTERIM FINANCIAL STATEMENTS

The unaudited condensed interim financial information furnished herein reflects all adjustments, consisting only of normal recurring items, which in the opinion of management are necessary to fairly state our financial position, results from operations and cash flows for the dates and periods presented and to make such information presented not misleading. Certain information and footnote disclosures normally included in financial statements prepared in accordance with accounting principles generally accepted in the United States of America have been omitted; nevertheless, the Company believes that the disclosures herein are adequate to make the information presented not misleading. These unaudited financial statements and related notes should be read in conjunction with our unaudited annual financial statements for the year ended December 31, 2017. Operating results for the three months and six months ended June 30, 2018 are not necessarily indicative of the results that may be expected for future periods.

## 3. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation and Use of Estimates - The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States (U.S. GAAP). The preparation of the accompanying financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities as of the date of the financial statements, and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

Cash and Cash Equivalents - The Company considers all highly liquid investments purchased with an original maturity of three months or less to be cash equivalents.

Fair Value Measurements - Fair value is defined as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. Valuation techniques used to measure fair value should maximize the use of observable inputs and minimize the use of unobservable inputs. The accounting guidance for fair value establishes a three-level hierarchy for disclosure of fair value measurements, as follows:

Level 1 - Inputs are unadjusted, quoted prices in active markets for identical assets or liabilities at the measurement date.
Level 2 - Inputs (other than quoted market prices included in Level 1) that are either directly or indirectly observable, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the instrument's anticipated life.

Level 3 - Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The carrying values of certain financial instruments of the Company, such as cash and cash equivalents, accounts receivable, accounts payable and accrued liabilities approximate fair value due to their relatively short maturities.

Concentrations of Credit Risk - Financial instruments that potentially subject the Company to a concentration of credit risk consist primarily of cash and cash equivalents. Bank deposits are held with two financial institutions having strong credit ratings and these deposits may at times be in excess of insured limits. The Company is exposed to credit risk in the event of a default by the financial institutions holding its cash and cash equivalents.

The Company's accounts receivable are derived primarily from customers who have signed contracts with the Company, for the Company to provide services to the customer. The Company performs ongoing credit evaluations of its customers, does not require collateral and maintains allowances for potential credit losses when deemed necessary.

Allowances for Doubtful Accounts - The Company did not record an allowance for doubtful accounts as of June 30, 2018 and December 31, 2017. The Company maintains an allowance for doubtful accounts for estimated losses that may arise if any of its customers are unlikely to make required payments. Management specifically analyzes the age of customer balances, historical bad debt experience, customer creditworthiness, and changes in customer payment terms when making estimates of the uncollectibility of the Company's accounts receivable balances. If the Company determines that the financial condition of any of its customers deteriorated, whether due to customer specific or general economic issues, an increase in the allowance will be made. Accounts receivable are written off when all collection attempts have failed.

Property and Equipment - Property and equipment are stated at cost less accumulated depreciation and amortization. Depreciation is calculated using the straight-line method over the estimated useful lives of the respective assets of three years for computer equipment, software, and for furniture and office equipment. Leasehold improvements are amortized over the shorter of the lease term or the estimated useful lives of the respective assets.

Revenues - The Company recognizes revenues when the following criteria have been met: persuasive evidence of an arrangement exists, the fees are fixed or determinable, no obligations remain, and collection of the related receivable is reasonably assured.

Revenues from service development and community set-up activities are deferred and are recognized ratably over the related development and service portions of the contract. Revenues from on-line community hosting, on-line community management, moderation services, and consulting are recognized as the services are provided.

Cost of Revenues - Cost of revenues is comprised of direct costs associated with the sales of our Strategy, Engagement, Moderation and Insight software and services to clients; the expenses associated with the development, set-up and operation of our services, including expenses associated with server costs for managing the software tools, license fees for our platform; and the cost of providing moderators and any strategic consulting services the client may request from us. These expenses consist primarily of salaries, payroll taxes, benefits and related expenditures for moderation and consulting services, as well as, software license fees, hardware costs.

Deferred Revenues - Deferred revenues are the amounts associated with the initial service development and set-up of a community for our clients and/or prepayments by customers. These service development and set-up revenues are paid upfront but recognized ratably as the development and operational service contract is recognized.

Product Development - Product development expenses consist primarily of salaries, payroll taxes, benefits and related expenditures for technology, software development, project management and support personnel. Costs related to the development of new products and enhancements to existing products are charged to operations as incurred. Software development costs are required to be capitalized when a product's technological feasibility has been established by completion of a working model of the product. To date, completion of a working model of the Company's products and general release have substantially coincided. As a result, the Company has not capitalized any software development costs because such costs have not been significant.

Sales and Marketing - Sales and marketing expenses consist primarily of salaries, payroll taxes, benefits and related expenditures for sales and marketing.

General and Administrative - General and administrative expenses are the combined expenses of the operations, facilities, finance, human resources, legal and other administrative functions. The expenses associated with these functions consist primarily of salaries, payroll taxes, benefits, professional fees, and related expenditures for our overall management and administration.

Stock-Based Compensation - The Company accounts for its stock-based compensation expense based on the fair value of the stock-based awards that are ultimately expected to vest. The fair value of an employee stock option grant is estimated on the date of grant using the Black-Scholes option pricing model, and is recognized as expense on a straight-line basis over the employee's requisite service period (generally the vesting period), net of estimated forfeitures. Forfeitures are estimated at the time of grant and revised in subsequent periods if actual forfeitures differ from the prior estimates.

The Company records the expense attributed to non-employee services paid with stock-based awards based on the estimated fair value of the awards determined using the Black-Scholes option pricing model. The measurement of stock-based compensation for non-employees is subject to re-measurement as the options vest, and the expense is recognized over the period during which services are received.

Income Taxes - The Company uses the liability method to account for income taxes. Under this method, deferred tax assets and liabilities are determined based on differences between the financial statement carrying amounts of existing assets and liabilities and their tax bases. Deferred tax assets and liabilities are measured using enacted tax rates applied to taxable income in the years in which those temporary differences are expected to be recovered or settled. A valuation allowance is established when necessary to reduce deferred tax assets to the amount expected to be realized. Financial statement effects of uncertain tax positions are recognized when it is more-likely-than-not, based
on the technical merits of the position, that it will be sustained upon examination. Interest and penalties related to unrecognized tax benefits are included within the provision for income tax.

Comprehensive Income (Loss) - Comprehensive income (loss) is defined as a change in equity of a business enterprise during a period, resulting from transactions from non-owner sources. There have been no items qualifying as comprehensive income (loss) and, therefore, for all periods presented, the Company's comprehensive income (loss) was the same as its reported net income (loss).

Earnings Per Share (EPS) - Basic income (loss) per share is computed using the net income (loss) and the weighted average number of common shares outstanding during the period. Diluted income (loss) per share is computed using the net income (loss) and the weighted average number of common shares and dilutive potential common shares outstanding during the period. Potential dilutive common shares include outstanding stock options and warrants. The dilutive effect of outstanding stock options and warrants is computed using the treasury stock method. For the three and six month periods ended June 30, 2018, diluted net loss per common share was the same as basic net loss per common share since the effect of inclusion of potentially dilutive common stock equivalents would have an antidilutive impact due to the loss reported. For the three and six month periods ended June 30, 2018 and 2017, options and warrants aggregating 26,385,266 and $28,835,530$ common share equivalents, respectively, prior to the application of the treasury stock method are not included in the calculation of diluted net income (loss) per share as they are anti-dilutive.

## 4. STOCK-BASED COMPENSATION

The 1996 Stock Option Plan ("1996 Plan") provides for stock options to be granted to employees, independent contractors, officers, and directors. Prior to 2004, options were generally granted at an exercise price which approximated eighty-five percent ( $85 \%$ ) to one hundred percent $(100 \%)$ of the estimated fair value per share at the date of grant, as determined by our Board of Directors. Since 2004, options have generally been granted at one hundred percent $(100 \%)$ of their estimated fair market value per share at the date of grant, as determined by our Board of Directors. All options issued under the 1996 Plan and the 2007 Stock Option Plan ("2007 Plan") have a term of ten (10) years, and generally have a vesting schedule such that they vest ratably over four (4) years, twenty-five percent (25\%) one (1) year after the grant date and the remainder at a rate of $1 / 36$ per month thereafter. The 1996 Plan expired in October of 2006 and was replaced by the 2007 Plan.

## Determining Fair Value

Valuation Method - The Company estimates the fair value of stock options granted using the Black-Scholes option-pricing model and a single option award approach.

Expected Term - The expected term of our stock options has been determined utilizing the "simplified" method for awards that qualify as "plain vanilla" options. The expected term of stock options granted to non-employees is equal to the contractual term of the option award.

Expected Volatility - A volatility rate was used as an estimate of the expected future volatility of the Company's common stock. The Company estimated the expected stock volatility based on the historical volatility of publicly traded peer companies for periods that are commensurate with the expected term (in years).

Risk-Free Interest Rate - The risk-free interest rate used in the Black-Scholes valuation method is based on the implied yield currently available on U.S. Treasury securities with an equivalent remaining term.

Expected Dividend - No dividends are expected to be paid.
Estimated Forfeitures - When estimating forfeitures, the Company considers voluntary termination behavior as well as analysis of actual option forfeitures.

The Company estimated the fair value of its stock options using the Black-Scholes option-pricing model, by using the following assumptions for the options granted during the nine months ended September 30, 2016:

Our revenues for the three months ended June 30, 2018 were approximately $\$ 1.7$ million, as compared to approximately $\$ 2.5$ million for the three months ended June 30, 2017. This was a decrease of approximately $\$ 809,000$ or $32 \%$ period-over-period.

For the three months ended June 30, 2018, revenues from our three largest clients comprised approximately $50 \%$ of our total revenues while all other clients represented approximately $50 \%$ of our total revenues. This compares to the three months ended June 30, 2017 where revenues from our three largest clients comprised approximately $66 \%$ of our total revenues and all other clients represented approximately $34 \%$ of total revenues.

Our revenues for the six months ended June 30, 2018 were approximately $\$ 4.1$ million, as compared to $\$ 4.9$ million for the six months ended June 30 , 2017. This was a decrease of approximately $\$ 807,000$ or $16 \%$ period-over-period.

For the six months ended June 30, 2018, revenues from our three largest clients comprised approximately $61 \%$ of our total revenues while all other clients represented approximately $39 \%$ of our total revenues. This compares to the six months ended June 30, 2017 where revenues from our three largest clients comprised approximately $69 \%$ of our total revenues and all other clients represented approximately $31 \%$ of total revenues.

The relationship with our largest client, Walmart ended in the second quarter of this year. They represented $25 \%$ of our total revenues in the quarter as compared to $48 \%$ for the second quarter of 2017. The revenues for the quarter were down approximately $\$ 809,000$ and Walmart represented over $95 \%$ of this reduction, while the other $5 \%$ was related to timing and renewal of projects with other clients.

Additionally, for the six months ended June 30, 2018 and 2017 Walmart represented approximately $48 \%$ and $49 \%$ of revenues respectively. The reduction in revenue period over period was approximately $\$ 807,000$. Walmart represented approximately $94 \%$ of this reduction while
the other approximate $6 \%$ was related to other client reductions offset by increases from new and existing clients and the timing of and renewal of projects with other clients.

## Cost of Revenues

Cost of revenues were approximately $\$ 786,000$, or $46 \%$ of total revenues for the three months ended June 30, 2018, and $\$ 988,000$ or $39 \%$ of total revenues for the three months ended June 30, 2017. This represented a decrease of approximately $\$ 202,000$ or $20 \%$ period-over-period. Cost of revenues for the six months ended June 30, 2018 were approximately $\$ 1.7$ million as compared to $\$ 2.0$ million for the six months ended June 30, 2017. This represented a decrease of approximately $\$ 241,000$, or $12 \%$ period-over-period.

## Operating Expenses

Product Development. Expenditures for product development were approximately $\$ 397,000$, or $23 \%$ of total revenues for the three months ended June 30, 2018, and approximately $\$ 541,000$ or $21 \%$ of total revenues for the three months ended June 30, 2017. This represented a decrease in absolute dollars of approximately $\$ 144,000$, or $27 \%$ period-over-period.

For the six months ended June 30, 2018, the expenditures for product development were approximately $\$ 928,000$ or $22 \%$ of total revenues. This compares to $\$ 1.2$ million in product development costs for the six months ended June 30, 2017 or $23 \%$ of total revenues. This represented a decrease in absolute dollars of approximately $\$ 222,000$ or $19 \%$ period-over-period.

The majority of product development costs are personnel related. We believe our product development costs will increase at a rate relatively close to the increases in revenues for the remainder of 2018. We are committed to our product development efforts and will continue to invest in product development programs. Such efforts may not result in additional new services and any new services may not generate sufficient revenues, if any, to offset expenses.

Sales and Marketing. Sales and marketing costs were approximately $\$ 243,000$, or $14 \%$ of total revenues for the three months ended June 30 , 2018 , and approximately $\$ 705,000$, or $28 \%$ for the three months ended June 30,2017 representing a decrease in absolute dollars of approximately $\$ 462,000$ or $66 \%$ period-over-period.

For the six months ended June 30, 2018 costs related to sales and marketing were approximately $\$ 733,000$ or $18 \%$ of total revenues. This compares to $\$ 1.2$ million in sales and marketing costs for the six months ended June 30, 2017 or $24 \%$ of total revenues. This represented a decrease in absolute dollars of approximately $\$ 465,000$ or $39 \%$ period-over-period.

General and Administrative. General and administrative expenses were approximately $\$ 638,000$, or $37 \%$ of total revenues for the three months ended June 30, 2018, and approximately $\$ 788,000$, or $31 \%$ of total revenues for the three months ended June 30, 2017. This represented a decrease in absolute dollars of approximately $\$ 150,000$, or $19 \%$ period-over-period.

For the six months ended June 30, 2018 general and administrative expenses were approximately $\$ 1.2$ million or $29 \%$ of total revenues. This compares to the approximately $\$ 1.4$ million in general and administrative expenses for the six months ended June 30, 2017 or $29 \%$ of total revenues. This represented a decrease in absolute dollars of approximately $\$ 215,000$ or $15 \%$ period-over-period.

## Financial Condition, Liquidity and Capital Resources

Our total assets were approximately $\$ 2.0$ million as of June 30, 2018, and approximately $\$ 2.8$ million as of December 31, 2017. This represented a decrease of approximately $\$ 831,000$, or a $30 \%$ decrease in total assets. Our cash and cash equivalents were approximately $\$ 1.3$ million as of June 30, 2018 which was a decrease of approximately $\$ 949,000$ or $42 \%$ from the cash and cash equivalents balances of approximately $\$ 2.3$ million as of December 31, 2017.

Accounts receivable was approximately $\$ 445,000$ as of June 30,2018 which is an increase of approximately $\$ 141,000$, or $46 \%$ from the accounts receivable balance of approximately $\$ 304,000$ as of December 31, 2017. Accounts receivable balances are expected to fluctuate with the levels of new client acquisition and enhancement activity and the timing of billings and collections.

For the three months ended June 30, 2018 we had positive cash flows of approximately $\$ 664,000$ while for the three months ended June 30 , 2017 we had negative cash flows of approximately $\$ 96,000$. For the six months ended June 30, 2018 we had negative cash flows of approximately $\$ 950,000$ while for the six months ended June 30,2017 we had negative cash flows of approximately $\$ 789,000$.

We believe that the combination of cash balances and cash flow from operations will be sufficient to satisfy cash needs for the current level of operations and planned operations for foreseeable future.

In the future, we may strategically seek to take advantage of opportunities in the equity and capital markets to raise additional funds in order to take advantage of opportunities that may become available to us, including expansion of operating activities and acquisition of businesses, products or technologies, or otherwise to respond to competitive pressures. Capital scenarios may include but are not limited to public stock issuance, private investment rounds, merger or acquisition and/or privatization. There can be no assurance that we will be able to raise additional capital on favorable terms or at all.

## Off-Balance Sheet Arrangements

We do not have any off-balance sheet arrangements, investments in special purpose entities or undisclosed borrowings or debt. Additionally, we are not a party to any derivative contracts or synthetic leases.
