# Update from the Chairman

It seems to have been a long winter with rain and then snow. However, we are planning the woodland work for this season.

A full bi-annual survey was completed at the end of 2017. This has highlighted some trees requiring remedial work. Apart from these trees, we have had one tree uprooted and an odd branch brought down during the winter. Fortunately, the timber fell within the woodland and caused no problems. These will be attended to this spring. Mr Anderson is in the process of obtaining quotes for the work.

The next phase of our Woodland Management Plan will include some work along the railway line and continuing the area along Beach Road where we were working last year. It is hoped that, if funds allow, we will be able to complete this section this year.

As usual, I will be contacting those neighbours most nearly affected once we have a start date. Julia Keep and I regularly attend the Parish Council Meetings and it has been indicated that we will be able to have the parking cones again this year. The cones were very successful last year in preventing parking at the entrance to Wheal Regent. They will be used during the period of the school summer holidays as last year.

## Savills Update

#### **Woodland Works 2018**

These have been instructed and will entail final clearance of the area along the railway line behind numbers 9, 10 and 10a, as well as completion of the area along Beach Road immediately to the east of the Wheal Regent Park entrance, again to complete this section. These works will be carried out with the continued aim to construct a natural boundary along Beach Road to assist in preventing unwanted encroachment into the woodland area.

#### **Service Charge considerations**

The 2017 service charge accounts are being audited at present and will be considered by the Directors when received and provided for wider discussion at the AGM. The service charge has been maintained at its present level of 5 years and it is felt that it may be prudent to consider a modest increase in 2019, in line with the general trend of increasing costs over this time. This will be considered further in the summer meeting and any such proposals will be presented for discussion and a general vote at the AGM later this year.

The Saplings protected by Plastic tubes, may look artificial, but most are in bud and should be visible later.

A few deciduous trees were blown down, where roots had been unable to have healthy spread.

The Tree Survey has been completed, with observation and action to follow where required.

Many cut or fallen trees have to be removed in the next few months.

Just a reminder...it is always unwise to walk in the woods when wind is gusting, dead branches can fall.

## Parking on Pavements

This is always a thorny issue, particularly when line of sight is restricted by vehicles parked near the blind bends. PCSO Julie Carpenter has advised that "by law vehicles must not be parked within 10 metres of a junction however this will be dealt with under the discretion of the attending officer. Please note though that if there is indeed an obstruction whereupon a vehicle cannot access the public highway from his/her own property then this should be reported to us via 999." Also, it is inconsiderate to block the pavement so that pedestrians have to walk in the roadway. We've all had to pull up on the pavement occasionally .... say, for a delivery...... but it's really discourteous on a regular basis.
