Fran McKeown

Members of HVA and our partners were shocked to learn of the tragic death of our colleague Fran McKeown over the Christmas period.

In the days after we learnt of Fran's death we were overwhelmed to receive many, many, messages of support and tributes from those who knew and worked with her.

These spoke of Fran's determination and creativity, her understanding and commitment to equalities as well as her personal warmth and sense of humour.

At the celebration of Fran's life event on 14th January many tributes were paid and it was an enormous source of comfort and strength for Fran's family to know how much her work had contributed to the Voluntary Sector and the support it offers to local people.

HVA are compiling the tributes we received and will be presenting this to Fran's family.

At times like this words are inadequate to describe a person whose energy and creativity made such a considerable contribution to our



work. But on behalf of everyone at HVA and the Hastings Community Network it is worth reflecting that Fran enabled an inclusive "community voice" to be heard in Hastings and understood that this could be achieved through hard work, passion and creativity.

Fran will be much missed but as someone engaged in community development for so long Fran would want the work she started with Hastings Community Network to grow and develop in the future.

Fran's family have chosen three charities to benefit from donations in her memory – Arthritis Research UK, Hastings RNLI and Hastings District Woodcraft Folk.

"I count myself lucky to have worked with so many friendly, committed and talented people in a worthwhile and interesting role which has hopefully made some positive contribution to the voluntary sector and to local people".

Steve Manwaring, HVA's Director, said "HVA has been very proud to have Rose as a member of our team. During her time with us Rose has contributed immensely to advancing the cause of volunteering in Hastings. Through her efforts many people are making a positive contribution to the Town and developing skills and confidence. We are very grateful for everything she has done".

Community Health Voice for Hastings & Rother

A new group representing the voluntary and community sector in health issues has evolved from the previous Hastings & Rother Health & Social Care Forum, and the group met on 19th December 2012. 'Community Health Voice for Hastings & Rother', as it is now called has a core group consisting of Sarah Corrie, Janet Geering, Roger Sweetman, Clive Mills, Gina Sanderson, Steve Manwaring & Tony Moore. They agreed that the role of the group would be to use community intelligence to help shape and influence local health priorities and to keep abreast of developments in Clinical Commissioning Groups (CCGs) and other related structures.

CCGs will be the new way commissioning takes place for primary healthcare in East Sussex and this group is keen to build meaningful relationships with the Hastings and Rother one.

Hastings Community Network will bring community and voluntary organisations together under this new name to ensure updates and information flows between the new CCGs, emerging Healthwatch structures and Health and Wellbeing Boards.

HVA Membership Renewal

For many years HVA has run an annual membership renewal process which involved posting or emailing you a copy of our latest membership form. To renew your annual membership we asked you most of the same questions that we asked the year before and in return you dutifully replied by telling us most of the things we already knew. We justified this on the grounds that we didn't have another practical way of doing it and because we needed to pick up any change of contact details or variation of the activities we included in our annual directory of groups / organizations.

This year we want to be a bit more efficient in how we carry out our renewal process, so we are going to try and do this online – to avoid us asking you for information we've already got.

Online renewal will show you all the details we currently hold about your organization, presented in a page of our website that only you will have access to. You will then be able to change any bits that are no longer correct.

We will do this by emailing a 'use once only' link to the email address we hold for your organization, together with some explanatory text (and my phone number at HVA).

The link in the email will take you to your organization's details page. You can then read through the current details and make any changes you want before pressing the save button. The only additional things we will need are; the name of the person who made the changes, whether it is ok to publish your organization's details and a confirmation that you comply with our membership criteria before you renew.

For security reasons, the link we send to your organization email address will only let you save changes to your data once and it will also expire after 7 days if you don't use it.

Because this is the first time we are conducting membership online, we would anticipate a few teething problems, but we do feel that learning how to carry out online membership renewal will reduce much of the duplicate effort which groups have faced at annual renewal time in the past.

Credit Union Membership for Groups

Hastings & Rother Credit Union Ltd is pleased to announce that, following changes in legislation in 2012, they are now able to offer membership to local voluntary and community groups. The aim is to provide a true community based banking service for local groups within Hastings, St Leonards & Rother. Such groups are often excluded from mainstream banking:

- Due to their small size
- Because the demands of mainstream banks are too onerous
- Because the offerings by mainstream banks are restricted.

Membership offers local organisations:

- Simple account opening & operating procedures
- A secure vehicle in which to deposit & manage their funds
- Participation as members of the credit union
- A truly personal service
- Potential access to a straightforward loan product (e.g. in the event that fund raising activities have not yet quite reached the required level to meet an immediate need).

Hastings & Rother Credit Union was established in 1999 and now has in excess of 1000 members. It manages over £1million of community funds every year. Benefit Changes

As you have been learning from the TV and newspapers, there are going to be many changes in the way benefits of all types are calculated, paid and organised in 2013. The situation is not yet fully clear but the Government are determined to see these changes through. For some people this may represent a major change, especially in Housing Benefit, Council Tax and variable service charges. One major change will be that many benefits will be amalgamated and paid as one amount direct to you. This will be called Universal Credit and will be paid monthly in arrears. HVA are working with the Credit Union to spread a simple message and would like to bring the following points to your attention:

 The benefit changes may create cash-flow problems for claimants who may be vulnerable to taking out high interest short term loans

- The interest on these loans is punitive and will create debt problems for them
- If people start saving with a Credit Union they can prepare for this change and build up a savings record in oprder to take out a low cost manageable loan when they need to

Surviving Winter Appeal

2011 Census

More data has been released from the 2011 Census, which may be relevant for your work and for any future funding bids.

Population figures show that between 2001 and 2011 Central St Leonards ward experienced one of the highest levels of population growth in East Sussex, with an increase of 1357 people (24% increase).

Central St Leonards also had one of the highest proportions of people of working age (aged 15-64), accounting for 73% of people in the ward, with a decrease of people aged 65+.

Wards in East Sussex with the highest proportion of children and young people include Tressell (24%) and Hollington (23%)

Between 2001 and 2011, the proportion of economically active adults in Hastings has increased by 3.2% to 67.8%.

25.4% (18,649 people) of adults in Hastings have no educational qualifications, a higher proportion than any other district in East Sussex.

Discretionary Rate Relief

Hastings Borough Council are reviewing their discretionary rate relief policy for 2013/14, which may affect charities, CASCs (sports clubs) and other community groups that own or rent a building. Their proposed policy can be found on HBC's website:

Next year, depending on the nature of your organisation, and the building use, Hastings Borough Council may grant your organisation 100% rate relief, or you may have to pay 10%, 20%, 50% or 100% of the rates bill for your building. HVA have been raising awareness of this proposed policy, and have submitted a response to HBC's consultation, which ended on 22 January. The final version of the policy is expected to be presented to Hastings Borough Council's Cabinet on 4th February 2013.

Learning's Not Just For Youngsters

The University of Brighton Hastings OAK programme, offers people over the age of 50, who have not experienced higher education, the chance to take part on a free 15-week course.

Students select their chosen research project with the help of their



tutors and may choose to develop a new skill or study a subject that personally interests them. Starting in February 2013, students are required to attend the Hastings campus for two full days a week.

From April 2013, when local authorities take the lead for improving the health of their local communities, public health budgets will be protected for the first time. The group is being run in conjunction with Counselling Plus Community (formerly Hastings and Rother Counselling Service) and will be facilitated by Eve Ashley who has worked within the NHS for approximately 20 years and has trained in working with groups and couples at the South London and Maudsley NHS Trust and the Tavistock centre for Couple Relations.

Relationship breakdowns can be amongst the most painful experiences of our lives, often resulting in a loss of confidence in our ability to live or cope by ourselves. These weekly groups will provide a place where participants can access mutual support, empathy and acceptance and sometimes new ways of thinking and insight.

Community First

Community First is a Government funded initiative to support community projects in some of the most deprived wards in the country.



Grants of up to £2500 will be available for activities that meet local needs, which will have to be matched by an equivalent amount of volunteering time or donations. The scheme is being run nationally by the Community Development Foundation (CDF).

Within Hastings, three wards have been allocated funding: Castle, Central St Leonards and Gensing.

In each ward, a Panel of local people has been established, and five priorities for funding have been chosen in each area. Hastings Voluntary Action have agreed to be the "Panel Partner" for the three wards, helping each of the Panels to get established and ensuring that they follow the guidance from CDF.

Awards For All England Changes

Projects throughout England now have the opportunity to apply for repeat and on-going activities under Awards for All in a pilot scheme running until the end of March 2013.

Currently Awards for All does not fund on-going, regular or repeat activities, as the programme has focused on 'new' project ideas.

However, in these challenging times BIG are increasingly aware of the pressures smaller groups face with rising costs and cuts to funding, and want to respond to this by looking at alternative ways of funding projects that support those most in need.

Following a successful six month pilot in the West Midlands and Yorkshire and Humber, BIG are now rolling out the pilot across England. This pilot will open out the criteria to all projects where the applicant has an income of less than (or equal to) £30,000 according to their latest accounts.

BIG envisage this pilot running until 31 March 2013. Any applications received for repeat and ongoing activities over this time period, and meeting the criteria above, will be assessed in the normal way.

Hastings Local Plan – The Development Management Plan

The Plan that identifies sites for development and provides specific policies to be used in the determination of planning applications is nearing completion. The final stage of public consultation on the Development Management Plan runs for 12 weeks from 21 January – 15 April 2013.



This stage is different to past consultations and is only concerned with two questions:

- 2. Is it legally sound?
