## **NOTES FOR APPLICANTS FOR Rothschild Awards 2016-17**

### **How are the scholarships awarded?**

Awards worth between £1000 and £2,500 are offered to applicants who intend to take a **full-time undergraduate** or **postgraduate** course at a UK university and can demonstrate outstanding academic credentials, acute financial need and a clear financial plan. Preference is given to academic courses at highly rated institutions. Preference is given to Final Year undergraduates in Civil Engineering courses, or failing that to final year undergraduates in any branch of the Sciences, and to any year of Post Graduate study in the Sciences. In the event that an applicant has not received any response by 30 August, please assume that the application has been unsuccessful. The decision of the Grant judges is final.

### **What must I send to BBUK before my scholarship request will be considered?**

Your application should include:

**a complete application form** as incomplete forms will not be considered.

**a curriculum vitae** The c.v. (maximum length two A4 pages) should start from GCSE levels or equivalent and proceed in chronological order without any gaps to the present. Periods of part-time education, and paid or voluntary work should be included, as should details of involvement in the Jewish community.

**an autobiographical statement** contained within the application form or a **single** side of A4 typed. This should include your interests, participation within the Jewish community, your reasons for taking the proposed course, reasons for being considered for a Rothschild Scholarship and if awarded what impact it would make.

**two current academic references** which **must** be written on the headed paper of the school, university or conservatoire & will be taken up.

**and a covering letter** (maximum length one A4 page) which should include any additional relevant information including details of any relevant disability not included in the application form, c.v. or autobiographical statement.

**A letter of acceptance from the university, or conservatoire** confirming your registration for the year for which you apply for the award will be required before any payment transfer is made

### **How should I complete the Application Form?**

The applicant in person should complete the form. This should be done in black ink and in BLOCK CAPITALS or typewritten.

SECTION 1: Under 'marital status', state whether single, married, partnered, separated, divorced or widowed.

SECTION 3: For each grant or loan applied for, please indicate the current status of the application, the expected amount and the expected decision date.

SECTIONS 4&5: The estimated expenditure and income should be realistic and reasonable.

SECTION 7: If your spouse/partner is also a student, details of his or her course should be stated here or in the covering letter. If the costs of children e.g. childcare are included in section 4, they should be detailed here.

The form must be signed and dated by the applicant themselves.

### **What happens if there is a substantial difference between expenditure and total available funding?**

The scholarships awarded by BBUK range between £1000 and £2,500. You should indicate in section 7 or in the covering letter how you propose to deal with the shortfall.

### **What happens in subsequent years of study?**

The scholarships are for a final academic year, i.e. for a period of nine to twelve months from 1st October 2015.
