### Haiti's First Endowed Community Foundation Fund Established

PORT-AU-PRINCE, HAITI APRIL 13<sup>TH</sup>, 2018- "*Give a man a fish, and you feed him for a day. Teach a man to fish, and you feed him for a lifetime.*" Determined to move Haiti from aid to development, a group of Haitians in Haiti and the diaspora along with some friends of Haiti, came together to establish the first grant making community foundation in the country.

The launch of ACT was announced this morning at an information session in Port-au-Prince with international donors hosted by the U.S. Agency for International Development.

ACT is registered in Haiti and operates as a grant-making community foundation. Registered as 501(c)(3) organization in the U.S., ACT has partnered with The Miami Foundation, the largest community foundation serving Miami for more than 50 years. The fund will provide sustainable support to Haitian organizations in Haiti within three interconnected pillars: environment, civic education, and entrepreneurship.

The Ayiti Community Trust is built on thoughtful and responsible leadership, transparency, and accountability. ACT is governed by a robust board, made up of 25 prominent Haitians and friends residing in Haiti, the United States, and Canada.

With its initial focus on sustainable solutions for Haiti's water challenges, the Ayiti Community Trust believes in innovative, integrated, and sustainable models to improve water availability, accessibility, distribution, and environmental renewal and protection. David Lawrence Jr. Friend of Haiti



### What is a Financial Endowment?

A financial endowment is a donation of money to a nonprofit organization and is structured so that the principal amount is kept intact, while the investment income is available for use. This allows for the donations to have an impact over a longer period then if it were spent all at once.

### How It Works!

The Ayiti Community Trust builds an endowment by soliciting corporate donors and foundation grants. The funds raised will be managed to provide returns and income that support this work in Haiti. ACT donor funds are deposited in The Miami Foundation with its long history of serving as a fiscal sponsor for tax-exempt organizations.

Interest yield from this endowment will be used to fund registered community organizations that have demonstrated or have the potential for significant social impact in Haiti. By identifying, vetting and investing in high-impact and high-potential organizations that can deliver results, we will measurably improve outcomes in our key focus areas of the environment, entrepreneurship, and civic engagement.
