DIRECTIONS DATED 18 FEBRUARY 2015

The Chief Justice has issued the following directions:

- 1. The parties are directed to file short heads of argument (no longer than 15-20 pages) on the following issues:
 - a) whether an order for reinstatement of an employee is competent in circumstances where such employee had resigned prior to the grant of such order;
 - b) whether the dismissal of a review application by the Labour Court, on the basis that the record of the arbitration proceedings is incomplete, is a denial of the applicant's right to fair administrative justice;

- c) who bears the onus/obligation to produce a proper and complete record of proceedings in anticipation of the prosecution of review proceedings; and
- d) what are the consequences in review proceedings when the Commission for Conciliation, Mediation and Arbitration or the parties to the dispute are unable to produce a proper and complete record of the proceedings.
- 2. The short heads of argument referred to in paragraph 1 must be lodged by
 - a) the applicant, on or before 6 March 2015; and
 - b) the respondents, on or before 12 March 2015.
- 3. Further directions may be issued.
