There will not be over-night security and the building will be locked at the conclusion of the trial each night.

WAIT LIST

After the closing date of January 31, 2020, CKC is offering a wait list to fill openings created by entries withdrawn after closing, only if the trial exceeds entry limits as stated above. A maximum of 30 entries will be placed on the wait list. All entries, including wait listed entries, must be received by the trial secretary prior to January 31st, 2020, 5:00 PM. Any entries withdrawn prior to Monday, February 10th, 2020 at 6:00 PM will be replaced by a wait listed entry when available. A full refund will be given for withdrawn entries when a wait listed entry is available to replace the withdrawn entry. Any wait listed entry that does not move off the wait list into the trial by Monday, February 10th, 2020 will receive a full refund. There will not be an AKC online entry wait-list.

CRATING

Crating will be restricted to paddock ring area. There will be NO crating area inside the main arena or the stall area. The use of ex-pens may be restricted to use by multiple dogs. Excess matting beyond crate size will not be allowed. The show site committee reserves the right to alter the crating arrangements for space purposes.

Bleacher seating is available, but due to very limited arena space, the use of personal chairs on the arena floor may be restricted. Persons with disabilities exempted.

CATERING

A concessionaire will be on site with an assortment of foods available for purchase. There will **NOT** be a worker voucher for the food vendor so PLEASE plan accordingly!

VENDORS

WALK-THRUS & OBSTACLES

A walk-through period will be held prior to each class, following the Judge's Briefing. The walk-through is restricted to handlers entered in that class. If a conflict with another ring or other show events is imminent, handlers may request to walk with a height group other than the one their dog is entered, but walking and/or running with an earlier group is preferred

Obstacles will conform to the current requirements of the Aqility Regulations. All jumps are displaceable.

A warm-up area, consisting of a regulation agility jump, shall be provided for all exhibitors. The warm-up area is to be used exclusively for warming up the dog and not for training or relieving of the dog.

DOGS MUST BE ON LEAD AT ALL TIMES OR CONFINED TO A CRATE OR EXERCISE PEN, EXCEPT WHEN COMPETING. OR WITHIN THE WARM-UP RING AREA.

PLEASE CLEAN UP AFTER YOUR DOG!

EXHIBITOR INFORMATION

Dogs qualifying at this titling event, receive credit toward their title. A recording fee is included with entry fees.

JUMP HEIGHT CARDS

All dogs competing in agility must possess an official AKC Jump Height Card. An official AKC Jump Height Card is defined as either a permanent jump height card, a valid temporary jump height form, copies of two different measuring forms (placing the dog in the same height class) dated on or after the dog's second birthday, or copies of three different measuring forms (two of which place the dog in the same height class) dated on or after the dog's second birthday.

Dogs that do not have a valid Jump Height Card must be measured by a judge of record for that trial and will only be effective for that set of trials, excluding the dogs jumping in the 24-inch division. If an AKC Field Representative or a Volunteer Measuring Official (VMO) is present, all dogs that have not been issued a permanent Jump Height Card or temporary jump height (yellow) form must be measured for a Jump Height Card regardless of the jump height entered. If a dog is measured by an AKC Field Representative or Volunteer Measuring Official (VMO) and is now eligible to jump in a lower height class, the measurement is effective immediately for any future runs. This does not apply to a challenge measurement for a permanent jump height card. Misrepresentation of a dog, including altering information on a Jump Height Card, is grounds for misconduct. Exhibitors should carry the original valid official Jump Height Card at each trial to present upon request:

HEIGHT DIVISIONS

Owners are responsible for entering the proper height division. All height divisions will be offered in both the Standard and Jumpers with Weaves classes. Dogs in Preferred classes MUST jump their measured height and may not jump in a higher height or any qualifying scores or placements will be disallowed. Effective, January 1, 2010, a dog that is measured down is now eligible to jump in a lower height class, the measurement is effective immediately for any future runs. This does not apply to a challenge measurement for a permanent jump height card.

CLASSES & CLASS CHANGES

Refer to Regulations for Agility Trials Chapter 2 Section 1 for eligibility.

TIME 2 BEAT CLASS- Regular or Preferred - Open to ALL dogs (no separate levels).

PREMIER STANDARD and JWW - Regular or Preferred - Open to ALL dogs (no separate levels).

After the close of entries, a dog may be moved down in their class level (ie, Master to Excellent). The request for the move to the class for which the dog is eligible must be in writing and submitted to the superintendent or trial secretary at least 30 minutes prior to the start of the trial.

AWARDS

Placement ribbons will be awarded for the first through fourth place in each height division of each class for Standard Agility, Jumpers With Weaves, Premier, FAST and T2B classes (regular and preferred).

All prizes must be claimed the day of the trial. None will be mailed. The club reserves the right to substitute a prize of equal value.

NOTICE TO EXHIBITORS

This trial will be conducted in accordance with the Rules for Agility Trials.

Fees must accompany entries. Exhibitors are responsible for complete, accurate and legible information on their entry forms. Entries are taken on a first received basis. A returned check will invalidate an entry and a \$30.00 service fee will be charged. Subsequent returned checks from the same exhibitor may result in their being put on a CASH ONLY basis for all CKC and or FRAAD events.

Telephoned, Faxed, or unsigned entries cannot be accepted. Entries not on official AKC entry forms and photocopies of entry forms without the agreement and rules on the reverse side of the official AKC entry form are not acceptable. No entry shall be made and no entry shall be accepted which specifies any conditions to its acceptance. Entries sent via express mail service, must be indicated "NO SIGNATURE REQUIRED."

Entries cannot be accepted, cancelled, altered, or substituted after the entries have closed except as provided for in chapter 11, section 6 of the Dog Show Rules. Changes, additions, or corrections to entry forms must be received in writing prior to the close of entries. Those received by telephone are not acceptable. There is no refund for duplicate entries. Every effort will be made to find all duplicate entries, but if the entry has been processed, no refund will be made.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, barred from competition by action of the Trial Committee. Overpayment of entries \$5 and under will not be refunded. Bitches in season are not permitted to enter the trial. Entry fees for bitches that come into season before these trials take place will be refunded provided the Trial Secretary receives notice in writing or thru email 30 minutes prior to the start of judging. A \$5 per day processing fee will be withheld for entries withdrawn due to a bitch being reported in season. Any other withdrawals after the closing date will not be eligible for refund. No entry fees will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, violent acts of nature, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.

Front Range Agility Association of Denver (FRAAD) and Colorado Kennel Club (CKC) may decline any entries for cause and may refuse to receive or may remove any dog on account of disease, viciousness or other cause, and no one shall have any claim or recourse against FRAAD/CKC or any official thereof. FRAAD/CKC and their agents, employees, etc., assume no responsibility for any loss, damage, or injury sustained by exhibitors, handlers, or their dogs, or property and further assumes no responsibility for injury to guests and/or children. This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number, or approved Foundation Stock Service (FSS) breeds, that are eligible to participate. Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Wherever the word "dog" is used in these regulations it includes both sexes. Fees must accompany entries.

Absolutely no puppies under 4 months of age are allowed on the agility trial grounds.

Safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport and that their dogs are familiar with and are able to perform all of the obstacles safely.

All regulations governing the use of this facility, and all regulations and decisions of the trial committee at this trial will be strictly enforced, including and not limited to the recorded information of this premium list. All dogs must be on leash at all times except when in the ring or when in the designated warm-up area. It is expressly understood that the exhibitors alone are responsible for the behavior of their dog(s), guest(s), and children. Any exhibitor whose dog(s), guest(s), and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, will be asked to leave the trial site. In such case, no refund of fees paid will be made.

Judges are not required to wait for dogs. They will adhere as closely as possible to the judging schedule. The owners or handlers of each dog are solely responsible for being ready at ringside when the class is to be judged. The trial giving club and the Trial Secretary have no obligation or responsibility for providing service runners or public address system for the purposes of locating or calling dogs that are not brought to the ringside when required.

"Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations."

There will be limited crating area available inside the building. The Show Site Committee reserves the right to alter crating arrangements for space purposes. Exhibitors are responsible for the conditions in and around their own crate. No dogs will be permitted in restrooms or to stay overnight at the show site.

In consideration of others, you will be expected to clean up after yourself and your dog(s) at the trial site. Your cooperation in this matter is appreciated.

For exhibitors coming from out of state, please remember you are coming to a higher altitude, which can affect health.

Class Changes Effective January 1, 2020

Entering a Mixture of Regular and Preferred Classes Within the Same Trial Weekend – Multiple Jump Heights Within the Same Trial Day

Effective January 1, 2020, exhibitors may enter a mixture of both Regular and Preferred classes on the same trial day and/or during a trial weekend. Any mixture of Regular and Preferred classes is allowed. Please note that if a dog qualifies in Regular Master Standard and Preferred Master JWW (or vice versa) on the same trial day, then NO Double Q shall be earned toward either the MACH or PACH title. The Double Q still requires that Standard Agility and Jumpers With Weaves be either both Regular OR both Preferred on the same trial day.

Additionally, within the same Regular or Preferred classes, a dog may now be entered in multiple jump heights within the same trial day. For example, the same dog may now be entered in 20-inch Master STD/JWW while also entered in 24C-inch Premier STD/JWW on the same trial day.

A <u>separate entry form</u> must be submitted when the same dog is being entered in a mixture of Regular and Preferred and/or different jump heights within the same trial weekend thereby clearly indicating which class(es) and/or jump heights belong together for each trial day of the weekend.

Entering For Exhibition Only (FEO)

As of January 1, 2020, For Exhibition Only may be offered at the option of the host club. FEO will be offered on a one-year pilot basis in order to give AKC time to evaluate its impact. FEO will allow exhibitors to work with their dogs in a trial environment. FEO is only allowed in the Time 2 Beat and FAST classes. FEO will be of value to new exhibitors or exhibitors that are having difficulty with a specific obstacle and/or ring environment. Competitors must enter in T2B and/or FAST. Participation in FEO is non-qualifying.

- FEO runs are treated as trial entries. The exhibitor must enter the class(es) (T2B and/or FAST) prior to
 the closing date, pay class entry fee(s) and the Trial Secretary must record the entry in the Trial Catalog
 as part of the results for that class. FEO does not need to be noted on the entry form; the handler will
 declare the day of the show.
- Dogs may be entered in any jump height for FEO runs. If entered in an ineligible jump height, the team is committed to FEO for that run and must declare FEO on the start line. Day of show jump height changes are not allowed.
- Dogs may be entered in any level of FAST (Novice, Open, Excellent, Master). If the dog is not eligible for
 the level entered, the team is committed to FEO for that run and must declare FEO on the start line. Day
 of show level changes are not allowed.
- The exhibitor must declare FEO in the ring prior to leading out. FEO may be declared earlier (ex. when
 checking in at the gate board).
- Toys are allowed in the ring
 - Toys must be non-audible
 - Toys may not leave the handler's hand
 - Toys that roll freely cannot be used
- Food/treats are not allowed in the ring
- FEO should be utilized for the benefit of the dog and not as a punitive correction. Harsh verbal and /or
 physical corrections shall not be tolerated. Any determination of harshness by the judge shall be
 immediately whistled and the handler will be dismissed from the ring.
- A judge must monitor the entire run. Judges can stop a run at any time

Fix and Go On (FNG)

As of January 1, 2020, Fix and Go On will be offered on a one-year pilot basis in order to give AKC time to evaluate its impact. FNG allows exhibitors to immediately reattempt an obstacle at any time while on course when the dog's performance of an obstacle is not to their expectation. This allows the dog to successfully complete the obstacle then finish the course or leave the ring on a positive note. Using FNG will result in a non-qualifying score.

Fix and Go On is not pre-entered; rather, it occurs during the course of the run.

INSTRUCTIONS TO ENTER VIA AKC'S ONLINE ENTRY SERVICES:

Go to the AKC Agility Online Entry Services home page at www.akc.org/AgilityEntry and follow the instructions there to use your My AKC account to enter this event online. During the first 48 hours after opening, the initial limit of entries designated as either online or paper will be as follows: 175 online entries and the remaining will be paper entries each day. If either form of entry (paper or online) has not filled at the end of the 48-hour time period, the club reserves the right to decrease or increase either one accordingly.

PARKING REGULATIONS

AGILITY TRIAL MOVE-UP FORM

From Chapter 1, Section 20: Move-Up entries will be accepted for dogs that have completed a title after the closing January 31, 2020. Email notification of move ups is acceptable, with return receipt verification from the secretary. Either Move Up forms or emails must be completed and delivered to the Trial Secretary prior to 6 PM, February 10th, 2020 for Friday entries. Move-up entries for Saturday or Sunday must be delivered to the Trial Secretary within 30 minutes of the conclusion of judging of the class they are moving up from. Dogs so moved up will run at the end of the running order. Move-ups can only be accepted if judging limits are not exceeded.

Entry move-up valid only if the dog was already entered in the Event indicated and only if approved by the Trial Secretary.

After the close of entries a dog may be moved down in their class level (eg, Master to Excellent). The request for the move to the class for which the dog is eligible must be in writing and submitted to the superintendent or trial secretary at least 30 minutes prior to the start of the trial.

Dogs who measure into the 24" regular jump height division may not enter 24-choice. Dogs entered in the **Preferred** classes **must** compete at the required jump height and **may not** compete in a jump height division **higher or lower** than their proper height division.

All dogs that have not been officially measured for an **Agility Jump Height Card** may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial or *back-to-back trials* only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the AKC Canine Partners ProgramSM may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.
