You also agree to confirm your 30 hours code by the deadline requested by Newcastle City Council or this will affect your child's additional free 15 hour place or be charged the cost of the nursery place.

<u>For those parents who are not eligible for the 30 hours code</u>: For those who wish to purchase the additional 15 hours the cost will be approximately £70 per week (to be confirmed at a later date).

- 3rd Recent history of attendance by a sibling at Archibald First School.
- 4th Children identified by the appropriate professional bodies as having 'special medical or social needs'.
- 5th The address of the child in relation to the school. (In the event of over subscription the address of a child will be used to make a final decision.)

Please note that nursery admission does not automatically guarantee a place in our Reception Year.

It should be noted that an offer of a place may be withdrawn if information supplied by you on your application is intentionally misleading or fraudulent. I have read the above and undertake to inform the school of any change of circumstances before the end of the Spring Term (Friday 3rd April 2020).
