Governance Structure and Scheme of Delegation

The governing body as a whole is responsible for the governance functions of: ensuring clarity of vision, ethos and strategic direction; holding the school to account for the educational performance of its pupils, and the effective and efficient performance management of staff; and overseeing the school finances and making sure its money is well spent. To manage this work, areas are delegated to committees, the Leadership and Management Committee and the Teaching, Learning and Achievement Committee. An additional small committee takes responsibility for the Headteacher's Performance Management.

The Leadership and Management Committee work closely with the Headteacher to develop and manage overall vision and strategy leading to school improvement. Responsibilities include the school budget, personnel and premises. The Teaching, Learning and Achievement Committee focuses on the delivery of the School Improvement Plan undertaking monitoring and evaluation of the curriculum, educational performance and provision for vulnerable groups, including special needs.

The committees meet every seasonal term and key points and decisions made at committee level are shared with the full governing body which also meets every seasonal term. The terms of this Scheme of Delegation are reviewed at least annually.
