"George could not forget the image of the children. He was concerned about their education and who would help with the cost," said Silver Shield Foundation's Co-Founder James E. Fuchs, who helped Mr. Steinbrenner establish the Foundation, receiving donations from friends and the net income from an annual Yankee Game.



ASSISTING WITH EDUCATION COSTS AND MORE

Since 1982 the Silver Shield Foundation has set aside an educational fund for each surviving child of firefighters and police officers who lost their lives in the performance of their duty, to assist with tuition payments for preparatory/private high school; college/university under-graduate/graduate school; vocational/technical school and tutoring services. Payments are sent directly to the educational institutions and certified tutors. The Foundation also provides many other helpful services and benefits to spouses and children.



THE FOUNDATION'S CARING WING

Covered under the Silver Shield Foundation's caring wing are the children and spouses of firefighters and police officers who make the ultimate sacrifice while members of the Fire Department of the City of New York; Police Department of the City of New York; Port Authority of New York/New Jersey Police Department; New York, New Jersey and Connecticut State Police and all police departments of Long Island and Connecticut.




A VISION FOR THEIR FUTURE
