

Guidelines for Part Bursaries for YYC Residential Courses



The YYC is open to all talented young singers aged 10 - 21 years old, irrespective of financial circumstances. All residential course fees are kept as low as possible but we recognize the fact that some talented young singers may not be able to afford to attend the courses.

We have a very limited number of half bursaries to award for each course, so even applications which meet the criteria may not be successful, due to limited funds available. We raise the majority of the money for bursaries from various Trusts and Foundations.

Bursaries are based on need, and we will have to ask you for information regarding family income and expenditure (including tax credits and other benefits). All information received will be treated with the strictest confidence.

General guidelines:

- Bursaries will be awarded at up to 50% of residential course fees.
- All successful bursary applicants will be required to pay the balance of the fees.
- The bursary application form must be completed and returned with the appropriate supporting documentation
- Total family income and expenditure is the main criteria on which bursaries are decided.
- As a guideline, total family incomes of less than £15,575 are more likely to be award bursaries, over £25,000 unlikely to be awarded.
- Applicants in receipt of free school meals are likely to be awarded bursaries
- Family income levels and supporting documents must be for the current residential course year applied for and documentation issued in the last 3 months
- Any change in circumstances which could affect eligibility for a bursary, even after it has been agreed, must be reported to the YYC immediately.
- Preference will be given to first time applicants for the main bursary scheme.
 Other funds may become available to enable repeat in future years, provided their circumstances are still such that they are still eligible and complete the bursary application process in the normal way.
- The decision on YYC bursaries is final and there is no right of appeal.
