Emma Maltby (nee Rawson) contracted Ewing's Sarcoma, a rare type of cancer usually found in younger adults. She died on 14th May 2003 aged 38, a month before her birthday.

To honour both Emma and her father's memory (who also died of cancer), the Fund which has been set up by her family, is working to achieve lasting benefits for children and teenage cancer patients in Yorkshire, with strong emphasis on providing learning opportunities. Education is an area which is rarely addressed, due to a shortage of funds from the NHS.

Therefore, in an attempt to redress the balance, the Fund has provided the Teenage Cancer Trust unit at St James's University hospital in Leeds with a Learning Mentor for the last five years. The Mentor's role has proved to be so successful and as an increasing number of patients are benefiting from the service, in February 2007 the Fund expanded its service and appointed their second Mentor based on the Children's Wing at St James's University Hospital. Educational support is now given to patients from the ages of 5 to 21.

As well as funding two salaries the Fund also provides bursaries to those patients wishing to further their education at college or university once they have made a full recovery from their illness. Often, the Fund is asked to make a further contribution towards the cost of resources required at the first stage of the course.

Due to the Mentor's position being new to St James's it has meant that a resource bank was required to support the patient's learning. Our commitment to this project is ongoing.

We are very fortunate to have an increasing number of supporters for The Emma Maltby Memorial Fund, constantly helping us to raise our income and our profile not just in Yorkshire but all over the United Kingdom. The Fund is now into its sixth year and in total has raised £800,000. The local support we have had from businesses, charitable trusts and individuals has been very gratifying and has allowed us to fund another Learning Mentor at St James's Hospital, Leeds earlier than expected. The two posts have proved tremendously successful, so much so, that Education Leeds now also funds its own Learning Mentor at St James's.

Our aims going into the future are to continue funding the Learning Mentors at St James's, but also to be in a position to fund further Learning Mentors in other parts of the country. With this in mind, we hope to fund a part-time Learning Mentor at the University College Hospital in London during the second half of 2010.

For young people to be able to continue their education while undergoing treatment for cancer should be a high priority and it is our aim to provide this.

Trustees' Report

The Trustees are pleased to report another successful year for the Fund with the role of the Learning Mentor expanding further and its success now being copied elsewhere.

Since the end of the financial year there have been some changes to the personnel of the Learning Mentors. Zuzana Panuskova returned from maternity leave to the position of Mentor for the 5-13 year age group. Lizzie Hackett, the Mentor for the 13 to 25 year age group, resigned in October 2009 to travel abroad with Bethany Ryder replacing Lizzie, starting in February 2010. Bethany is a BA graduate in German and Italian and has recently worked as a volunteer for the Salvation Army as a Project Leader for pupils with behavioural problems. Bethany has also assisted with an Inclusion Project at Wetherby High School and instigated a

new curriculum for pupils in need of learning and pastoral support.

Our First Learning Mentor, Simon Pini, continues to be associated with the Fund. Simon resigned in November 2009 and took a sabbatical as a research assistant working on projects to improve the overall care of adult cancer patients on a Psycho-Social Research Group based at St James's Hospital. He is now undertaking a PhD in research of teenage cancer patients and the role of the Learning Mentor in hospitals. Simon has this to say about his future:

'Although I am leaving the post I will still be involved in this area. With the support of the EMMF and the University of Leeds I am due to begin a PhD in November 2009, where I will look to provide some research evidence of the experiences of teenage cancer patients attempting to continue their education during treatment. There is very little research into this specific topic and I hope that by doing this project we can move forward the level of support in this area."

The 2008 Midsummer Ball was again a great success with around 400 guests attending with the Ball being the most profitable thus far. The decision was taken to have a year off in 2009 while plans for the 2010 Ball are well under way.

The past twelve months have been another successful year for the charity and we remain well positioned going forward. However, it is fair to say that it was the Fund's most difficult year with the current economic climate resulting in Charitable Trusts in particular seeing their outgoing donations decline as their own income reduced. With the financial climate still in some turmoil, the next twelve months may also prove challenging. It is because of this scenario that we retain healthy reserves and the funding of the Learning Mentors is in place for the next three years.

As our profile nationwide increases we are consistently being approached by organisations for either funding or the provision of Learning Mentors. It would be very easy to agree to these requests and we only wish we could but there has to be balance between our current funding needs and reserves to ensure we are in a strong financial position going forward. Having said that, we feel we have sufficient reserves to support a Learning Mentor at University College Hospital London on a part-time basis. This will inevitably move the charity forward to a national status while widening the level of support.

Income: Our income from charitable trusts was reduced this year due to the current financial climate but remains an important area going forward.

The Emma Maltby Midsummer Ball: The summer of 2008 saw the fifth Midsummer Ball which again proved an outstanding success and thanks must go to the committee. It is very hard work organising such a large event but does provide a good source of income and as important is a very good public relations project.

Third Party Events: This was our most successful area of fundraising this year with a big increase in the number of events and also more importantly the income generated. We would like to thank all of the volunteers for their support and look forward to working with them again and in particular Helen Medd and Helen Chapman for the successful launch of the

"Naughty But Nice" cookbook and we look forward to continued sales.

Gift Aid: Donors are encouraged to complete a Gift Aid Form to increase the value of their donations by 25%.

Funding of Learning Mentors: The cost of funding the Learning Mentors stands at £42,348 per annum. The Trustees' feel that with the reserves in place the Fund is in a position to continue to fund two Learning Mentors with the scope to fund a third position in London.

Expenditure: With the growth of the Fund, there has also been a growth in expenditure, although this has been kept in check.

Bursaries and TCT Projects: The provision of bursaries is one area where the Trustees feel that an increase can be achieved to assist patients in continuing their education.

Website: We have developed a new website over the year and although this was at a cost to the Fund it will aid the Fund going forward and bring in further revenues.

Gap: We are pleased to announce that from October 2009 we have been chosen as the Charity of the year for the GAP stores in Harrogate.

Goals for 2009/2010: If the Fund is to continue to be successful there are a number of matters that need to be addressed in the coming year.

- The IT system needs to be maintained so that it continues to assist the Fund rather than hold it back. This can be seen through the development of the new website.
- Collection Boxes are now in use and have been distributed to local shops and businesses. This increases our visibility as well as raising funds, but there is scope to increase the number of retail outlets where they are displayed.
- To increase our visibility with businesses in the Leeds area and increase the amount of funding that can be achieved from the business community as a whole.
- Payroll Giving: This is an area which has not been developed, but could be important for the Fund going forwards.
- Legacy Programme: As with payroll giving this is an area which needs to be investigated.
- Closer links to the TCT in order to establish where the Fund may be able to assist
 going forward in the provision of further Learning Mentors. To some extent this has
 been achieved in the last twelve months and we look forward to being able to assist at
 the UCH College Hospital in London.
