## Chairman welcomes pewter testing success

ABPC Chairman, Richard Abdy, has welcomed the results of the latest round of testing of pewter by the Sheffield Assay Office. As he has previously reported, the Council has been arranging extensive, independent, tests aimed at demonstrating that pewter products can meet the requirements of the new European Directorate for the Quality of Medicines & Healthcare (EDQM) - Metals and alloys used in food contact materials and articles Regulations.

The last series of tests, by the Sheffield Assay Office, finally established the correct testing methods and measurements and demonstrated that the pewter products tested were, for the most part, fine and did not cause any problems in terms of the new limits.

The exception to these results were pewter flasks which showed results of slightly over the permitted 100mg/kg for tin released into the liquid during storage. Testing of an ABPC member's products had taken place using the testing procedures outlined in the EDQM over a 10 day period, at a temperature of 40° Celsius, using an acidic food simulant.

However it has long been the policy of ABPC members to issue guidelines for use with flasks that recommend a limit of <u>24 hours</u> for storage of spirits. Therefore subsequent tests were carried out in line with the advice issued on the sale of a flask (see box, to right).

Tests carried out after 24 hours following these recommendations were positive and the release limit for tin was comfortably within the required limit. A further test after 72 hours also passed within the required level. Indeed they passed the tests after 72 hours with a result of 3.2mg per litre against the 100mg per litre limit.

The ABPC's interim recommendation to members arising from these test results, therefore, is that pewter items intended to hold liquid sealed inside for any length of time should be should be sold with guidelines similar to those above.

THIS is a genuine British Pewter spirit flask made by craftsmen by traditional methods using traditional materials. Simple preparation and care of your flask will enhance your lasting enjoyment.

- As you would any vessel intended to hold food or drink, wash your flask in hot soapy water and rinse thoroughly before filling with spirits, and again before each refilling.
  After washing, polish the outside surfaces of the flask with a soft cloth to maintain the high polish.
- Avoid storing spirits in your flask for periods in excess of 24 hours.
- Do not fill your flask with effervescent 'mixer' drinks, either alone or mixed with spirits.

Following these procedures will ensure that your favourite 'tipple' remains in good condition and that your flask gives you many years of reliable service.
