"Dealing with Dementia" was launched two years ago by the Institute to expand resources for this critical role.

## FACT SHEET

Dealing with Dementia is a training program developed by the Rosalynn Carter Institute for Caregiving (RCI).

- Provides tips and strategies for caregivers for caring for their loved ones and for themselves
- Implemented in Georgia over the last two (2) years
- The grant (through the U. S. Department of Health and Human Services/Administration for Community Living https://www.acl.gov/) has been extended for one year and will fund Phase Two (national expansion)
- Morton was selected as one of twenty (20) host sites from numerous applications across the country
- Morton was chosen as a partner to provide the training due to Morton's ability to reach a substantial number of family and professional caregivers' (a requirement set by RCI)
- Morton and five (5) other Oklahoma agencies providing caregiver support will receive enhanced training during Phase Two
- The six (6) Oklahoma agencies being trained serve 22 counties in Oklahoma
- Training dates are August 22 and 23 at Morton, 1334 N. Lansing Ave.
- RCI will be providing all the training/materials and materials for all 6 agencies to roll out the training to Oklahoma caregivers
