The committee agree that to increase the amount paid to commoners by any significant amount would require a lot of money to make a difference. The VGS want to fund other projects such as the verge restoration project and supporting the New Forest pony breed. Numbers of animals have gone up in the scheme due to the new BPS, so the payment per livestock unit has gone down. The committee do not want to increase the pot as this would incentivise a further increase in animal numbers.
