





Public EBITDA Multiples over Time




Public Revenue Multiples over Time





LTM Gross Profit Margin %







LTM Revenue Growth %




LTM Revenue per Full Time Employee x 000's
















Revenue Multiples - Dentsu Group Inc.

P/E Multiples - Dentsu Group Inc.






