

### Quarterly FSC-ATMC Meetings

The ATMC holds regular meetings with the FSC on a quarterly basis. At the meeting held on 19 April 2016, the following main issues were raised and discussed:

- Guidance on the use of electronic utility bills to verify physical addresses
- FSC Administrative Penalty Rules Cumulated penalties for late filing of accounts

# Sub-Committees of the Managing Committee



The Managing Committee sets up sub-committees as and when specific issues related to the global business industry arise. These sub-committees comprise members of the Managing Committee, meet as often as required to thrash out issues under concern and present their findings in a report to the Managing Committee. The latter subsequently takes the matter forward with the relevant authorities, as applicable. The following sub-committees are presently live:

- Sub-Committee on CRS chaired by Mr Shahed Hoolash

- > Statutory Filings with FSC Paperless Initiative
- Section 3 Change in Business Purpose
- Section 6 Change in MC/RA
- Statistical Surveys channeled by FSC Consolidated Surveys
- > Multiple Directorship issues
- > Request for more regular meetings with FSC
- Managed companies
- > CRS
- > Grey area in relation to lapsing of GBC license.

A brief of the outcomes of the meeting was communicated to members on 10 June 2016.

### Protocol on the India-Mauritius DTA



Following the signing of the Protocol on the Mauritius-India DTA on 10 May 2016, the ATMC took the following actions:

- (a) On 11 May 2016, an urgent Members' Meeting was convened and which was attended by senior level members.
- (b) On 11 May 2016, a communication was prepared by the ATMC and circulated to members. It aimed at guiding them on the lines along which they could reassure their clients on the fact that Mauritius remains an attractive destination as an IFC along with the prevailing ease of doing business and neutrality of the Mauritian jurisdiction.
- (c) On 12 May 2016, a press conference was organised at Palms Hotel, St Jean Quatre Bornes. The ATMC expressed its views on the signed India-Mauritius protocol. The press conference was well attended by CEOs and Managing Directors of members of the ATMC.

### Meeting with Bank of Mauritius




The ATMC met with the Second Deputy Governor of Bank of Mauritius on 23 June 2016 with a view to discussing several issues that GBCs are facing with banks, including KYC and DD issues, opening and closure of GBC accounts as well as fees and charges, and minimum balance requirements. The Bank of Mauritius has requested the ATMC to convey its concerns formally so that it can take up the issue with the concerned banks.

#### Guidance Notes to supplement the FSC Code of Business Conduct



At the request of the FSC, the ATMC has prepared a Guidance Notes to supplement the FSC Code of Business Conduct which has come into force in January 2016. The draft Guidance Notes is being finalised and will shortly be submitted to the FSC.

### Corporate Social Responsibility



The Chairperson of the National CSR Committee, Mrs Danielle Wong and two Officers of the National Corporate Social Responsibility Committee made a presentation on 06 May 2016 at the ATMC Secretariat. It was emphasized that CSR should not be viewed as an isolated project or a one-off event but as a sustained effort to achieve a set objective. It was also suggested that members of the ATMC might consider teaming up with a Non-Governmental Organisation (NGO) as they have the experience in implementing CSR programmes. The Association will set up a Sub-Committee to look into this matter and will make proposals to the Managing Committee. These proposals will subsequently be communicated to members.

# Review of ACCA Courses calendar

Following requests received from members to the effect that their operations are adversely impacted as a result of study leaves granted to employees during peak periods, the ATMC contacted ACCA course providers to convey these concerns and to request them to consider reviewing their course calendars as follows:

- October February (for March exams).
- January May (for June exams)
- April to August (for September exams) and
- July to November (for December exams)

The Course providers have acknowledged ATMC's request and will, to the extent possible, consider these concerns in respect of forthcoming batches of ACCA students.

- (iii) Workshop organised by Mauritius Cooperation Enterprise (MCE) in collaboration with the Mauritius Information & Technology Industry Association (MITIA) and targeted clusters of the Services sector in Mauritius. The workshop was held on 05 May 2016 at Blue Tower Ebene.
- (iv) Networking dinner hosted by the BPP University Law School UK on 08 June 2016, held at Labourdonnais Waterfront Hotel, Port Louis, during which discussions were held with Professor Julian Davies on the global business industry in Mauritius and the opportunities for Mauritian students undertaking LLB courses.

### Proposed Introduction of Limited Partnership Liability



The Financial Services Commission Mauritius in collaboration with the Ministry of Financial Services, Good Governance and Institutional Reforms, is proposing to introduce Limited Liability Partnerships in Mauritius. To that effect, members were invited to provide their views and comments. These were submitted to the FSC on 20 June 2016.

### Working Group on Takeover Legislations

The FSC has set up a Working Group to look into difficulties met by operators when applying the Securities (Takeover) Rules 2010. The ATMC is represented by Mrs Caroline Leclezio, member of the Executive Committee. The first meeting of the Working Group was held on 13th July 2016. The main areas of improvements in the Rules identified by the FSC include:

- (a) The definition of 'effective control' per Rule 2
- (b) The definition of 'person in concert' per Rule 2
- (c) Mandatory Offer per Rule 33
- (d) Waiver of Mandatory Offer per Rule 34
- (e) Exemptions per Part XI

A communication was addressed by email to all members on 13 July 2016 inviting them to provide details of the difficulties that they are encountering on the application of the Securities (Takeover) Rules 2010 for onward submission to the Working Group.
