# Level 3 Diploma for the Children and Young People's Workforce

**A Children and

This apprenticeship is designed to develop the knowledge and skills required when working with children and young people from birth to 19 years of age. It is relevant to a wide range of job roles in early years and social care settings and is suitable for learners who are working or want to work at a supervisory level in the Children and Young People's Workforce.

## To be eligible – you must:

- Be aged 16 years or older
- Have been resident in the UK/EU for at least three years prior to commencing your apprenticeship
- Be employed in England and have a Contract of Employment
- Work for at least 30 hours per week
- Not currently enrolled onto any other apprenticeship, or another DfE funded FE/HE programme
- Meet a minimum level of English and Maths skills in order to undertake this course

## Training is arranged to suit you

The minimum Guided Learning Hours (GLH) for the Advanced Apprenticeship in Children and Young People's Workforce is 725 hours.

Training takes on average 20 months to complete, however this can be shorter dependent upon whether you have any recognition of prior learning (RPL) or unit/credit exemptions. We will discuss this with you at enrolment.

## Course structure

The course is made up of the following components:

- Level 3 Diploma for the Children and Young People's Workforce - Social Care Pathway
- Functional Skills English, Maths and ICT (Level 2)
- Level 2 Award in Employment Responsibilities and Rights in Health, Social Care or Children and Young People's Settings

## Mandatory Units

- Engage in personal development in health, social care or children's and young people's settings
- Promote communication in health, social care or children's and young people's settings
- Principles for implementing duty of care in health, social care or children's and young people's settings
- Promote equality and inclusion in health, social care or children's and young people's settings
- Support Children and Young People's Health and Safety
- Develop Positive Relationship with Children, Young People and Others Involved in Their Care
- Working Together for the Benefit of Children and Young People
- Understand Child and Young Person Development
- Understand How to Support Positive Outcomes for Children and Young People
- Promote Child and Young Person Development
- Understand How to Safeguard the Wellbeing of Children and Young People

## Optional Units

- Additional units to meet a minimum of 25 credits.

## Social Care Pathway

- Promote the well being and resilience of children and young people
- Professional practice in children and young people's social care
- Assessment and planning with children and young people

## Functional Skills (Level 2)

Everyday English and Maths and ICT to bring skills up to date. This consists of teaching, four tests and three practical assignments.
