FOREWORD FROM THE CHAIR

I am pleased to introduce this year's Greater Lincolnshire LEP Annual Report, which captures the diversity and range of activity undertaken by the LEP and partners, and demonstrates the economic impact we are all making across Greater Lincolnshire.

While the economy is moving in the right direction, there is a need to do more if Lincolnshire is to play a stronger role regionally and nationally. We are focused on investing in order to grow our skills, businesses and infrastructure which, with innovation, will drive Lincolnshire's productivity and wealth.

The good news is that we continue to perform well against the 2030 targets in our Strategic Economic Plan 2014-2030¹. There are currently 4,800 more people in employment in Greater Lincolnshire than in 2014 against the target of 13,000; over 15,000 businesses have been supported against the target of 23,000 and in the three years between 2014 and 2017², the economy in Greater Lincolnshire grew by £890 million in real terms against the target of £3.2 billion.

We exist to promote economic growth, so it is important, as we consider this country's changing relationship with the European Union, that we continue to deliver an environment where business can increase productivity, create jobs and shape the future. Significant infrastructure investment is being made across the area, including Lincoln's Eastern Bypass, Grantham's Southern Relief Road, Boston's Quadrant, East Midlands Trains, and the South Humber Industrial Investment Programme.

This is enabling investments in new schemes such as the Lincoln School of Medicine, the North Lincolnshire University Campus, Skegness Countryside Business Park and the Food Enterprise Zones in Holbeach, Hemswell Cliff and Grimsby. This year we have been busy laying the foundations for a Greater Lincolnshire Local Industrial Strategy which focuses on the actions we must take to develop Lincolnshire's economy of the future. We expect to have developed this during 2019.

Small business is essential to Lincolnshire. We ensure our small businesses can access help and support, and our Growth Hub has supported over 1,258 in the last year. It's been another great year, and I am proud of what we achieved.

The future for our area is full of opportunities and our Local Industrial Strategy will help to release innovative opportunities. I would like to thank all those who contribute so much, our board directors, our staff, Team Lincolnshire Ambassadors and all the members of the numerous strategy boards. The Greater Lincolnshire LEP is a strong and robust partnership.

We have reviewed and improved our governance structures, and this year have welcomed four new Directors, and many other strategic committee and board members. Over 175 experts and leaders give their time across our Boards and committees to join the drive for economic growth and prosperity for all.

We hope you enjoy reading our Annual Report and we welcome any ideas and proposals you have to help enhance innovation and connectivity across the area. Thank you for your continued support and engagement with the LEP and helping to ensure that Lincolnshire is a wonderful place to live, work and thrive.

This is a critical time for the UK economy, with both uncertainty and opportunity. Never has the role of the LEP been more important.

NOTE 2: MATCH FUNDING (INCLUDING VOLUNTARY BOARD CONTRIBUTION)

There is a requirement for the LEP to match fund £250,000 of the core budget with a further £250,000 of match funding. Analysis has shown that match funding of £316,784.48 has been achieved supporting the delivery of the LEP core function.



⁵ As part of year end procedures the Accountable Body reviewed interest calculations and identified an adjustment for an additional £23,763 for Cash balance 3. This will be added within the 19/20 financial year.

ECONOMIC CLIMATE

Greater Lincolnshire is a diverse economy that has more larger land based and manufacturing sectors than other parts of England.

Total GVA output currently stands at £21.5 billion⁶. Growth in Greater Lincolnshire has typically been lower than average due to the structure of the economy and predominance of traditional, and labour intensive industry sectors. Greater Lincolnshire is home to just under 38,000 VAT/PAYE registered businesses, as well as over 69,000 self-employed with over 99% of our registered businesses categorised as small and medium enterprises.

It is a very large area, measuring over 110km from north to south – the same as from Peterborough to Westminster, and with a population density less than that of Cornwall.

Lincolnshire's GVA growth remains relatively strong after 2016's contraction, and slower growth in employment has meant that levels of productivity have risen. Exports grew by £1.8 billion this year, house building rates rose for the first time in two years, and wage growth continues to outpace the national average across the area.

HIGHLIGHTS AND KEY ACHIEVEMENTS **LOCAL MODERN INDUSTRIAL STRATEGY**

This year we have been laying the groundwork in developing a Local Industrial Strategy for Lincolnshire. We are seeking to agree an industrial strategy with Ministers, setting out joint commitments between Government and local leaders to develop the Lincolnshire economy. The LEP has been tasked with developing the plan on behalf of the region. In January we published a prospectus for the industrial strategy, signalling that we are ready to start formal engagement with Government on its proposals and inviting local people, businesses and other organisations to give their views on the priorities.

OUR VISION IS TO:

- Be home to a world leading agri-food industry, developing and demonstrating new technologies and being the envy of our global competitors.
- Drive our unique natural resources to act as a test bed for energy and water, reduce costs and environmental impact, and identify cutting edge solutions for commercial models of energy generation and storage.
- Further develop and implement new ways to support the health and care of people who live in hard-to-reach areas, and support people through innovative ways to live well and independently for longer.

OPPORTUNITIES AND FRAMEWORK DOCUMENTS PUBLISHED JAN 2019

- Support a high-profile, high-quality tourism industry, supporting innovation across tourism services and facilities to transform into a modern, culturally and creatively vibrant visitor economy.
- Drive an efficient, highly skilled ports and logistics industry through developments in technology and automation with new methods of delivering goods and services, supported by a strong workforce including technicians, programmers and engineers.

To achieve this we want to equip people Greater Lincolnshire to transition to an automated, digital, and fast-changing environment, where digital advances and automation will be game changing.

The development of this strategy has been a key focus for 2018-19 and will continue to be a high priority until the end of the year.

IMPLEMENTING THE NATIONAL LEP REVIEW

The role and responsibilities of LEPs including the Greater Lincolnshire LEP have grown significantly since formation in 2011.

The implementation of government's Strengthening LEPs Review, changes to the national political landscape, Brexit, and the Industrial Strategy, bring both opportunities and challenges for LEPs.

The Greater Lincolnshire LEP has always ensured that good governance is embedded and this has been widely recognised across government.

In response to the review we have recently updated and republished a number of key documents to further strengthen our governance to include; a comprehensive Assurance Framework; newly adopted Articles of Association; and a Financial Statement and an Annual Delivery Plan. All can be found on our website **www.greaterlincolnshirelep.co.uk**

Significant changes have also been made to the LEP Board addressing gender balance, strengthened private sector representation, increased diversity, and supported by an independent secretariat. We now have a 33% female Director representation on the LEP Board, along with both an SME and Diversity Champion.

STRATEGIC ECONOMIC PLAN 2014 - 2030TO DATE THE

The first Strategic Economic Plan (or SEP), was published in 2014 with the refresh completed in the Spring of 2016 to reflect a changing economic and political climate.

It details how we can grow the Greater Lincolnshire economy and increase productivity, and remains the principal strategic document for Greater Lincolnshire to provide evidence, attract funding, and ensure a cohesive approach to economic development for all stakeholders. We will be refreshing this strategy to align with the Local Industrial Strategy later this year.

THE SINGLE LOCAL GROWTH FUND (SLGF)

Growth Deals provide funds to local enterprise partnerships for projects that benefit the local area and economy. Our Growth Deal totals £123 million and runs until 2021.

The LEP currently holds contracts to the total value of £310 million with an agreed grant contribution of £101 million in Growth Deal funding, which levers in a further £209 million of investment through delivering 29 major transformational growth projects across Greater Lincolnshire.

Some recent examples of these include:

AGRI-FOOD AND MANUFACTURING

Our three Food Enterprise Zones in Holbeach, Hemswell Cliff and Grimsby, are creating employment facilities specifically designed to support the growth and expansion of our strategically important agrifood/tech clusters and supply chains, with the award winning Peppermint Interchange already complete, and works starting this autumn on the Agri-Food Centre of Excellence building at Holbeach.

HEALTH & CARE

A new Medical School in Lincoln will link closely with the newly launched National Centre for Rural Health & Care and the Lincoln Institute for Health. This highquality 5,682m² integrated clinical facility that will drive skills development across the fields of medicine and allied health subjects, is providing the platform to grow the scale and diversity of existing provision from professional development to post-graduate qualification.

SKILLS

Our Skills Capital Investment Fund Programme is delivering high-quality skills provision within our priority sectors, with a strong focus on digital technologies - as demonstrated at the brand new Digital Skills Centre at New College Stamford, and the emerging Digital & Professional Skills Centre at Lincoln College in partnership with Risual Education Ltd and Microsoft.

We are also investing in the creation of an exciting new university led Technology & Innovation Centre at Grantham in partnership with South Kesteven District Council, Invest SK and the University of Lincoln which will open this autumn. We are also investing in transforming Scunthorpe's Civic Centre into a dedicated university campus to inspire and raise the aspirations of children and young across our area.

INFRASTRUCTURE

Work begins on site for Phases 2 and 3 of the £80 million Grantham Southern Relief Road scheme this summer and key infrastructure investment into Scunthorpe Town Centre has helped transform the Church Square and surrounding area.

Boole Technology Centre, Tentercroft Street Growth Corridor, Bishop Burton Riseholme College (Showground Campus), Peppermint Interchange, Sutterton Roundabout, Lincoln Transport Hub, Digital Skills Centre at New College Stamford and eight of the nine Unlocking Rural Housing projects have all been completed and are now successfully contributing to the local economy.

PIPELINE PROJECTS

Within the 2018-19 period this year, Greater Lincolnshire developed a clear position on prioritisation of future Pipeline Projects which will contribute to the delivery of the SEP and the LIS, and a group of strong schemes has been identified which can quickly respond to both new funds arising and projects being required to replace stalled schemes.

It is expected that post Brexit, a new UK Prosperity fund will be launched by government, and having a strong LEP pipeline of schemes for short, medium, and long term delivery and meeting specific economic strategic criteria for the fund, is essential. "We are committed to boosting economic growth across the Northern Powerhouse, Midlands Engine and the UK as a whole."

EUROPEAN FUNDING (ESIF)

The European Funding Programmes (European Regional Development Fund (ERDF), European Agricultural Fund for Rural Development (EAFRD) and LEADER) have committed over £61 million to Greater Lincolnshire projects. Over 3500 enterprises have received support across Greater Lincolnshire with 2187 business and properties now benefiting from reduced flood risk. Funding has additionally helped to support 19 large scale transformational projects focused around our priority sectors, supporting activity in research and innovation, enhancing access and use of ICT, SME competitiveness, a shift towards a low carbon economy, climate change adaption and risk prevention and management, preserving and protecting the environment, and promoting resource efficiency.

Greater Lincolnshire European Structural and Investment Fund (ESIF) Programme has funded projects in support of business growth, economic infrastructure and skills.

THE EUROPEAN REGIONAL DEVELOPMENT FUND (ERDF)

This fund, which focuses on larger, more strategic schemes helps to support our areas priority sectors.

To date we have contracted over £43 million of ERDF funding in support of 19 transformational projects. Projects range from; supporting innovation centres in the agrifood sector; rolling out superfast broadband coverage for up to 97% of the county; providing comprehensive business support to SMEs across Greater Lincolnshire; boosting renewable energy use in SMEs; supporting sea defence projects to protect Lincolnshire homes, businesses and land from future flooding; and developing biodiversity schemes to protect our natural environment. A further £22 million of projects are currently under consideration.

THE EUROPEAN AGRICULTURAL FUND FOR RURAL DEVELOPMENT (EAFRD)

Combined with our more locally led LEADER programmes, this fund is targeted at investment in business diversification, food processing facilities, rural tourism, culture, heritage and rural services has also benefited many businesses with over £9.7 million of grants awarded to date.

THE RURAL DEVELOPMENT PROGRAMME FOR ENGLAND (LEADER),

Targeted at investment in business diversification, food processing facilities, rural tourism, culture, heritage and rural services has also benefited many businesses with over £4.8 million of grants made to date.

EUROPEAN SOCIAL FUND (ESF)

The LEP developed £18 million of skills and training projects for the Education and Skills Funding Agency, to create projects that would address particular challenges.

A comprehensive programme of skills and training began in 2017 and completed in 2019. The programme was made up of; Skills Support to the Workforce; Skills Support to the Unemployed; Support for young people aged 18-24 not in education, employment or training (NEET); Skills Advisor Programme; and The World of Work website.

INVEST & GROW

Our £9 million rolling infrastructure Growing Places Fund (Invest & Grow) is designed to unlock stalled housing and commercial developments. No new loans were made during 2018/19 but Expressions of Interest were received. Project applications remain open for this fund.

FINANCIAL SUMMARY

Following the repayment of a loan by Stokes café and existing loan interest received the balance available for loans is £3 million. No new loans were made during the period but expression of interests have been received and the LEP remain open to applications for eligible projects.

Within the Invest to Grow cash balance 2 other funds have been created; the Feasibility Fund and the Business Investment Fund.

FEASIBILITY FUND

Our feasibility fund seeks to accelerate new investment opportunities and increase economic activity across Greater Lincolnshire. To date we have contracted with 9 applicants, awarding £306,500.

At the beginning of the financial year the total feasibility fund held was £288,172. Within the year £31,566 was added to create a larger fund of 319,738 which was split into 2 distinct funds:

Within the year, one contract has withdrawn to a value of £50,000 and one project remains un-contracted at £20,000. Other projects have underspent against their agreed contractual values. £98,299 has been paid to contracts within the financial year and estimated spend in 2019/20 will be £51,560.40. Following in year activity the funds have been realigned and now are:

GROWTH FUND

The Greater Lincolnshire Growth Fund was launched in October 2017 to support the private sector businesses operating in one of the LEP's priority sectors and to add value to other existing funding streams.

Almost £3 million of grant funding has been made available to both small and medium enterprises (SMEs) and larger businesses within the Greater Lincolnshire area who can deliver transformational projects which align with the wider economic ambitions of the Strategic Economic Plan. Five projects have recently been awarded.

COASTAL COMMUNITIES FUND

This year, the Greater Lincolnshire LEP was successful in our bid of £370,000 to support the Coastal Communities Fund for the coastal careers and skills programme on the Greater Lincolnshire Coast.

This will establish a Coastal Business/ Provider Forum, supporting strategic and collaborative work with local employers and providers developing a local skills offer. This forum will harness leadership of key anchor employers that already offer year-round employment to the benefit of the wider economy and will begin later this year. "This is fantastic news for tourism businesses on the Lincolnshire coast and for local residents working in the sector or looking to begin their career in tourism."

EMPLOYMENT AND SKILLS

The LEP has continued to play an important leadership role in the broader skills system and was one of five LEPs in the country to be invited to take part in an adult training pilot with the Department for Education. Results will feed into the future National Retraining Programme and are expected later this year.

We were also invited as one of seven LEPs to shape the SAP Programme. This involves developing a set of roles and responsibilities for local Employment and Skills Boards (or Skills Advisory Panels) and working with analysis at the Department for Education to agree a process for a new Skills Analysis, set to map the demand for and supply of skills and qualifications.


The SAP Programme has now been rolled out across the country and the Greater Lincolnshire Employment and Skills Board has commissioned the skills analysis that will be published later this year.

The skills analysis will underpin the 'People' section within the Greater Lincolnshire LEP's Local Industrial Strategy (LIS).

The LEP began working with the national Career and Enterprise Company to roll out the Enterprise Adviser Network programme in September 2018. The programme aims to match local secondary schools with businesses and employers to help support careers programmes for young people. Our first Enterprise Coordinator was recruited in September 2018 to help develop this network of businesses, and two further Enterprise Coordinators will join the team over the summer 2019 with the support of Lincolnshire County Council and District Councils. There are 54 secondary schools across Lincolnshire, requiring matching business leaders and we are busy encouraging businesses to get involved. We have continued to work with the Education and Skills Funding Agency on the skills and training ESF Opt-In Programme, and have successfully extended projects that were due to end in July 2018 for a further 9 months. We have supported over 2000 businesses to develop new skills, and our Industry Educator project - delivered by Bishop Grossteste University, and which supported over 200 people from local industry to deliver training in colleges, has been highlighted nationally as an innovative project and paved the way to other areas developing similar models.

The Skills Capital Investment Programme which was developed by the Employment and Skills Board last year to ensure that FE colleges have improved facilities to deliver technical and vocational training, has culminated this year with a number of awards being made. This includes the Digital Skills Centre at New College Stamford, and the Engineering, Manufacturing and Agri-Tech Centre at Boston College (EMAT).

The recent announcement that the University of Lincoln, working in collaboration across the whole of the LEP area with FE colleges, has been successful in its bid for an Institute of Technology is fantastic news for the area. This will bring additional funding to develop new facilities for training in agri-tech, engineering, food manufacturing and digital across the area and provide local people with new opportunities to develop higher level technical skills.

Our Business Lincolnshire Growth Hub is a single place to go to for business experts and mentors, support and guidance, grants and finance.

This countywide service supports any business looking for support to grow and become more competitive. We are very proud of our success stories and unrivalled reputation in this area where we are known for exceeding our targets and delivering high customer satisfaction.

The Business Lincolnshire Growth Hub **WWW.BUSINESSLINCOLNSHIRE.COM** offers easy access to one to one, fully funded impartial advice.

Our experts provide specialist advice on; accessing finance, resource efficiency, supply chain development, digital, innovation, and exporting, as well as specialist support in our priority sectors.

Businesses which have accessed the Growth Hub's support, particularly through face to face support, have been continuously developing and growing their businesses, and this year, 243 new jobs were created.

We also offer Scale Up Workshop Programmes including coaching, business workshops, briefings and flagship events, online information guides and self-help tools and a grant support scheme finder.

The Growth Hub also provides access to the National Business Support Helpline via phone or online webchat, facilitated access to the national programmes including; Department for International Trade, Intellectual Property Office, Innovate UK, Enterprise Europe Network, and access to outreach programmes such as enterprise, innovation and incubation spaces across the county, which provide services such as virtual office, hot desk facilities, meeting rooms, and networking events.

We also run a network of technology hubs, where businesses can access state-of-the-art equipment like 3D printers and scanners, and laser cutting equipment to help with design, prototyping and small-scale fabrication as well as digital motion capture equipment used to quantify precise movement and human-equipment interaction.

SECTOR DEVELOPMENT

This year has seen progress in our priority sectors to include the launch of the business Growth Fund to support this.

The agri-food sector continues to influence and engage regularly with government and hosted their annual event in the House of Commons, influencing MPs on the importance to the industry of some critical issues including; workforce supply and skills; trade; and infrastructure.

Greater Lincolnshire supports the UK's largest and most progressive agri-food sector, based on dynamic businesses, strong innovation, and well developed supply chains. Our local businesses are national leaders in this growing sector and the University of Lincoln now has the largest agri-food robotics team in Europe. Over 30% of all UK food transport travels through or starts in Lincolnshire and the food chain provides 24% of Greater Lincolnshire's jobs (13% nationally) and 21% of its economic output. We are the largest processor of fish with 70% of the UK market, and produce over 25% of the potatoes and vegetables and are a major producer of value-added processed food.

Progress has continued on the three Food Enterprise Zones with the Peppermint Park Interchange not only completing, but winning a regional engineering award.


Lincolnshire's manufacturing sector is worth £4.1 billion, and we excel in a wide range of areas, such as metals and composite manufacturing, electrical machinery, and food and drink packaging equipment.

This year in collaboration with the University of Lincoln and 6 transnational partners from 3 other European countries, an Interreg Funded programme CoBot project called COTEMACO (Collaborative robots within Agrifood/ Manufacturing environments) has been launched. The project will help Lincolnshire' manufacturing SMEs to explore how robotics can help them meet the challenges they face in maintaining their cost competitiveness against large-scale production facilities in low-wage economies.

In December 2018, we launched the WWW.PROMOTELINCOLNSHIRE. CO.UK website, to include newly content and promotional 'Let's Shout About Lincolnshire's pages. The Visitor Economy Board has also been active in commissioning and publishing a Hotels Study and the LEP hosted our first ever Heritage Works Visitor Economy Conference.

An energy focus group has been co-ordinated and an Energy Strategy has been developed, and will be published shortly. Meanwhile a new Health and Care Board pilot was inaugurated, with recruitment for a permanent board to drive activity in this field arising from the Local Industrial Strategy under way. "We're delighted to have earned recognition from one of the engineering industry's leading institutions. This award is a huge testament to the hard work of all the people that helped make the **Peppermint Junction** improvement project a reality, including all of the residents and road users that remained patient while we were on-site working."

INWARD INVESTMENT

The LEP has been working hard to build on the relationships with International companies and to shape future policy, prioritise work streams, and to direct funds appropriately. By working closely with the companies, we continue to support them to grow in a direct benefit to the Greater Lincolnshire economy.

We were seen promoting Greater Lincolnshire at MIPIM in Cannes in March - the leading real estate event for property professionals and a key event for professionals from all sectors.

Promoted as a year's worth of business in 4 days, the exhibition provides the opportunity to showcase our large scale projects, meet key international stakeholders, and gain insight into finance and investment, cities and infrastructure, key sectors and property hot spots.

Continued efforts with partners to raise the profile of Lincolnshire and to support foreign owned businesses, have continued alongside the Department for International Trade (DIT) to respond to specific Inward Investment enquiries and to develop propositions to attract and retain foreign investment.

"This was our third year attending MIPIM, and judging by the meetings held and positive responses that we received whilst we were out there, it is shaping up to be our most successful MIPIM yet". "We were able to secure an array of firm leads, make countless introductions and generate two potential new projects, which is really exciting. HIGHLIGHT ON

INFRASTRUCTURE

BOSTON QUADRANT is a key investment in infrastructure, enabling housing, employment and leisure facilities.

Across a 27 hectare site, The Quadrant comprises a mixed-use development being delivered by Chestnut Homes (Land) Limited on a site straddling either side of the A16. Growth Deal funding and a Growing Places Ioan has specifically supported initial infrastructure provision, with additional investment towards affordable housing being contributed under the Unlocking Rural Housing Programme. The completed scheme will include a number over 500 new homes, with a broad mix of dwellings, including one and two-bedroom apartments and two, three and four-bedroom houses. Land has been set aside for commercial operators, including a pub/restaurant site, and a variety of sites for drive through/restaurant uses. It is estimated that once complete the scheme will directly lead to the creation of 113 new full-time jobs within the local economy and lever in an additional £18.3 million of private-sector investment.

The Unlocking Housing Programme was allocated £4.1 million Single Local Growth Funding (SLGF) to facilitate delivery of 419 affordable homes.

HIGHLIGHT ON

THE DIGITAL SKILLS CENTRE AT NEW COLLEGE STAMFORD is delivering the latest digital qualifications and commercial training under the auspices of the Skills Capital Investment Fund Programme.

This scheme has refurbished and upgraded existing college facilities to deliver 21st-century digital skills training and education by; developing NCS' computing provision in response to changing needs locally, regionally and nationally; delivering at least 10 additional qualifications; enabling curriculum innovation to support business needs in emerging technologies, enabling automated production, in agri-tech and renewables, working with at least 150 new employers; and increasing the number of learners accessing high quality education and training provision in key sectors, including apprenticeships and HNC/D's.

The recent refurbishment and upgrade of the college's computer learning facilities will enhance the delivery of digital skills training and education. It will also support the further development of cyber security, mobile technologies, green IT and cloud computing, all of which have been identified by UKCES as drivers for high-level skills needs within the digital sector."

BUSINESS SUPPORT

MICROCAPTURE is a Grantham-based business specialising developing specialist fragrances using a process called micro-encapsulation, which produces a slow continual release of fragrance. This is added to paper, tissue, carpets and other materials to provide a long lasting fragrance release. MicroCapture received grant funding and advisory support to bring their manufacturing processes in-house, through the purchase of software required to build an efficient in-house production system, reducing their production costs and allowing them to meet customer demands quicker.



ASALI is a family-run business producing genuine leather products ranging from weekend bags to key rings, some officially licensed by the Ministry of Defence. ASALI now boasts the ability to personalise their items to make each one truly unique. The company also supports various charities, including several associated with the RAF. ASALI received a Digital Grant to assist in investment to continue growth through the Business Lincolnshire Growth Hub. Using the grant, ASALI could now sell their personalisation services online, allowing many more customers to buy their products.

HAWKENS GINGERBREAD is primarily a manufacturer of high-quality gingerbread products to both the retail market and the foodservice market with a particular emphasis on local, authentic products made with care and attention which helps set them apart from the competition. A slow rate of growth and missed opportunities, predominately due to a lack of funding, support or skills, prompted Hawkens Gingerbread to contact the Growth Hub adviser team. Business Lincolnshire offered bespoke advice, Hawkens was guided through an application process, and was subsequently awarded a grant to help them purchase a new piece of baking machinery, helping them to increase production by a staggering 5000%.

HIGHLIGHT ON INVESTMENT

LEONARDO The Italian owned Leonardo have built a new £2 million Training Academy in Lincoln to train the cyber and electronic warriors of the future. This has created 15 new cyber security training jobs. The LEP have worked closely with Leonardo to help them secure accommodation for their students who travel from overseas and can stay in the area training for up to 3 years.



BRIGHT LITE STRUCTURES American owned Bright Lite Structures have expanded their operations moving to a new site in Stamford. BLS are a unique R&D company specialising in carbon fibre composite and work with both the automotive and aerospace industry. They have received significant support from the LEP in assisting them with the move including pre planning advice, funding options and advice and guidance. This investment has created 17 FTE new jobs.

ANNYALLA CHICKS New Irish inward investment into Lincolnshire. The Butterwick site is over 14 acres. Phase 2 went operational in November which means the site has now created 30 FTE new jobs. The LEP has worked closely with the company throughout the investment, assisting in providing advice on recruitment, funding and access to DIT sector specialists. Phase 3 will be operational in 2019.

LOOKING FORWARD...

Lincolnshire has a strong and resilient business community and its £21.5 billion GVA contributes significantly to the UK economy.

We have a large business base relative to our population with low unemployment, good business survival rates and a robust advanced engineering sector, visitor economy, and agri-food sectors. However, there are challenges ahead. Our economic productivity is £26.80 per hour worked; 20% below the national average, we have lower levels of qualifications in our workforce, and we face increased global and regional competition in a post-Brexit economy.

We must raise our game and demonstrate our ambition. We need to achieve a higher level of government funding, invest in infrastructure, increase innovation, improve productivity rates, and generate greater opportunities for Lincolnshire. Our work to develop at pace a Local Industrial Strategy will form the strategy to achieve these ambitions.

Instrumental to our success will be extending our collaboration with the private and public sectors across the whole of Midlands, through the Midlands Engine, and working closely with our neighbouring LEP to increase our collective power and influence.

As we pass the half-way point of the Growth Deal Programme, the LEP is focused on delivery and future pipeline and investment opportunities.

Focus areas of activity for 2019/20 include:

- Leading the development of the Local Industrial Strategy for Lincolnshire
- Strengthening the area's profile with Government, MPs and officials
- Leading strategic delivery of the area's energy strategy which underpins growth ambitions
- Working with partners to address strategic transport challenges
