


Quality assurance

Things to ask yourself before we arrive

Installing cavity wall insulation is a pretty simple process, but to make it even easier there are a few things we need you to do to make sure you are ready for our visit. For a full step by step guide visit our website at www.sigenergy.co.uk/insulate.

Take a minute to ask yourself the following questions and you're all set to go:

- Are the road and the driveway outside your home clear so we can gain access?
- Can we position our ladders against the walls of the property?
- Have you closed all the windows and doors to protect against dust?
- Have you warned the neighbours to do the same?
- Have you removed any objects fixed to the external walls and from windowsills and shelves?
- Have you signed the pre/post installation sheet?

We'll check that any flues from fires on the external walls are still working normally.

Loft Insulation putting a hat on your home

Our expert installers will usually only take a couple of hours to insulate your loft. Here's how we do it.

First

We'll check the access to the loft is clear and put down protective dust sheets. There will be additional cost if work is needed to access the loft.

Next

We will bring the insulation into the house sealed in plastic and open once in the loft area.

Then

We lay the insulation between and across the joists in the roof. We also insulate the pipes and tanks to stop them freezing in cold weather.

Finally

We insulate and draught-proof the loft hatch so the whole roof space is taken care of.

- Is the loft clear of storage boxes or any other items?
- Do you know where/how to turn the water off?
- Is the area around the hot water tank clear and is the heater off?
- Have you signed the pre/post installation sheet?

Cavity wall insulation

What is cavity wall insulation?

The walls in your house have two layers with a cavity or gap between them. When we install cavity wall insulation we fill this gap with insulating material to reduce heat loss through the wall.

Do we have to look after it once it's installed?

No. Once it's in you can forget all about it and just enjoy being in a warm home.

How long will it last?

Our insulation comes with a 25-year guarantee but should last as long as the building is in good condition.

How do I know if I have cavity walls, and if I have cavity wall insulation already?

Our Insulation Advisor visits your home and conducts simple tests to see if your home is suitable for insulation. This takes about half an hour, is free and there is no obligation to book on the spot. You can have a think about it and call us another time, or book with the Insulation Advisor.

Loft insulation

What is loft insulation?

Loft insulation is a thick layer of material placed in and across the joists in your loft. It dramatically reduces the loss of heat through the roof making your house a warmer and cheaper place to live.

If there is insulation already in the roof do you take it out?

No. We will leave existing insulation in place and place new insulation on top of it.

Can I still use the loft for storage after installation?

Yes, but take care. As the insulation covers the ceiling joists you must be careful not to place items directly on the ceiling or they might fall through. We can provide a quote for installing walkboards if you wish.

Is the insulation material safe?

Yes. If you handle the material its best to wear gloves.

Do we have to look after it once it's installed?

No. You can forget all about it and just enjoy being in a warm home.

General questions

Why is it so cheap?

Insulation for your home is subsidised as part of environmental initiatives run by the UK Government. Please note that SIG Energy Management is not a Government agency nor is SIG Energy Management in any way associated or affiliated with the Government.

How long does it take?

The installation is carried out by our specialist partners Miller Pattison and it typically takes a couple of hours to install loft insulation and less than half a day for cavity wall insulation.

How long will I have to wait after I give the go ahead?

Typically around 6 weeks from the time you book your appointment, to installation day. You can book a day convenient for you, but we do need you to be at your home on the installation day.

Will there be any mess?

We will protect your belongings with dust sheets for the loft insulation and our Installers wear covers on their work boots so your carpets will be protected. Small holes will be drilled into the wall and we will re-point the mortar after.

Priority Programmes

There's plenty of support available to keep your home warm. Priority programmes set up by the Government mean that people on lower incomes can qualify for help with the cost of installing loft and cavity wall insulation.

Priority Status

If you receive any of the following benefits, then you qualify for Priority status.

Qualifying Benefit Type:

- Attendance Allowance
- Council Tax Benefit
- Disability Living Allowance
- Housing Benefit
- Income Support
- Income Based Job Seeker's Allowance
- Income Related Employment & Support Allowance
- Disablement Pension (which includes constant attendance allowance)
- War Disablement Pension (which includes a mobility supplement or attendance allowance)
- Working Tax Credit (income is £16,190 or less)

Super Priority Status

If you are in one of the following two benefit groups then you automatically qualify for Super Priority status.

- Child Tax Credit income is £16.190 or less
- State Pension Credit

You are also eligible for Super Priority status if...

If you receive any of the following three income-based benefits PLUS one of the qualifying components listed below, you automatically qualify for Super Priority. If you DON'T receive one of the qualifying components then you are still eligible for Priority status.

- Income Based Job Seeker's Allowance
- Income Related Employment and Support Allowance
- Income Support

- Severe Disability Premium
