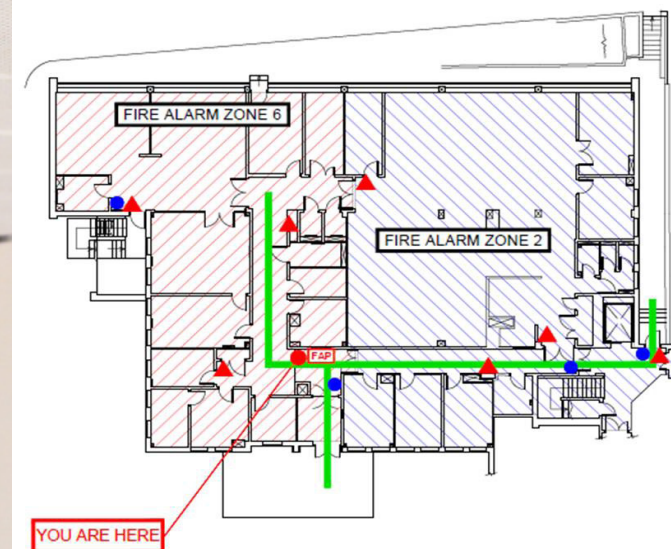
We can provide your information in a range of formats, such as detailed CAD drawings, Excel spreadsheets or as an upload to your CAFM system.
