GIRES is an unincorporated association governed by a Constitution adopted on 29th October 1997.

The charity's objects are to advance education into Gender Identity and Intersex issues, and in particular to:

(a) initiate, promote and support research particularly to address the needs of those in whom there is a strong and ongoing desire to live and be accepted as a member of the opposite sex from that assigned at birth;

(b) publish the outcome of such research and other relevant information in order to inform interested parties and the general public;

(c) enable the public to achieve a wider understanding of these issues and thereby provide equal treatment within society of those whom they affect.

GIRES Trustees are elected annually at the Annual General Meeting.

In the furtherance of its objects, GIRES relies mainly upon the efforts of volunteers.

### **Financial review of 2017**

In 2017, GIRES recorded an income of £46,868 (£55,754) and expended £46,915 (£56,015) which included the cost of a number of non-recurring grants and projects, resulting in a net loss £47 (net loss £261).

Income from members' subscriptions and donations amounted to £9,660, which was lower than the previous year where the subscriptions and donations were £14,826. This year, we received corporate subscriptions of £21,265 (£17,729). A considerable amount of time has been expended by Bernard and Terry Reed generating this form of income.

Further benefit was provided by the individual trustees who worked in a voluntary capacity on the Charity's funded projects, training sessions and speaking engagements, for which income was received of £7,992 compared with £18,585 last year

The amount received from HM Revenue and Customs in respect of Gift Aid recoveries on subscriptions and donations was  $\pounds 1,895$  ( $\pounds 2,867$ ).

The charity pursues a prudent policy of restricting its expenditure on governance costs to less than its receipts from subscriptions, donations and Gift Aid. In 2017, expenditure of £8,488 remained significantly below receipts of £32,820.

At the year end, The Charity held £4,297 in restricted funds (£22,325). These are to be expended on the joint research project with Mermaids which has been funded by Awards for All.

The Charity held bank balances at the year end of £65,749 (£69,564), including the restricted funds. These monies are placed in a current account at NatWest Bank and deposit accounts at Scottish Widows Bank. These banks still appear to be financially strong and are covered by the Financial Services Compensation scheme in the same way as for individuals. Bank interest received amounted to £10 (£121).

#### **Reserves policy**

The Charity's reserves policy is to hold a sufficient minimum balance of unrestricted funds to cover one year's expenditure on the cash costs of governance and literature. At  $31^{st}$  December 2017, the balance of £50,811 (50,858) was substantially greater than the required minimum of £10,523 (£18,309).

#### Insurance

It is a requirement of the major grant givers, that it has adequate insurance cover in place. In any case, the trustees' view is that the scale of the charity's operations has now expanded sufficiently to warrant such protection. Accordingly, GIRES has arranged cover, at a total cost of  $\pounds$ 776, for professional indemnity ( $\pounds$ 500,000), public liability ( $\pounds$ 2,000,000) and employers liability ( $\pounds$ 10,000,000), which includes cover for volunteers. The charity has also arranged Trustees' indemnity insurance ( $\pounds$ 100,000).

### Fulfilling GIRES' Objectives in 2017

The Gender Identity Research and Education Society (GIRES) was established in 1997. GIRES upholds the right of all those trans<sup>1</sup> people who do not fit the typical boy/girl, man/woman tick boxes, including people who intend to change gender role completely and others whose gender identity is non-binary, to live freely in a society that celebrates diversity. However, trans people still suffer severe disadvantage, including high suicidality.

To support them, GIRES combines the expertise of a voluntary team of trans and non trans people, many of whom have direct experience of the issues with which it is involved. They undertake the wide range of work described below and ensure that the charity is robustly governed. As at 31 December GIRES had 9 trustees who were trans people, or their relatives or friends, like most of the charity's 350 individual members. The charity also has 115 organisations as Corporate Members, which are involved in healthcare, sport, education, housing, insurance, banking, defence equipment, nuclear power, aviation, information technology, telecommunications, television, publishing, food processing, trades unionism, law, policing, emergency services, regulation and local and central government.

GIRES responds annually to 2,000 requests for help from trans individuals, their families, professionals and the media. The charity serves its Corporate Members, and other public and private sector organizations, in: developing policies and practices, supporting individuals who change their gender expression in the workplace or educational setting, engaging with the trans community, training, e-learning and design of healthcare schemes for trans employees. The charity delivers about 50 training sessions and conference presentation per annum. The training always achieves high evaluation scores. GIRES maintains an online directory of the steadily growing number of trans support organisations, which now has over 400 entries.<sup>2</sup> GIRES supplies a wide range of literature and its website provides a wealth of material, including free e-learning resources that enable users to obtain CPD points.<sup>3</sup> The website is accessed from 189 countries and its use has grown rapidly.<sup>4</sup>

GIRES has been at the forefront of campaigns to improve the lives of trans people through stronger legal protection, better medical care and greater respect within society. The charity responds to the constant stream of invitations to contribute to consultations on changes to government policies that affect the lives of gender diverse people, for instance with regard to the mental health of children and young people. It also attends the meetings of influential bodies where issues of concern to gender diverse people are discussed, including the Parliamentary Forum on Gender Identity, the Equality and Diversity Forum, the Gender Recognition Panel Users Group, the Crown Prosecution Service Community Accountability Forum and the National LGB&T Partnership.

Greater support and more readily available information, provided by GIRES and many other organisations, have empowered rapidly growing numbers of trans people to live and work more openly. It is becoming ever more apparent that 5 % of the population is gender diverse.

Highlights of the year included:

- Completing the joint study with Mermaids, funded by the National Lottery, of families' experiences at the Tavistock Gender Identity Development Service for young people; the resultant report has been submitted for publication in a peer reviewed international journal
- Preparing factsheets for schools on the transition of a pupil or a teacher, as part of the LGBT Consortium's anti-homophobic and transphobic bullying project funded by the Department for Education
- Supporting the highly successful National Trans Youth Network conference, hosted by Linklaters in London on 11 November 2017, which was attended by 120 young people and 60 adults.
- Contributing to the new Prison Service Instruction on caring for trans prisoners
- Publishing on the GIRES website highly topical papers on the gender recognition process and gender identity monitoring
- Developing, as a member of the National LGB&T Partnership, some of the of a Public Health England toolkit, that will inform public health nurses about how best to meet the healthcare needs of young and older LGBT people
- Providing a series of individually designed training sessions for the managers of Transport for London's call centre staff (6 sessions), Kent Community Health NHS Foundation Trust staff (5 sessions) and Aycliffe Secure Centre staff (4 sessions), together with double or single sessions for many others, including the DVLA whose 5000 staff have all worked enthusiastically through the elearning resource that GIRES developed for employers and service providers
- Receiving the Attitude magazine's Pride Award for the work undertaken for GIRES by Bernard and Terry Reed

However there is much more to do. The law has to be strengthened to make gender recognition a less onerous process and to provide protection clearly for non-binary people. GIRES plans to produce a booklet on the intersection between faith and gender diversity. Many more employers and service providers in the public and private sectors need to introduce trans supportive policies and provide trans awareness training for their staff. Medical care for trans adolescents and adults has to be brought into line with world best practice and expanded cost-effectively to meet the growth in demand (averaging 58% per annum among adolescents during the past five years and 22% per annum among adults) and reduce the present excessive waiting times for even an initial specialist appointment (14 months for adolescents and 18 months for adults). Having a reliable measure of the number of trans people among employees, service users and generally is important in planning for the support they need and GIRES is working on monitoring gender identity accurately with NHS England, the Office for National Statistics and the Solicitors Regulation Authority. Gender is often used incorrectly as synonymous with sex. GIRES supports the application of the term "sex" to biological factors and "gender" to psychosocial and cultural factors. Hence, male/female are terms for describing sex. 'Man/woman, or any variations between or outside these psychosocial categories, are terms for describing gender identity'.

#### Statement of trustees' responsibilities

Charity law requires the trustees to prepare financial statements for each financial year, which show a true and fair view of the state of affairs of the charity and its financial activities for that period.

#### Independent Examiner's Report to the Trustees of GIRES

I report on the accounts of the Charity for the year ended 31st December 2017, which are set out on pages 7 to 11.

#### Respective responsibilities of trustees and examiner

The charity's trustees are responsible for the preparation of the accounts. The charity's trustees consider that an audit is not required for this year under section 144 of the Charities Act 2011 ("the Charities Act") and that an independent examination is needed.

### Notes to the accounts

#### **Basis of accounting**

The Financial Statements have been prepared under the historical cost convention and in accordance with the Statement of Recommended Practice: "Accounting and Reporting by Charities" (SORP 2005) and the Charities Act 1993.

#### Incoming Resources

Donations & legacies are included in the Statement of Financial Activities (SOFA) when:

- the charity becomes entitled to the donation, legacy or similar income and any conditions for receipt are met.
- the trustees are reasonably certain that they will receive it and
- the trustees are reasonably certain that the value can be reliably measured.

Intangible income such as volunteer time and professional services that have been donated are not capable of financial measurement and as such are not included.

Subscriptions are reported in the year in which they are received.

Income from corporate subscriptions which have a life extending beyond the Financial Year reported on has been apportioned to that year according to the proportion of the work which the Trustees consider to have been completed by the end of the Financial Year. The balance of that income is carried forward as Deferred Income.

#### **Resources expended**

Resources expended are included in the Statement of Financial Activities on an accrual basis, inclusive of any VAT, which cannot be recovered. Charitable activities represent the resources expended in the delivery of programme and project work directed at the achievement of the charitable aims and objectives. Governance costs represent the costs which relate to the general running of the charity i.e. all the activities which allow the charity to operate, generate information required for public accountability and carry out the planning processes which contribute to the future development of the charity. Resources expended, wherever they can be so identified, are allocated to the charity's activities as costs directly attributable or as Support or Governance costs. In the case of GIRES, which neither owns nor rents premises and has no paid staff, other costs have been apportioned on a basis the Trustees have considered to be a reasonable estimate for the relevant allocation.

#### Fees for examining the accounts

The external examiner, Mr I Rankin, has made a charge of £675.
