



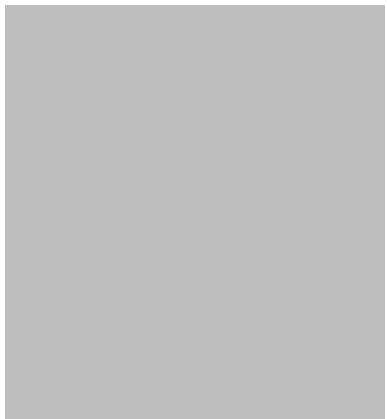



1] Terms & Conditions

1. Definitions: "The seller" means Italian Furniture Co (Leeds) Limited. "The buyer" means the person, firm or company which place the order with the seller. "The goods" means the article, things or items described in the order. "The Order" means the order placed by the buyer for the supply of the goods.

2. Unless otherwise agreed in writing by the seller, these conditions which supersede any earlier conditions appearing in the seller's catalogue or elsewhere shall override any terms and conditions stipulated, incorporated or referred to by the buyer whether in the order or in any negotiations and all guarantees, warranties or conditions (including any conditions as to quality or fitness for particular purpose) whether express or implied by statute, common law or otherwise are excluded and hereby negated (save where such exclusions are prohibited by the Unfair Contract Terms statute, Common Law, or otherwise are excluded and hereby negated (save where such exclusions are prohibited by the Unfair Contract Terms Act 1977).

3. All descriptions, specifications, drawings and particulars of weights, dimensions and materials have been given by way of identification only and the use of such information shall not constitute a sale by description. The seller's employees and agents have no authority to make any representation, statement or report not contained in or incorporated into the quotation by the seller and the seller shall not be bound by any unauthorised representation, statement or report if the seller adopts any changes in construction, design or specification of its products, the buyer shall accept the product so changed in fulfilment of the order.

4. The seller will notify the buyer orally or in writing of the arrival of the goods at the premises of the seller and the buyer shall within 48 hours of such notifications specify a date and time for delivery of such goods. In the event that the buyer fails to unload the goods within 4 hours of their arrival at the buyer's premises or such other destinations as notified to the seller in the order at the time so specified the buyer shall be liable to the seller for the additional costs incurred by the seller. The seller shall not be liable to the buyer for any damage or loss arising directly or indirectly from any delay in delivery.

5. The seller does not guarantee the exact quantity of goods so delivered and the buyer shall accept and pay in full at the order price for all goods actually delivered notwithstanding minor discrepancies between the quantities ordered and the quantities delivered. The seller may at its absolute discretion despatch and invoice part orders.

6. Delivery charges are included in the price except where otherwise stated. Goods are not accepted by the seller for return from the buyer without the prior consent of the seller in writing. Payment shall be made within 30 days of delivery of goods to the buyer and in the event of late payment the seller shall be entitled to interest on the amount outstanding at the rate of 4% above the base rate of Natwest Bank PLC from time to time in force calculated from day to day.

7. All delivery notes must be signed by the buyer and the driver delivering the order. In the event that the quantity of goods

delivered falls short of the quantity specified on the delivery note the actual quantity unloaded shall be recorded on the delivery note and countersigned by the buyer and the driver delivering the goods who shall also record the container Seal Number and whether "SEAL BROKEN" or "SEAL INTACT" on delivery.

8. The buyer shall inspect the conditions of the goods immediately upon receipt thereof and shall within 48 hours from such inspection give notice in writing to the seller of any matter or thing by reason whereof he alleges that the condition of the good is not in accordance with the contract. If the buyer shall fail to give such notice the condition of the said goods shall be deemed to be in all respects in accordance with the contract and the buyer shall be bound to accept and pay for the same accordingly. Any goods for the subject of a claim by the buyer shall be retained by the buyer pending inspection by the seller.

9. The seller shall not be obliged to entertain or discharge any claim for less than £150 and the maximum liability of the seller for shortages and defects in respect of any goods shall be the amount invoiced by the seller to the buyer in respect thereof. Under no circumstances shall the seller be liable to the buyer for loss of profits or economic loss.

10. The goods shall be at the buyer's risk from the time of delivery to the buyer's premises or to such other premises notified to the seller on the order.

(a). The goods and any other goods delivered by the seller to the buyer shall remain the sole and absolute property of the seller as legal and equitable owner until such time as all money due to the seller has been paid to the seller.

(b). The buyer acknowledges that it is in possession of all such goods as bailee for the seller until such time as they become the property of the seller.

(c). Until the goods become the property of the buyer, the buyer undertakes to store such goods on its own premises separately from its own goods or those of any other person and in a manner which makes them readily identifiable as the seller's goods.

(d). The buyer's rights to possession of such goods shall cease if it does anything or fails to do anything which would entitle a receiver to take possession of its assets or which would entitle any person to present a petition for the winding up or bankruptcy of the buyer.

(e). The seller may for the purpose of examination or recovery of its goods enter upon any premises where they are stored or where they are reasonably thought to be stored.

(f). In the event that the buyer purports to sell all or part of such goods before the property therein passes to the buyer the entire proceeds of such purported sale shall be held in trust for the seller and shall not be mingled with any other money or paid into any overdrawn bank account and shall at all times be identifiable as the seller's money.

(g). The buyer warrants that it is not at the time of entering into



this agreement insolvent, and knows of no circumstances which would entitle any creditor to appoint a receiver or to petition for winding-up or bankruptcy or to exercise any other rights over or against its assets.

(h). All furniture sold is intended for domestic use. We cannot accept responsibility if used for contract/commercial purposes.

(i). WE RESERVE THE RIGHT TO INCREASE PRICES ON IMPORTED GOODS AT SHORT NOTICE, IF APPROPRIATE.

2] Delivery & Returns

We operate the following policies regarding the delivery and return of purchased goods. For more information please contact us directly.

Delivery:

11. Deliveries are issued nationwide to all main areas of the United Kingdom.

12. Delivery times may vary as they depend on the availability of stock and whether the transport is in the desired area. Typical delivery times range from 2-6 weeks.

13. Booking confirmation and reminder will be made prior to delivery being dispatched.

14. Delivery hours are from 9-6.

15. Delivery only available on orders over £500 within the UK.

16. Delivery to Scotland only available on orders of £1000.

17. Payment is strictly C.Q.D. (Cash/cheque on delivery)

Returns:

18. Any damage must be notified in written form (Fax/Letter) within 7 working days commencing on delivery date

19. Any goods to be returned must be in original or similar packing.

20. Credit will be issued upon receipt of goods in warehouse.

21. Customer will be issued with either a credit note on the customer account or a cheque.

3] Home Delivery

22. Service: We undertake to deliver all orders received to your final customers within 5 working days, providing that the relevant items are in stock. And payment has been received in full. Notification will be sent for out of stock items, together with the anticipated due date if required into our warehouse. If you wish to split the order for more than one delivery, a separate charge may be applied to each delivery.

23. Booking In: The majority of orders will be booked in with the customers no less than two days prior to the delivery and a message will be left if the customer does not answer and there is

a facility to leave a message. If the customer refuses the delivery then we will reschedule for the next time we are in the area. Please note the refusal may cause the delivery to extend beyond the 5 working days period. Some customers may be called the day before if we have free slots available on a run. In these instances no messages will be left as time constraints make it difficult to finalise a run when waiting for responses. However, we will contact the customer again to arrange delivery within the 5 working day period. When the driver arrives at the customer's address if the driver needs to wait for more than 20 minutes to take in there delivery a charge will occur to the customer.

24. We will require at least two contact details for the customer, i.e. mobile number, daytime/evening number and/or an email address. Clearly the more contact details we have will increase the likelihood of us being able to contact the customer.

25. In the event where booked orders have either been refused, wrong item ordered, or there is no one available to take delivery will still incur a delivery charge

26. All orders will be accompanied with plain delivery notes, without prices showing only consumer information.

27. Communications: All orders delivered by our Home Delivery service will have the signed POD Confirmation attached to the relevant invoices.

28. Conditions: If our delivery teams feel that damages to the product or premises or injury to themselves or others may occur through delivery, we will advise them to leave the goods in a safe and convenient place.

29. Items damaged by the customer that needs to be replaced will be payable by the customer together with a further delivery charge. Items refused by the end customers for any reason, the products will have to go back to the retailer we will not accept items to our warehouse, a further delivery charge will incur for return and forwarding to the retailer.

30. Cancellations of Orders: We reserve the right to cancel orders if:

31. Payment have not been made to Italian Furniture Company (Leeds) Ltd.

32. Goods were ordered incorrectly

33. Price: Deliveries will incur a charge of £7.50 up to 20 kg there after £0.23p per kg 50kg items will be £38 as it is a two man service there after £0.38 per kg - PLEASE CALL OFFICE FOR AN ACCURATE DELIVERY CHARGE
