MARKETPLACE ENROLLMENT ASSISTANCE TO BE OFFERRED

(TULSA, OKLA., Nov. 1, 2018) Morton Comprehensive Health Services will host events for Marketplace Health Insurance Enrollment on Nov. 17 and Dec. 8 from 9 a.m. – 1 p.m. at its main clinic at 1334 N. Lansing Ave.

Morton's certified application navigators and assisters will assist individuals applying for or renewing applications for health insurance through the Marketplace exchange. During the enrollment period, which begins Nov. 1 and ends Dec. 15, Morton representatives are available at it North Lansing clinic, Monday-Friday from 8 a.m. – 5 p.m. by appointment or walk-in.

Individuals eligible for Medicare can also receive enrollment assistance during the work week in November and December. The deadline to make changes to Medicare coverage is Dec. 7.*
