

## ALCHEMY METALS TERMS AND CONDITIONS

- Any queries relating to the transfer of waste from the "client" listed over must be addressed by the "client" within 5 working days of the advice note being received.
- The title of all skips and portable cages/containers remains with Alchemy. The skips and cages/containers are supplied on your site in good condition and can be recalled by Alchemy at any time giving 5 working days written notice to the "client". Whilst on your site this equipment is the clients responsibility and should be covered by your insurance.
- The "client" agrees to indemnify Alchemy for the full cost to replace or repair any equipment, stolen, lost, removed or damaged whilst on the "clients" site.
- Pre-booked, short notice, cancelled, empty or part full bin collections are charged at £225.00 plus VAT unless otherwise agreed.
- Container removals at the end of term are charged at £170.00 plus VAT per pallet space for cages/containers and £235.00 per skip.
- Containers removed from the "clients" site, with the "clients" permission, but without the express written permission of Alchemy will be charged at a daily rental fee of £1.50 per portable cage/container and £2.50 per day per skip from the first day of the last full transaction by Alchemy from your works, a charge of £165.00 per pallet space\* to recover the empty cages/containers , a charge of £225.00 plus VAT to recover each empty skip.
- Containers removed from the "clients" site at the end of term will be charged at £170.00 per pallet space\* to recover the empty cages/containers , and £225.00 plus VAT to recover each empty skip.
- Should a first delivery of a container/cage or skip be made to the "clients" site and then cancelled either on the day of delivery or after the delivery has been made without completely filling the container with the "agreed" scrap metal a two way charge will be made (terms above), for both the original delivery and the removal of Containers.
- The "clients" material (metal waste) will be payable against received weights only confirmed over Alchemys calibrated bridge and subject grade and foundry analysis.
- Weighbridge tickets will be kept for 6 months only.
- All deleterious contaminations for example plastics, paper, rubbish, other metals etc. as well as water, oil and fines will be deducted from the Net material weight and labour and disposal charged subject to each outturn. All free running oil/coolant/water charged at 12 pence per litre (kg). All liquids guaranteed disposed of correctly and a certificate of disposal can be provided on request.
- All chemicals will be charged subject analysis in accordance with our disposal charges.
- All sealed units/cannisters e.g. gas cannisters will not be accepted and a charge made to return them to the client unless otherwise agreed prior to transaction.
- Quantities (non-ferrous) collected under 200kgs unless otherwise agreed will be zero rated and haulage may be charged pro-rata. All steel disposals under 1000kgs will be zero rated and haulage may be charged pro-rata unless otherwise agreed.
