Terms and Conditions

1. **Prize draw** For each fifty pounds loaned by the Lender, the Lender will receive one entry in a quarterly prize draw commencing in June 2016. One randomly selected winner will receive a prize of £100.00 (one hundred pounds) in each quarterly draw.
2. **Interest** No interest will be paid.
3. **Tax Relief** The Loan qualifies as a debt for Social Enterprise Tax Relief and the Borrower will provide the Lender with the necessary Compliance Certificate to forward to HMRC.
4. **Repayment** The Loan will be repaid in full on 31 March 2021. In the event of the winding-up of the Borrower, qualifying Loans will be subordinated to all its other debts.
5. **General Provisions**
 - 5.1 This agreement will be interpreted in accordance with the laws of England.
 - 5.2 This agreement may only be amended by written agreement of both the Borrower and the Lender.
 - 5.3 If HMRC or a court of competent jurisdiction holds any provision of this agreement to be invalid, the rest of the agreement will not be affected or invalidated as a result.
 - 5.4 Headings are inserted for convenience only and are not to be considered in interpreting this agreement. Words in the singular mean and include the plural and vice versa.
 - 5.5 The form above and these Terms and Conditions together constitute the entire agreement between the parties and there are no further provisions, either oral or otherwise.
