## **Background:**

**Skyway Safe Access Equipment Ltd** understands that your privacy is important to you and that you care about how your information is used and shared online. ## 2. **Information About Us**

2.1 Our Site, www.skyway is **owned and** operated by Skyway Safe Access Equipment Ltd, a limited company registered in Ireland under No. 318916, whose registered address is Kells Business Park, Kells, Co Meath.

# 3. Scope - What Does This Statement Cover?

This Privacy Statement applies only to your use of Our Site. It does not extend to any third-party websites, plugins and applications that are linked to from Our Site (whether We provide those links or whether they are shared by other users). Clicking on those links or enabling those connections may allow third parties to collect or share data about you. ## 4. What Data Do We Collect?

Some data will be collected automatically by Our Site (for further details, please see section 12 on Our use of Cookies), other data will only be collected if you voluntarily submit it and consent to Us using it for the purposes set out in section 5, for example, when signing up for an Account. Depending upon your use of Our Site, We may collect some or all of the following data:

- 4.1 Name, marital status, title, date of birth or gender;
- 4.2 business/company name;
- 4.3 billing address or delivery address;
- 4.4 contact information such as email addresses and telephone numbers;
- 4.5 back account, payment or transaction details;
- 4.6 IP address (automatically collected);

- 4.9 a list of URLs starting with a referring site, your activity on Our Site, and the site you exit to (automatically collected);
- 4.10 industry you operate

## 5. **How Do We Use Your Data?**

We are committed to protecting your privacy, and will only use your personal information in accordance with applicable Data Protection Legislation.

- 5.1 We use your data to provide the best possible products and services to you. This includes:
  - 5.1.1 to perform our obligations, including:
  - supplying Our products and services to you;
  - authorising payments; and
  - providing and managing your access to Our Site.
  - 5.1.2 where you have expressly consented to us doing so, including:
  - supplying you with email Insert Type of Email e.g. newsletters, alerts etc. that you
    have subscribed to (you may unsubscribe or opt-out at any time by using a link in
    our newsletter);
  - analysing your use of Our Site and gathering feedback to enable Us to continually improve Our Site and your user experience;
  - responding to communications from you; and
  - where you make an enquiry or request any particular information, to respond to that enquiry and provide the requested information.
  - 5.1.3 where it is necessary for compliance with legal obligations, including:
  - for record keeping and regulatory compliance purposes; and
  - for carrying out checks to prevent money laundering.
  - 5.1.4 where We otherwise have a legitimate interest in doing so, including:
  - carrying out checks to prevent fraud to protect us from dishonest activity;
  - undertaking surveys or market research to enable us to improve the service We offer; and
  - ensuring that our website is presented in the most effective manner for you and your computer.
- 5.2 In some cases, the collection of data may be a statutory or contractual requirement, and We will be limited in the products and services We can provide you without your consent for Us to be able to use such data.
- 5.3 With your permission and/or where permitted by law, We may also use your data for marketing purposes which may include contacting you by email, telephone, text message, or post with information, news and offers on Our products and services. We will not, however, send you any unsolicited marketing or spam and will take all reasonable steps to ensure that We fully protect your rights and comply with Data Protection Legislation.
- 5.4 Where you have given us your consent to use your personal information in a particular manner, you have the right to withdraw this consent at any time, which you may do by contacting us. Please note however that the withdrawal of your consent will not affect any use of your personal information made before you withdrew your consent.



## 6. How and Where Do We Store Your Data?

- 6.1 We only keep your data for as long as We need to in order to use it as described above in section 5, and/or for as long as We have your permission to keep it. We keep all customer, employee and contractor data as long as it is permitted by law. All confirmed members of our email lists are kept until they unsubscribe. In any event, We will conduct an annual review, to ascertain whether We need to keep your data.
- 6.2 Some or all of your data may be stored or transferred outside of the European Economic Area ("the EEA") (The EEA consists of all EU member states, plus Norway, Iceland and Liechtenstein). You are deemed to accept and agree to this by using Our Site and submitting information to Us. If We do store or transfer data outside the EEA, We will take all reasonable steps required by law to ensure that your data is treated as safely and securely as it would be within the EEA and under Data Protection Legislation. ## 7. **Do We Share Your Data?**

- 7.1 We may share your data with other companies in Our group. This includes Our subsidiaries. Where you provide personal information to one company within Our group it may be shared with other companies within Our group. This is in our legitimate interests to enable us to operate Our group effectively and to enable us to provide you with an efficient service.
- 7.2 We may contract with third parties to supply products and services to you on Our behalf. These may include payment processing, delivery of goods, search engine facilities, advertising and marketing. In some cases, the third parties may require access to some or all of your data. We currently contract with:

- b) providers of outsourced services, such as hosting and IT support or maintenance services (to the extent necessary for the provider to provide those outsourced services to us); and
- 7.3 We may compile statistics about the use of Our Site including data on traffic, usage patterns, user numbers, sales and other information. All such data will be anonymised and



will not include any personally identifying information. We may from time to time share such data with third parties such as prospective investors, affiliates, partners and advertisers. Data will only be shared and used within the bounds of the law.

7.4 In certain circumstances We may be legally required to share certain data held by Us, which may include your personal information, for example, where We are involved in legal proceedings, where We are complying with the requirements of legislation, a court order, or a governmental authority. We do not require any further consent from you in order to share your data in such circumstances and will comply as required with any legally binding request that is made of Us.

## 8. What Happens If Our Business Changes Hands?

- 8.1 We may, from time to time, expand or reduce Our business and this may involve the sale and/or the transfer of control of all or part of Our business. Data provided by users will, where it is relevant to any part of Our business so transferred, be transferred along with that part and the new owner or newly controlling party will, under the terms of this Privacy Statement, be permitted to use the data for the purposes for which it was originally collected by Us.

## 9. **How Can You Control Your Data?**

  - d) All personal data processed for profiling purposes shall be secured in order to prevent discriminatory effects arising out of profiling.
