Some important facts about your Geo Personal Lines Holiday Home UK & Overseas insurance are summarised below.

This policy summary does not contain the full terms and conditions of the contract. Please read the full policy document to make sure you understand the cover it provides.

Insurer

For overseas properties, the insurance for this policy is provided by Lloyd's Syndicate 2007. For UK properties, the insurance for this policy is provided by Ageas Insurance Limited (80%) and Royal Sun Alliance (20%).

Type of Insurance

The Geo Personal Lines Holiday Homes UK & Overseas insurance policy provides cover for the Buildings and/or Contents of your holiday home, Legal Liability, Valuables and Personal Effects, Personal Money and Credit Cards and Pedal Cycles as selected by you.

Duration

The Geo Personal Lines Holiday Homes UK & Overseas insurance policy will remain in force for a period of 12 months from the date of commencement, or as otherwise shown on your policy schedule. You may need to review and update the cover periodically to ensure it remains adequate.

Cancellation rights

We hope that you are happy with the cover this policy provides. However, you have the right to cancel it within 14 days of inception or renewal or receipt of policy or renewal documentation, whichever is the later, without giving any reasons. If that happens, your premium will be refunded to you, after deduction of a charge for the cover provided from the beginning of the contract to the date of cancellation, and in the event that a claim has not been made that would be considered as having completed the contract.
