This agreement shall be construed and governed in accordance with the laws of England and the parties shall submit to the jurisdiction of the courts of England.

### **CONDITIONS OF HIRE**

Equipment is hired subject to our Terms and Conditions for the Hiring of Plant and/ or Sale of equipment. Please note that by opening this credit account you are agreeing to hiring the equipment subject to the stated Terms and Conditions of Hire. A copy of applicable Terms and Conditions has been issued to you at the time of completing this application.

## **DATA PROTECTION**

The information supplied by you will be stored on computer and used for the administration of the account. Carrier Rental Systems (UK) Ltd is registered and will use the information in accordance with the Data Protection Act 1984 and 1998 including any subsequent amendment.

#### **PAYMENT TERMS**

I/We confirm that the information supplied by me/us is correct. A Credit Account will be opened on the strict understanding that payment will be made in accordance with Carrier Rental Systems (UK) Ltd and its subsidiaries standard Terms and Conditions. I/We understand that interest for late payment of the account can accrue for which will be payable by me/us at a rate of 2% above the Bank of England Base rate prevailing at the time.
