Effaith y Gorchymyn fydd:

Gwahardd unrhyw berson rhag peri i unrhyw gerbyd fynd mewn unrhyw gyfeiriad ar hyd y darn hwnnw o'r ffordd a adwaenir fel Ffordd yr A4086, Pen y Gwryd, Llanberis o'i gyffordd gyda Ffordd yr A4086 â Ffordd yr A498 ym Mhen y Gwryd, Llanberis hyd at ei gyffordd ger Maes Parcio Parc Cenedlaethol Eryri yn Nant Peris.

Mae angen y Gorchymyn er mwyn galluogi i “Dreiathlon Slateman 2019” gymryd lle. Hyrwyddwr y Gystadleuaeth yw “Always Aim High”.

Ni fydd y Gorchymyn yn atal mynediad i gerddwyr ar unrhyw adeg i'r eiddo a leolir ar neu ger unrhyw ffordd mae'r gorchymyn yn ymwneud ag o, neu i unrhyw eiddo y gellir ond cael mynediad iddo gan gerddwyr o ffordd o'r fath.

**ROAD TRAFFIC REGULATION ACT 1984
SECTION 16(A) AS AMENDED BY THE ROAD TRAFFIC
(TEMPORARY RESTRICTIONS) ACT 1991**

**THE GWYNEDD COUNCIL,
SPECIAL EVENTS ORDER (THE A4086 ROAD, PEN Y GWRYD, LLANBERIS –
“SLATEMAN TRIATHLON”)
(TEMPORARY TRAFFIC MANAGEMENT) 2019**

NOTICE IS HEREBY GIVEN that the Gwynedd Council intend to make an Order to enable the “Slateman Triathlon 2019” to take place.

The effect of the Order will be to:

Prohibit any person from causing any vehicle to proceed in any direction along that length of road known as the A4086 Road, Pen y Gwryd, Llanberis from a point at the junction of the A4086 Road with the A498 Road at Pen y Gwryd, Llanberis to its junction near to the Snowdonia National Park Car Park at Nant Peris.


The Order is necessary to enable the “Slateman Triathlon 2019” to take place. The Promoter of the Contest is “Always Aim High”.

The alternative route for vehicles is to follow the A498 Road in a south westerly direction to its junction with the A4085 Road and then turn right. Follow the road ahead to its junction with Lôn Ceunant, turn right, and then onwards along the road to its junction with the A4086 Road. Turn right again, and then continue along the road up to its closure and vice versa for vehicles travelling in the opposite direction.

The Order will not have the effect of preventing at any time access for pedestrians to premises situated on or adjacent to any road to which the order relates, or to any premises only accessible to pedestrians from such a road.

The Order comes into effect on the 18th May, 2019 and will continue in force between the hours of 09.00 a.m. until 12.15 p.m.

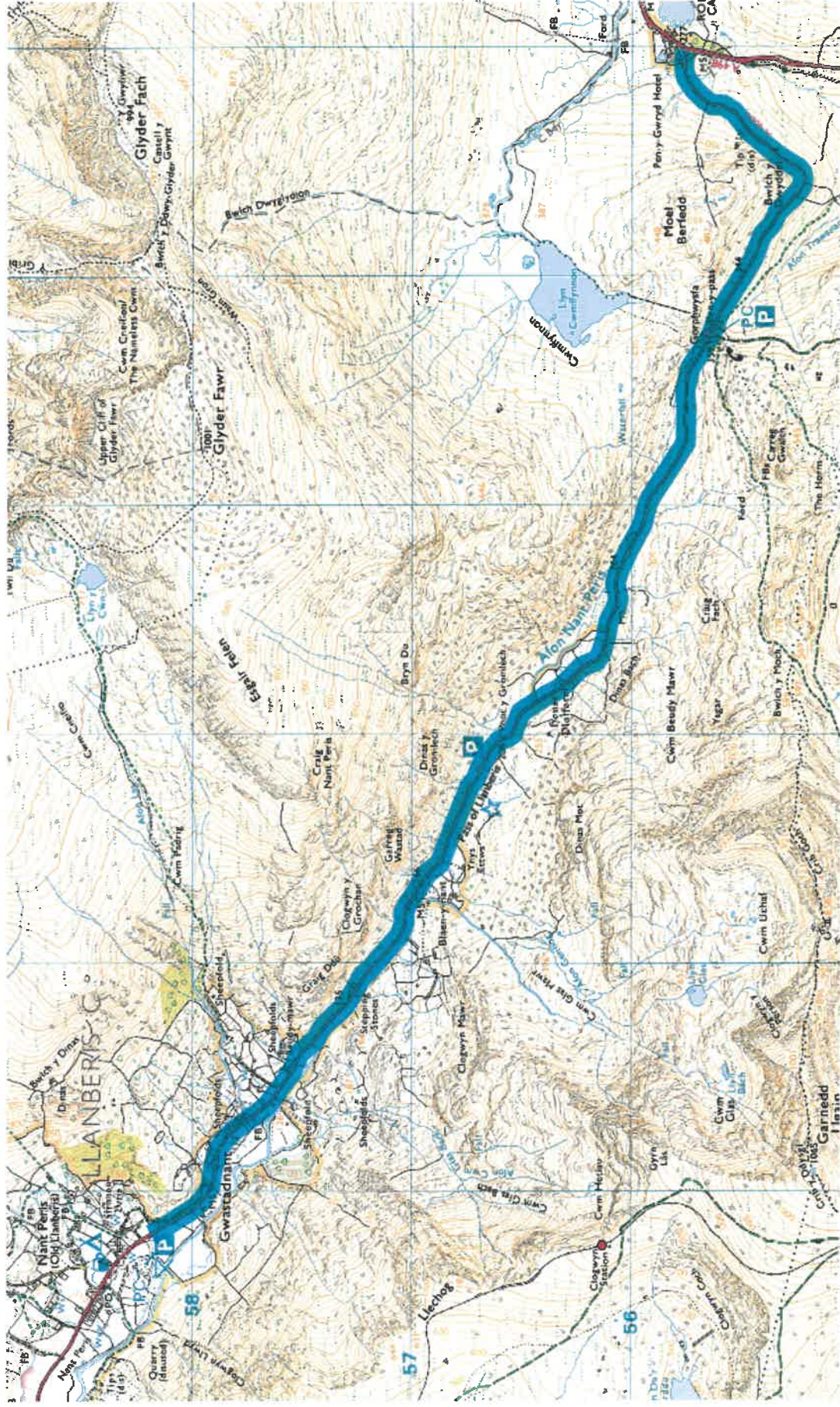
