To: 26 June 2019 (June 2019 business month)

# Incentive Plan for 7-Star Distributors



Distributors are required to maintain an active 7-Star Rank (100PPV) monthly, throughout the qualification period.

## Option 1:

Accumulate 12,000 AGPV (Accumulative Group PV) and increase 3,600GPV or more, vs. previous year

i.e.  $AGPV(\text{July } 2018\text{-June } 2019) - AGPV(\text{July } 2017\text{-June } 2018) \geq 3,600 \text{ GPV}$

**Award: \$500 Travel Voucher towards "2019 Tiens Passion Trip".**

## Option 2:

Accumulate 12,000 AGPV and increase 7,200GPV or more vs. previous year, i.e.  $AGPV(\text{July } 2018\text{-June } 2019) - AGPV(\text{July } 2017\text{-June } 2018) \geq 7,200 \text{ GPV}$

**Award: \$1,000 Travel Voucher towards "Tiens Passion Trip 2019".**



# Incentive Plan for 8-Star Distributors



**Distributors are required to maintain active 8-Star Rank (200PPV) and 2000TNPV from July 2018 to September 2018 /2500TNPV from October 2018) monthly, throughout qualification period.**

Accumulate 24,000 AGPV (Accumulative Group PV) and increase by 7,200GPV or more vs. previous year,

i.e.  $AGPV(\text{July } 2018\text{-June } 2019) - AGPV(\text{July } 2017\text{-June } 2018) \geq 7,200GPV$

**Award: \$1,000 Travel Voucher towards “2019 Tiens Passion Trip”.**



# Incentive Plan for Honorary Distributors



Distributors are required to maintain active Honorary Rank for 12 months.

(Honorary Rank assessment will be based on the result of May 2018).

Accumulate 24,000 AGPV (Accumulative Group PV) and increase by 7,200GPV or more vs. previous year.

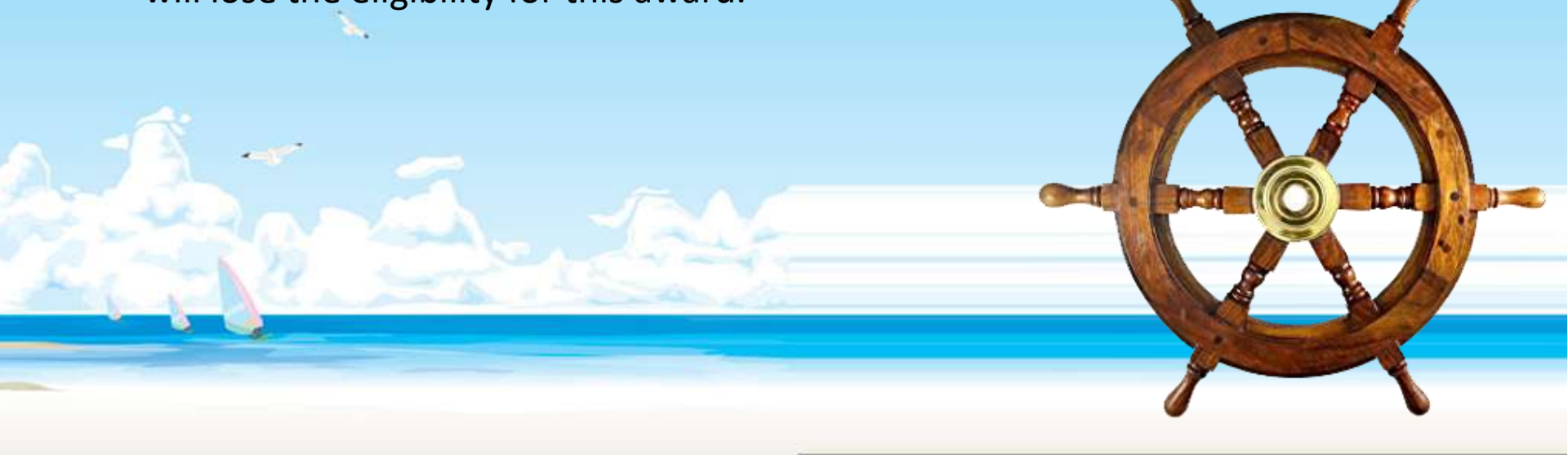
**Award: \$ 1,500 USD Travel Voucher  
towards “2019 Tiens Passion Trip”.**



# Incentive Plan for Honorary Distributors



- If you fulfil the above criteria, but miss (1) month active Honorary Rank qualification - **Award - 1,400USD;**
- If you fulfil the above criteria, but miss (2) months active Honorary Rank qualification - **Award - 1,300USD;**
- If you fulfil the above criteria, but miss (3) months active Honorary Rank qualification - **Award - 1,200USD;**
- If you miss more than (3) months active Honorary Rank, you will lose the eligibility for this award.



# Special Remarks



1. Only distributors who are registered with their actual names and meet all requirements in the " TIENS Policies & Procedures" will qualify to receive the above-mentioned rewards. TIENS DS who have not provided their real personal information by the end of the qualification period will not be eligible for the rewards.
2. Distributors can receive only one reward from 2019 TIENS Passion Trip Incentive Plan.
3. Award: All winners may receive their rewards only if he or she will participant this 2019 Passion Trip. Travel Voucher Awards are NOT exchangeable for Cash or Products.



# Special Remarks



4. With special approval, winner could transfer his/her award to downlines or family members.
5. Winner is eligible to buy only 1 ticket of the 2019 Passion Trip package for partner or downline if additional space is available.
6. Should there be any product refund or product replacement after issuing the rewards, the company reserves all rights to reclaim the rewards from the respective distributors accordingly.

# FAQ



- When will the trip take place?  
**A: September 2019, it will take 5 days for the trip.**
- Where will this trip go through?  
**A: Mediterranean cruise.**

- How many Distributors or leaders will be in the group of Passion Trip?  
**A: About 150 – 200 persons.**



# FAQ



- If I am a new distributor joining in July 2018, advancing to 7-star in June 2019 with monthly 100PPV and accumulated 12 000GPV, plus YOY increase 7 200GPV, can I receive the award? Which grade?

**A: Yes, sure. You will receive 1,000USD of award.**

- If I am an existing 6-star Distributor and advanced to 7-star in May 2019 and fulfilled all other conditions, can I receive the award?

**A: Yes.**

- Currently, I am a 7-star Distributor. If advancing to 8-star in May 2019, how should I qualify? What award can I receive?

**A: You should qualify according to your rank's requirement specified in this incentive plan, i.e. 10 months with 7-star, 2 months with 8-star. Finally, you will receive the award proportionally, maximal 1, 000USD in this example.**



# FAQ



- If I am an active Bronze Lion in July 2018 and I will be sometime as active 8-star and sometimes as active Bronze Lion from July 2018 to June 2019, am I eligible to qualify as 8-star?

**A: No, you need to qualify according to Honorary Rank Distributors' requirement in this incentive plan. If you miss more than (3) three months of active requirement for your Honorary Rank, you will lose the eligibility for this award.**

- Currently, I am a 8-star. If I will advance to Bronze Lion in April 2019, should I qualify as 8-star or Bronze Lion?

**A: You should qualify according to 8-star's requirement.**

- In the business month of May 2018, I was active as a Gold Lion. If I could be active only as Silver Lion or Bronze Lion in the qualification period and fulfill all other requirements, could I qualify to win 1,500USD?

**A: No, you should qualify as an active Gold Lion or above, if you miss more than (3) three months of active requirement for Gold Lion, you will lose the eligibility for this award.**
