CHAIRMAN'S COLUMN

I have recently written my annual review of Trust activities which forms part of the submission of the financial report for the year ended December 2013. An important section is setting out the work done by Trust Directors and thanking them for all they do. This is a valuable exercise for me because it draws into focus just how much they and our officers do in the course of a year. Beyond this, lies the input of our various work teams who do so much but are out of the publicity spotlight. All our progress is made by volunteers who work mostly at their own expense. It is this aspect which everyone should keep in mind when looking at what has been done over a twelve month period. So often volunteers work harder, do more and put themselves through greater inconvenience than those in paid employment.

I try to visit our work sites at regular intervals but I recently particularly enjoyed a conducted tour of Tamworth Road in the company of our engineer, Peter Buck. The efforts made by Terry Brown and his growing band of workers were truly impressive. From Lock 24 to the A51 a "real" canal is taking shape with the prospect of watering not far away. The standard of the construction is at the very least professional and we can all stand in the reflected glory of what has been done. This is only a short section of a seven mile canal and it has taken a quarter of a century to achieve but a momentum has been established which can only increase. The membership and the wider public must now see that the Lichfield Canal will soon emerge from its long sleep.

Of course, work continues elsewhere even with less obvious and dramatic results. The Hatherton is always on our agenda and we know that Denis Cooper and his team continue to maintain and improve the section from the Roman Way to the M6. David Dixon recently led a walk for members of the Inland Waterways Protection Society along as much of the canal as can be reasonably accessed and this showed our continuing commitment. Increasingly we are turning our attention to the section of the Lichfield from Lock 18 (one of our earliest restoration projects) to "Railway Turn where we will construct a channel within the footprint of the southern bypass. Further on, we are looking at schemes to get under the cross-city railway towards London Road and then on to Cricket Lane. We still use our Atkins report as the phased basis of our work but, as we always knew, the exact requirements of engineering will bring about departure from Atkins and some modification.

Our Vision

To reinstate the historic Lichfield and Hatherton Canals for the benefit of the community. The natural wildlife corridor from Huddlesford to Hatherton will provide a valuable amenity for walkers, cyclists, boaters and visitors to use and will bring prosperity to the area. This project will also provide an opportunity for young people to learn about our history, our heritage and our environment.

CHAIRMAN'S COLUMN

Continuing the theme of hard working directors, officers and "activists" we now have John Bryan as a director concentrating on our sales, promotions and exhibitions activities. He is bringing a new professionalism to this work.

Tom Reid is our press officer and is feeding material to the local media. Meanwhile, Paul and Beverley Marshall have revamped the website and keep it fully furnished with new material. If you have not recently looked at the website I strongly recommend that you do so. As ever, if one starts to list individual achievements there is the danger of leaving someone out and I must stress again that we have a robust and growing team of hard-working volunteers.

This impressive account of activity also draws attention to the continuing need to tell our story to the general public and to attract new membership. Our temporary occupation of an otherwise empty shop in central Lichfield has helped greatly. We have had limited opening hours through the winter but it has brought over a thousand people through the door to view the displays and to talk to our staff. It has also brought in a useful trickle of new members. Some have even joined our volunteer force or offered useful professional and technical services. The opening hours are very dependent on a very small team of helpers and if anyone wishes to give a few hours please let us know.

Once again it is almost AGM time. Details, agenda and outline accounts can be found further on in this magazine. Please join us if you can. Attendance is always good and the atmosphere is friendly and supportive. Each year we invite someone who is actively involved in waterways restoration to talk to us after the interval. This year we will welcome Brian Nelson, Vice-Chairman of the Shrewsbury and Newport restoration scheme. It should be fascinating to hear how they are tackling their scheme which is every bit as challenging as ours. Our membership of the Staffordshire Waterways Group keeps us in touch with the dozen or so projects which are operating within the county. (Although much of the Shrewsbury and Newport is in Shropshire some is within Staffordshire).

Meanwhile, the more observant members will have noticed that our mission statement which appears on the Chairman's Page has been redrawn. The original has been in place for many years and has served us well. These statements are surprisingly difficult to put together and the new version has been gestating for many months. We felt the change was necessary to reflect the changing attitudes of waterways' users and of potential funders. Controversial though it may be it is now sensible to show that canal restoration is seen as "inclusive" and not the sole preserve of boaters who can be represented as exclusive and well-off. It does not mean there has been any material change in the ambitions of the Trust simply an adjustment in the way we show ourselves off to the wider public.

BOWER QUEEN OPENS THE HERITAGE TOWPATH TRAIL

Lichfield Greenhill Bower Queen Savannah Bennett and Deputy Bower Queen Charlotte Aspley had a very important date on Saturday April 13 when they officially opened the city's latest outdoor amenity – the Lichfield Canal Heritage Towpath Trail.

The first completed section of the Trail, from Lock 25 in the Borrowcop Locks Canal Park on the A51 Tamworth Road to the bus stop adjacent to the A38 bridge, has been made disabled-friendly by volunteers from our Trust after months of hard work in extremely testing weather conditions.

Wheelchair-users, walkers, runners and cyclists will be able to use the section, which runs alongside the watered Pound 26, Lock 26 and Pound 27, which will also be in water later this year. Work is currently going on to create a winding hole, where narrowboats can turn around, and Pound 27 will be lined with puddled clay before being filled with water.

The Trail passes a section of narrows, a short length of single-vessel width canal, before rising on a gentle gradient up to the Tamworth Road. The disabled-friendly section is part of an ambitious programme to create a seven-mile Heritage Towpath Trail alongside the Lichfield Canal, which when restored will run from Huddlesford to Catshill Junction at Brownhills, where the Lichfield Canal links to the Wyrley and Essington Canal.

The Trail will provide a unique community amenity, in close proximity to Lichfield's cultural and industrial heritage, and an important wildlife corridor, with new nature reserves linking heathland and wetland areas. *Tom Reid, (Publicity Officer)*

LICHFIELD CANAL WORK REPORT

I can't believe it's 3 months since I composed my last piece for the magazine, but here we are, back on British Summer Time and with the winter behind us. After such a wet start to the year it's good to see the site drying up, making our tasks



much more pleasant. So, how have we spent those months? Looking at the last issue, I see that we hoped to complete the earthworks for the towpath wall from the narrows to the A51 "in a couple of weeks", but I'm afraid it took far longer than that, due mainly to atrocious ground conditions at that end of the site; for a few weeks it was impossible to get the dumper through the deep mud and ruts, so we went to Plan B and moved our

attention to Pound 25, where we'd found the foundations of the towpath wall were inadequate and needed underpinning. Even there, conditions, at first quite good, deteriorated as the weather worsened and the ground cut up, but we battled on and

finished a vital job in reasonable time. It was very hard graft, as all the concrete was mixed on site and had to be shovelled out of the dumper into a narrow opening in the shuttering. The finished job isn't one of our prettiest efforts but is structurally very sound and should ensure the stability of the wall.





Fortunately for us, the completion of this job also saw an improvement in the weather and we were able to complete the towpath earthwork after many months of hard work and the moving and levelling of vast amounts of material, probably well in excess of the previous estimate. That only left the construction of the wheelchair-friendly footpath surface, a vital part of our Heritage Towpath Trail, but I'll return to that story later.

Another project mentioned in the last issue was the repairing of lock 26, which having already been prepared, was given a new base of reinforced concrete

in mid-January; another good step forward. Farther away from Tamworth Road, at Fosseway Lane and in Darnford Heath, "The Staffords", our hedgecutting gang, have ploughed their own furrow and transformed previously overgrown areas into wide, easily walked footpaths which are already appreciated by an increasing number of people.

LICHFIELD CANAL WORK REPORT

We've made a start on the foundations for the winding hole wing walls adjacent to the narrows and hope to have these finished in a couple of months, after which we can look towards preparing the channel for lining, our great ambition for the year.

So, back to the Heritage Towpath Trail! Having completed the earthworks towards the end of March, we had less than 3 weeks in which to complete the



construction of the footpath, a distance of about 1/4 of a mile, involving retaining boards, a base layer of crushed concrete and a final topping layer. It was obviously going to be hard to meet our deadline of 13th. April, so I asked if the gang could



possibly do a few extra hours or different days. How magnificently they responded! We normally put in around 150 hours a week,but in the 2 weeks prior to the opening ceremony we did over 650 hours' work. Even so, it was like a TV makeover programme, with us frantically putting the finishing touches as the Bower Queen arrived for the ceremony.

The effort was worth it, however, and I believe the path is one of our greatest

achievements. Users will only see the finished surface and never realise the months of dedicated work that made it possible. Some people may say that it's not really canal restoration, but as at Fosseway and Darnford, the public can see the benefits

of our work and from the appreciative comments we hear it can only be good for the standing of the Trust.

Finally, as always, but this time more than ever, my thanks to all the lads and girls for their wonderful support and friendship. I don't know how many restoration groups exist, but I don't think anyone in a similar position to me can have such a fine group of workmates; I'm very proud to be a part of it all.

Spring is "Sprung"

After waiting patiently for winter to release its icy grip to allow the Trust's Environmental (Green) Team to "Spring" into action, we are now further frustrated by a deluge that would have even challenged Noah!

None the less, in the interim we have not been idle and the thinking and planning processes, together with the greenhouse cultivation of suitable woodland


and canal-side bulbs and wild flowers has continued apace. One concept under active consideration, in partnership with members and colleagues at FIRA, a Birmingham based company of Environmental and Landscape Architects is to develop a Sensory Trail along the Tamworth Road section.

Some while ago a chance meeting with a visiting member of the



Staffordshire Blind Association together with companion dog Cora, set in hand a idea for this environment friendly development of the Tamworth Road site.

This is an iconic visitors site with its fall of three locks within a six hundred metre length, offers many opportunities to attract development funding for its eventual return to a fully operational condition. Not only for prospective boaters approaching the



Lichfield City Centre, but also for gongoozlers, walkers, twitchers, and exercisers, and healthy living seekers, both physical and mental.

This development proposes the enhancement of the natural ecology through the provision of a sensory Length of the "Lichfield Canal Towpath Trail" (LCTPT). This would be a specifically focused section of the longer proposal of a Trail linking together the Huddlesford and Ogley Junctions.

The Grass is "Ris"

The Sensory Trail is proposed to enhance the walking experience by the stimulation of each sense through specifically focused planting, (for example Honeysuckle and Ramsells to delight the nose). The following are some ideas, and further suggestions are most welcome; together with any appropriate plants surplus to your garden's requirements.

THE BORROWCOP LOCKS CANAL PARK

The "touchy-feely" sense is already covered (in Spades) by the existing Hawthorn and Holly hedgerows. These, together with the occasional Bramble and Dog Rose setting an ambush, waiting to "bushwhack" the unwary walker, suffice to meet this sensory requirement. Although donations of more attractive plants and shrubs are always welcome. Incidentally, I gather that at one time it was an offence to allow your narrowboat - towing horse to browse and hence damage the "quick" as it was then known. If caught, was the punishment to tow the next mile or so by hand?

I Wonder Where the "Birdies Is"?

This planting plan is in the earliest stage of consideration thus further input would be valued. Any ideas please??

Some Say the "Bird Is on the Wing"

Winter Aconites - These are one of the first spring plants to flower, always a welcome sight.

But That of Course "Is Absurd" Snowdrops

- Substantial clumps of this iconic bulb have been planted over past years and these have matured to please the eye right now, Please take a walk to enjoy and admire.

Woodland Daffodils and Tulips - Two years ago the team planted a substantial number of woodland miniature Daffodils and Tulips along the Coppice path, and particularly on the Cricket Lane corner. The results of the earlier planting will present its first reward in the next few weeks (again weather permitting).

And Finally

Woodland Primulas - Last year Our President and his Lady kindly donated a tray of Woodland Primulas to the Trust. These have been over-wintered and are now ready to be set along the Towpath and in the Coppice to brighten the more shady spots.

HS2

The hybrid bill is now going through the Commons. The Trust continues to monitor the situation closely but is currently confident that the channel at Cappers Lane will not be obstructed by the railway. Vigilance will be maintained at all levels.

District Local Plans

The latest news from Lichfield DC is encouraging and it now seems likely that the inspector will accept the recommendation concerning the route. The situation concerning South Staffs Council which covers much of the Hatherton is less clear and moves are under way to clarify this. Route protection is vital to both schemes and the Plans will last until at least 2028.

The Chase Line Railway

This route crosses the Hatherton at Churchbridge and will require us to tunnel through it. The line is about to be electrified and positioning the line of the tunnel is crucial. We have learnt in Lichfield that if heavy OLE equipment is above the proposed channel then tunnelling will not be acceptable to Network Rail. This is already a difficult and constrained area and it is vital that we get this right at the planning stage.

Heritage Towpath Trails

Planning of the Lichfield trail is going well and the descriptive map is in an advanced stage of preparation. We will turn our attention to the Hatherton as it is equally important to open up the route to the public well in advance of channel building and restoration. Inevitably, a Hatherton trail will be less coherent than the Lichfield but it will be an important step forward.

Coal from the Ashby Canal

To show kindred spirit, our Trust was represented at a well-attended special ceremony staged by the Ashby Canal Association at Snarestone on 17th April. The event was

held with the kind assistance of UK Coal and the co-operation of Leicestershire County Council to highlight the restoration of the Ashby Canal to Measham and beyond to the disconnected but restored section at Moira. Progress is limited by the funding available and help is needed: this marked the next stage in the restoration process. Motor boat "Aquarius" and Butty "Ilford", were each loaded with 18 tons of



coal, courtesy of UK Coal from its nearby open-cast workings. The boats travelled south along the length of the Ashby Canal, then touring the waterway system, suitably adorned with promotional banners. This event recreated the spectacle of commercial coal carrying which ended on the Ashby Canal in the early 1970's. Our Trust will maintain its interest in the Ashby development where lessons may be learned from the way the canal is put back in water.

Land Purchase

It is obvious that the Trust must own, lease, or have a licence to operate on the track of both canals. Steady progress has been made on this over the years, especially on the Lichfield. Although the areas of land are in themselves quite small the price can be high. We have a land fund which is used for such purchases but rebuilding reserves can be a slow process. We were able to buy land off Cappers Lane but funds were much depleted. We have been fortunate with some recent and generous donations but we still lack the level of balance that we need. There are several valuable parcels of land for which we could bid if funds allowed. The recent major inflow of money has been for the Feet of Clay appeal which seems to have captured much attention. However, the land fund remains a priority.

Ogley Travellers

There has still been no decision announced on the planning application.

Membership subscriptions

It is pleasing to note that 4 out of every 10 members add a voluntary donation to their annual subscription, taking the average payment across all members to £15 each as unrestricted income. This may be a fairer way of maintaining our basic income rather than a general increase in subscription rates when the donations may then cease, or members choose to discontinue their support. The basic £10 adult subscription has not changed since the very beginning, 25 years ago, so its purchasing power is very much less and may well have to be adjusted in line with other values as we go forward. So please add on what you can afford to represent your personal subscription to support our work.

Gift Aid declarations

70% of our subscriptions are paid with the benefit of a Gift Aid Declaration for the Trust to claim the equivalent tax value. Each year, tax rates are reviewed in the Chancellor's Budget where the amount allowed before any tax follows an upward trend. Therefore, people on lower incomes benefit by not having to pay tax which means that declarations established in the past may not now be valid.
