### **What data do we collect?**

### **How do we collect your data?**

### **How will we use your data?**

### **How do we store your data?**

### **Backup**

### **Marketing**

We do not conduct marketing towards individuals, beyond using our website to promote our services.

### **What are your data protection rights?**

The right to access - You have the right to request Lintronics Limited for copies of your personal data. We do not charge for this service.

The right to rectification - You have the right to request that Lintronics Limited correct's any information you believe is inaccurate. You also have the right to request Lintronics Limited to complete information you believe is incomplete.

The right to erasure - You have the right to request that Lintronics Limited erase your personal data, under certain conditions (subject to tax and accounting law).

The right to restrict processing - You have the right to request that Lintronics Limited restrict the processing of your personal data, under certain conditions.

The right to object to processing - You have the right to object to Lintronics Limited processing your personal data, under certain conditions (subject to tax and accounting law).

The right to data portability - You have the right to request that Lintronics Limited transfer the data that we have collected to another organization, or directly to you, under certain conditions (subject to tax and accounting law).
