# **Big Life Group Social Prescribing Development Fund**

The aim of the fund is to support new and established groups and organisations to build capacity and deliver projects to support social prescribing to Be Well clients. The fund will support Be Well clients in reducing social isolation, improving or managing their health and well-being.

Applications must demonstrate how they meet one or more of the objectives of the fund:

**Enabling** – working with community groups to quickly and easily scale up production that is overused

**Responding** - to opportunities and gaps identified within our communities **Connecting** – reaching community groups not yet involved in the provision of support to clients of social prescribing services

**Targeting** - specific communities or communities of interest **Building** – adding value and strengthening local infrastructure.

There are 3 levels of funding available: micro grants, medium grants, exceptional grants (over £10,000)

You first need to complete an Expression of Interest form before you apply for the Manchester Social Prescribing Development funding. They will use the information you provide in the Expression of Interest form to decide whether to invite you to submit a full application.

Grants applications will be assessed on the community impact, sustainability, outcomes and budgetary detail. The average grant award is £1,000. Larger grants, maximum of £3000, may be considered in exceptional circumstances.

The Charity Service would not normally fund an organisation that has been registered for less than 3 years.

## **Chronicle Cinderella Fund – The Charity Service**

Funding from our Chronicle Cinderella Home Fund is available for individuals or organisations to support the costs of respite care and support (including but not limited to the provision of holidays) for the benefit of children and young people under the age of 25 who are sick, convalescent, have special educational needs or are disadvantaged for any other reason. The respite care and support should provide a positive experience for the young person and/or provide a beneficial short period of rest for the young person's carers and family.

- The maximum amount of funding available for an Individual application is £1,000.
- The maximum amount of funding for a Group application is £3,000 (although our average grant tends to be around £1,000).

Please note:Individual applications must be completed, and submitted, by a Sponsor such as a Social Worker, GP, Teacher or other professional person who knows the individual, the family and their circumstances well enough to complete the application on their behalf.

- They will normally only fund respite care and support where the family lacks the
  resources to pay for the respite care and support themselves, or where the local
  authority is unable to make such provision.
- All applications must be approved prior to any activity taking place. Funding will not be approved or paid retrospectively.

The Greater Manchester Trustees are particularly interested in the following:

- Causes with which the Duchy has historical association such as Church livings, Estates etc. within the boundaries of the three Counties (Greater Manchester, Lancashire, and Merseyside) and purposes which will benefit the community

- Skills and employment support

Funding pots are available for projects of £10,000 and projects between £10,000 and £40,000.

Community groups, association or unincorporated community associations, registered charities, including charitable incorporated organisations (CIOs), social enterprises or community benefit societies, CICs, tenant and or resident associations, schools and academy trusts can apply.

#### **Manchester Airport Community Trust Fund**

Each year Manchester Airports Group contributes £100,000 to the Fund; any fines levied at aircraft that have breached our stringent noise limits are also paid into the Fund. These funds are then used to support neighbourhood and community projects throughout the area. The Trustees award grants of a maximum of £3,000. Groups eligible for support covers an approximate 10-mile radius of the Airport, concentrating on the areas most exposed to aircraft noise. To be successful a group MUST:

- Carry out positive work in the community and be of charitable nature and be 'Not for Profit' status.
- Be Community, Socially or Environmentally focused
- Based within the area of benefit

The project should also:

- Improve, enhance, protect and conserve the natural and built environment; or offer heritage conservation;
- Promote or advance social welfare;
- Provide better appreciation of the natural and urban environment;
- Create a safe habitat for flora and fauna.
- Demonstrate lasting benefit to the community.
- Benefit all members of the community regardless of race, gender or religion.
- Be from an established group or charity able to demonstrate clear banking or financial records, and not an individual or commercial organisation working for profit.

Deadline: For the next Board meeting on 11th Jan 2023 applications need to be submitted by **18th November 2022**

#### **Fund Objectives:**

- To fund social and charitable activities and services linked to the patients and communities of PHP Health Practice Centres
- To support the Practice Social Prescribing referral service and enable the ongoing provision of new and existing local services.
- To create, support or enhance the community services to which the Social Prescribing Link Workers of PHP practices would like to refer their patients.
- To improve the health and wellbeing of patients and communities within a ten mile radius of PHP buildings.
- To advance the education, promotion and protection of good health within the communities served by PHP buildings

The minimum grant available is £5,000 and the maximum grant is £10,000.

## **Resonance Community Development Fund**

Resonance Community Developers Fund invests in projects looking to develop community led and owned assets for both affordable/social housing and/or sports facilities in Greater Manchester. The Fund aims to invest in substantial projects, normally in excess of £1 million across Greater Manchester.

The investment is primarily for community-led projects that includes housing and sports/leisure. It can help communities from the start of their projects right through to completion with; financial support for pre-development, feasibility and land acquisitions and development finance.

The fund mainly invests in community benefit societies, which is a type of a cooperative. It can work with existing societies or provide support to help you understand and set up a community benefit society.

GMCVO, as the local delivery partner, will provide support and connect community groups with local partners to help deliver the projects. Resonance are an experienced FCA Fund Manager with over 17 years' experience of investing in communities and social enterprises across the UK. Their Fund can provide finance as a project evolves and is available for pre-development feasibility, land acquisition and development finance, to construct homes or sports facilities.

# **Trafford Housing Trust Community Grants**

Community Grants are available to fund projects in the local area which meet one of the following priorities:

- Children and Young People: Children and young people living in the communities are better equipped with skills, knowledge and attitude to thrive in life.
- **Maximising Income/Reducing costs:** Residents' incomes are increased and maximised, supporting them to live independently.
- Wellbeing (Mental and Physical): Residents are more resilient to changes in personal circumstances through increased levels of wellbeing.

 Community: Residents feel more connected with their local community, with local amenities and cultural and social opportunities to meet their needs

Applicants' work must benefit people in Trafford and the surrounding areas. There are four different levels of funding:

- Micro grants of up to £500. Main aim: to make a difference in the local community.
- Small grants of between £500 and £5,000. Main aim: to make an impact against a locally identified need.
- Medium grants of between £5,000 and £25,000. Main aim: to achieve focused work. Local needs should be evidenced and met, and will typically last for one to two years.
- Large grants of between £25,000 and £100,000 (capped at £50,000 per year for a maximum of a two-year project). Main aim: to develop sustainable work to meet a growing need in the community (for two-year projects).

Micro grants are available to individuals and new or informal groups (e.g. applicants do not have to be a formally constituted group to apply). Those applying for the medium grants should provide a recent set of annual accounts. For a large grant, organisations should also have a recent set of annual accounts; be incorporated either as a charity or a company which does not distribute funding to shareholders.
