The carriage of dangerous goods is a complex and strictly regulated operation.

Organisations which carry, pack, fill, load and un-load dangerous goods are required by The Carriage of Dangerous Goods and Use of Transportable Pressure Equipment Regulations and The European Agreement Concerning the International Carriage of Dangerous Goods by Road (ADR) to appoint an examination qualified Dangerous Goods Safety Adviser (DGSA) when specific threshold levels are exceeded.

The role of the DGSA is to examine the activities of the undertaking to ensure they meet Regulatory compliance. Where deviations are found the DGSA is there to assist in implementing change, suggesting viable solutions to problems, providing training and monitoring the equipment used and the roles of the participants engaged in dangerous goods works. Two other important functions are the investigation of accidents involving dangerous goods and the production of the Annual Report which must be retained for five years.

The Regulatory framework of ADR imposes extensive requirements on all organisations involved with dangerous goods both directly and indirectly. Packaging manufacturers are required to meet strict quality standards. Label producers must adhere to highly specified designs, vehicle producers must offer variants which have protected electrical and exhaust systems, tankers must also meet strict specifications dependent upon the intended load, packers must ensure that goods are properly prepared for transport, drivers must have appropriate training, vehicles properly equipped and the Consignor must produce transport documentation. The DGSAs' role is to give advice on, and check that, all these issues are dealt with before transport occurs.
