Alberta

A Message from Alberta Environment and Parks:

2014 Municipal Solid Waste to Landfill Measurement – Update

Keep up the great diversion work Alberta. Municipal solid waste disposal per capita is measured annually in Alberta. This measure shows the waste to landfill has decreased for the last five years with the exception of 2013 which included waste volumes generated from the southern Alberta floods. Data is collected from municipal landfills receiving municipal solid waste that voluntarily report.

In 2014 the volume of municipal solid waste disposed was 666 kilograms per person. The department is in the midst of collecting data for the 2015 measure. Saskatchewan

A summary of current legislation and updates from the Ministry of Environment:

Hazardous Waste Management

- Contains information on waste with hazardous properties, which may have potential effects to human health or the environment.
- Topics such as asbestos, C&D waste, copper wire recycling, spills etc.

Solid Waste Management

- This section deals with the collection, treatment and disposal of solid wastes generated by the Saskatchewan populations using effective waste management practices.
- Topics include landfill/transfer station closure, design, operations, municipal waste incineration

Online Business Service

- Just like online banking, the service provides a centralized record of all your activities. You can view and manage your work from anywhere at any time. Submitting notifications, permit applications and reports is easier than ever.

Saskatchewan Environmental Code

- Contains the Code Chapters, Standards referenced in the Code, and the Code Knowledge Centre

Manitoba

Manitoba is pending approval of the new Waste Management Facilities Regulation and changes to the Solid Waste Management Program. For more information and updates on Manitoba's Solid Waste Management Program, please visit http://www.gov.mb.ca/conservation/envprograms/swm/index.html

NWT

The Electronics Recycling Regulations were enacted under the Waste Reduction and Recovery Act on August 25, 2015. Under the Regulations, a territory-wide Electronics Recycling Program was launched on February 1, 2016. An estimated 150 to 250 tonnes of electronics are expected to be collected and recycled under the Program annually.

Amendments to the *Beverage Container Regulations* came into force on February 1, 2016. The changes allowed the Beverage Container Program to operate more efficiently and be more cost effective.
