If you would like to moor your boat with us this season you will need to sign and return this form. No mooring will be offered until we receive a signed form. Please read the mooring contract and Rules of the Site (below) carefully before signing to avoid misunderstandings, and keep a copy for your records.

The current annual fees for mooring and winter storage that apply from 1st April each year are available on our website or please ask us for a copy.

Boats on site will be launched ready for Easter (weather permitting). If you would like your boat anti-fouled before launch please inform us if you have not already done so.

You will need to ensure that your boat is licensed in time for the launch. ANT (Avon Navigation Trust) carry out spot checks, which could result in a £50 fine if your boat is found to be on the water without a current licence. We cannot accept responsibility for launching an unlicensed vessel. New boaters should advise ANT of their address so that they can take advantage of the discounted licences (01386 552517).

Please remember that as per the Terms of Business, if you need any work carried out on your boat (other than what you can do yourself) then let us know and we will arrange it for you. We cannot allow contractors on site without prior arrangement – this is deemed as a breach of contract. Besides which we could save you money by using our trade contacts.

## Rules of the site:

**ALL MOORINGS ARE FOR 12 MONTHS; ALL FEES MUST BE PAID FOR THE WHOLE OF THIS PERIOD AND ARE NON-REFUNDABLE.**

1. Payment can be made by two 6-monthly payments in advance or by monthly standing order.
2. All boats must carry insurance, please provide a copy.
3. All boats require a current Boat Safety Certificate (valid for four years) in order to get a licence, please ask about getting your boat booked in with us if your test is due.
4. Any boat sold whilst under a mooring contract with us will be subject to commission at our current rate.
5. Mooring contracts are not transferable with change of boat ownership and are not fixed to specific moorings.
6. Please read the Terms of Business carefully (ask if you have not received a copy). The issuing of this document is a condition of our own Yachtyard insurance. Whilst taking great care when handling your boat, accidents can happen and in that event it will be a claim on your insurance not ours.
7. Only two cars per boat at any one time and no driving on the grass. We accept no responsibility for any loss or damage to customer's vehicles or property whilst on site.
8. During the season domestic refuse can be placed in the bin by the gate according to the guidelines. When the bin is full or absent you must take refuse home with you.
9. Please ensure that all children wear life jackets.
10. Please keep all dogs on a lead and clear up any mess.
11. Generators can be used between 9-11am and 5-7pm, to avoid disturbing other boaters and local residents.
12. Strictly no access to moored boats during floods.

- I would like a summer mooring and winter mooring/storage for my boat from 1 April (or from the date of signature if joining part way through the season) to the following 31 March and I understand that the fee is the same whether my boat is on or off the water.
- This agreement shall automatically renew for another one (1) year term, unless either party provides notice to the other of its intent to terminate this agreement not less than seven (7) days before the end of the then current term.
- **I understand that payment must be made until 31 March of each contracted term. Should I decide to take my boat away during this period I am still liable for the full amount.**
- Failure to return a signed annual contract will result in the loss of a mooring allocation. The proprietors reserve the right to terminate this agreement with one month's notice, and in that event to repay any unused portion of mooring fees.
