



# Paladin National Stalking Advocacy Service Annual Report

**July 2014 – July 2015** 





## **1.Introduction**

Paladin, the National Stalking Advocacy Service was launched in the House of Lords on July 11<sup>th</sup> 2013 following the highly successful All Party Parliamentary Stalking Law Reform Campaign which was spearheaded by Laura Richards and others. The All Party report was published in February 2012. By May a new stalking law had been passed by both Houses of Parliament.

The Campaign was much wider than law reform. The terms of reference included training of criminal justice professionals, risk assessment, sentencing, treatment programmes for perpetrators and reviewed the gap in terms of advocacy for victims. Paladin's work builds on and addresses many of the recommendations and in this report and we are funded to assist high risk victims throughout England and Wales. Our team of highly skilled Independent Stalking Advocacy Caseworkers (ISACs) ensure h victims of stalking are supported and that an integrated multi-agency response is in place locally to keep victims and their children safe.

#### **Key Objectives of Paladin**

- Provide advice and support to high risk victims of stalking
- Raise awareness of dangers and risks of stalking
- Provide training to professionals
- Scrutinise the new stalking laws
- Campaign on behalf of victims
- Develop a victim's network of support

Stalkers steal lives and also take lives, if their behaviour remains unchecked and they are allowed to escalate. In many cases this has resulted in serious violence, rape and in some cases murder. All victims of stalking require an effective co-ordinated agency response, whether the perpetrator is a (ex) partner, acquaintance or a stranger. Despite changes in the law, our ISACs are continually raising awareness with police about these changes, what constitutes 'direct and indirect evidence', 'online and offline behaviour' and a 'course of conduct' in order to achieve improved outcomes. In addition to our work with criminal justice agencies, ISACs routinely speak with, and write letters of support to, employers, housing associations, children services, probation officers and mental health professionals to improve responses and outcomes for clients.

We do not duplicate the work of established domestic abuse services and/or Multi-Agency Risk Assessment Conferences (MARACs) but bring additional expertise to the process. We aim to ensure that the risk is taken seriously, particularly for acquaintance and stranger stalking cases, where local services and the public protection infrastructure is not as developed as in the domestic violence sector. Partnership working is vital to keep victims safe and we





know our unique service is a lifeline for many. Paladin is therefore vital to support victims, improve the coordination of multi-agency work, as well as scrutinise the implementation and application of the stalking law. We are the only service of this kind in the world and we know our unique service is a lifeline for many.

#### Structure and Staffing

Paladin is a Community Interest Company (CIC 8361675) and operates as a not-for-profit Social Enterprise. The service operates as a discrete function of the registered charity Safer Places (Charity Number1018832), a high profile, well established domestic violence charity. ## 2.Paladin's Second Year of Operation

It has been an incredibly busy year not to mention a challenging one and our team and service is stronger than ever! It's impressive how much has been achieved with the wind, at times, against us. But in line with Henry Ford's inspiring quote about aeroplanes taking off in the wind, the whole team have worked tirelessly across the year and have truly surpassed all expectation. Key headlines activities from the last year include:

- Supporting and advocating on behalf of 296 clients. This does not include the hundreds of advice calls from professionals and victims
- Campaigned for and successfully achieved Domestic Violence Law Reform in partnership with Women's Aid and Sara Charlton Charitable Foundation
- Nominated for three awards
- A visit from a delegation of senior police and government officials from Japan
- Three major partnership events 'Behind Closed Doors' London, 'Behind Closed Doors'
   Gloucester and 'Turning the Tables on the Stalkers' with Collyer Bristow
- Delivering over 40 training sessions across the UK to more than 2500 professionals
- Media coverage in more than 60 newspapers, magazine articles, radio interviews and appearances on TV
- Running our first ISAC university accredited training resulting in 13 newly accredited ISACs
- Producing and disseminating quarterly e-bulletins
- Drafting more than 30 briefings for the media and Parliamentarians
- Numerous debates in both Houses on our campaigns and stalking law
- New and improved website
- Working on new stalking legislation in Northern Ireland
- Launching our petition for a register for serial stalkers and achieving 124, 694 signatures
- Publishing our 'Stalking Law Two Years On' Report and the findings received coverage in the Independent, Sunday Mirror and BBC Breakfast
- Launching our workplace package
- Launching our digital and cyber leaflets
- Invitation to attend and present our report findings and recommendations on stalking law at a roundtable with the Crown Prosecution Service (CPS)

Here's a more detailed look at our activity in our second year:

Provide Advice and Support to High Risk Victims of Stalking

In the first year we aimed to assist between 200-250 victims. Over the past year we have seen an

increase in the number of victims referred and have supported and advocated on behalf 296 clients.

We have given advice to hundreds more professionals and victims and are now collecting data on this.

Referrals have been received from police, probation, Victim Support, third sector specialist support

services as well as self-referrals. Self-referrals are 47% of all our referrals, which is hugely encouraging

and illustrates our reach due to the significant media focus on Paladin and stalking.

We triage all cases and use a standardised specialist risk assessment model to inform this process. We

then complete a full assessment with the client and also collect data at intake and at closure of a case.

Although we advocate in all high risk cases, every client contacting us will be risk assessed and they

will then receive advice, signposting, a support package as well as a detailed safety plan

54% have been assessed as high risk

25% medium

21% standard risk.

We collect outcome data in order to understand our client's experience and journey. From our closed

cases, and where it has been possible to complete an outgoing assessment, we have extracted the

following data, which has been divided into three sections: Safety, Impact and Training.

Safety

Overall we seek to increase the safety and well-being and reduce isolation for victims. This is achieved

through improved identification and recognition of stalking as a serious crime, improved responses to

victims when stalking is reported, along with better identification of risk and effective risk management

interventions. In addition, improved emotional and psychological support to victims enhances their





sense of well-being and reduces isolation. As victims feel safer, they experience an improved quality of life. When they feel their 'lived experience' is believed and heard, this becomes a vital part of their empowerment process and emotional recovery.

From the completed outcome assessments, we know that 69% (N=38) of our clients felt safer upon closure and 58% (N=32) experienced an improved quality of life (Table 1). This is extremely positive and encouraging. Safety is paramount as well as understanding that the psychological impact of being stalked can manifest and continue long after the behaviours have ceased.

Each client has an extensive and bespoke safety plan, which is reviewed if there is any change in risk or circumstance. What is perhaps most significant is that 93% (N=51) of clients felt confident to access services and 88% (N=42) felt able to make plans and manage risks for themselves upon closure of the case. This again is very encouraging and positive.





#### Impact of Our Casework

Our second key outcome is that victims will experience less severe stress levels and feel less isolated on closure of their case. Importantly 58% (N=32) experienced an improved quality of life, 69% (N=38) felt safer on last contact with us, 76% (N=42) experienced a cessation of abuse and 85% (N=35) a reduction in risk.

Training and Intervention by Paladin

Our third key outcome is that victims will benefit from better informed and trained criminal justice professionals as a consequence of our interventions and training packages. The impact and outcome measurement evaluation measures whether high risk victims experienced greater levels of satisfaction

with the criminal justice system response as a result of Paladin intervention.

We have found that 67% (N=36) clients felt that Paladin's intervention led to a better response from professionals, which is positive. We would like to see this improve and there are some agencies who have been particularly slow to change who were highlighted in our report 'Stalking Law Two Years On'. Additionally, our clients do not always know the extent of our discussions with other professionals behind the scenes. However, importantly, 91% (N=49) were satisfied with the response and service that

they received from us.

Paladin's intervention has led to an increased number of victims feeling supported and getting appropriate advice as well as many more who were much more confident to access services and in

some cases our intervention resulted in a cessation in abuse and a positive outcome for the client.

B. Raise Awareness of Dangers and Risks of Stalking

Having set up and co-ordinated the first National Stalking Awareness week in 2011, we fully recognise

the need to do much more to raise the profile of stalking and change society's attitude to stalking.

Paladin works closely with the media to promote key messages on stalking including newspapers, magazines, TV and radio. Our records show that we have had over 60 media 'hits' in the last year including the Telegraph, Independent, Mirror, Guardian and Daily Mail, International Business Times and our magazine coverage has been extensive magazines including Take a Break, Cosmopolitan, Closer and Marie Claire. We have also participated in many radio and TV interviews including ITV London News on July 3rd. In the short time we have existed we have become the 'go-to service ' for

media comment on stalking.

We also proactively engaged with the media to ensure extensive coverage across the last year for our DV Law Reform campaign. As a result of this successful campaign domestic abuse, coercive control and the pattern of abuse was criminalised on March 3 2015 when the Serious Crime Bill received Royal

Assent.





Our second campaign calling for a register for serial stalkers and domestic violence perpetrators has also attracted widespread publicity throughout the past year. This has involved extensive newspaper and magazine articles, as well as radio and TV interviews and debates in both Houses of Parliament.

Strong partnerships are very important and we have run successful partnership events with other services including 'Behind Closed Doors' with City of London Police and Victim Support and 'Turning the Tables on the Stalkers' with leading cyberstalking lawyers, Collyer Bristow. Over 200 professionals including senior managers and human resources personnel attended 'Behind Closed Doors' which was held in the Livery Hall at the Guildhall in November 2014. The aim was to raise awareness of workplace DV and stalking and signpost delegates to best practice to support their employees. The conference was opened by Commander Wayne Chance and Lord Mayor Alderman Alan Yarrow gave the closing address. There were some inspiring speakers at the event including Paladin ambassadors John and Penny Clough, Fiona Bowman a survivor of domestic abuse and we gave a speech on Stalking in the Workplace. The feedback from those who attended was excellent with 87% saying they found the event useful, 100% would recommend it to others.

#### Feedback included:

- 'Incredibly powerful session that makes you think and want to act' (British Airways).
- 'A great session that I would recommend to any HR professional. It has made me think about how I should respond to a victim or perpetrator of domestic abuse of stalking as an employer' (American Express).

Paladin received a wonderful letter of thanks from Commander Wayne Chance of the City of London Police highlighting how important our partnership working is and that we were vital to the success of the event. We are now organising another event to be held at Mansion House on October 27.

The 'Behind Closed Doors' brand and theme was used for an event in Gloucester on June 16 by Nick Gazzard, father of Hollie Gazzard, who was murdered by her stalker. Nick had attended the London event and approached his Police and Crime Commissioner, Martin Surl, to run one in their area. More than 200 professionals attended. I was asked to give an opening address and we had a stand at the event too. We launched our new workplace package and gave an interview to BBC Radio Gloucester. We also attended and had a stall at the IFSEC International conference at Excel on June 16 and engaged attendees about the need for a workplace policy and our new workplace package.

In November 2014 we organised a seminar in partnership with Collyer Bristow, leading lawyers on cyberstalking called 'Turning the tables on the stalkers'. Speakers included two of our clients, Nadine Dorries, MP, and Betsy de Thierry, who highlighted their experience of stalking, Alison Morgan, prosecutor in Stella Creasy, MP, and Caroline Criado Perez case, Dr Claire Hardaker on her research paper on 'Online Threats and Misogyny'. I delivered a presentation on the online and offline risks of





stalking. The event was an excellent opportunity to discuss the effects of cyber stalking online. Our new Digital and Cyberstalking leaflet was launched at this event and was very well received.

Paladin continues to be invited to attend and present at key events across the UK to raise awareness of stalking and the work of our service. On November the 25th I gave a keynote address at a conference in Enfield as part of the White Ribbon Campaign. Later in the afternoon I attended an event at the Safenet AGM in Burnley and gave a keynote address to over 50 attendees in the council chambers. Our Chair, Rachel Horman, gave a presentation at a conference in Haringey about coercive control and the new legislation, which was very well received.

Given our connection with National Stalking Awareness Week, Paladin were proud to support the 2015 campaign which started on 20<sup>th</sup> April with the theme "What is Stalking?" Paladin held a tweet-a-thon across the week with different themes each day. The daily themes were:

- Monday 20 April: Stalking Behaviours -highlighting different stalking behaviours including direct and indirect, online and offline
- **Tuesday 21 April**: Stalkers –highlighting the typologies and characteristics of stalkers and perpetrators by examining what more can be done to risk assess and risk manage them.
- **Wednesday 22 April**: Know the Law, Use the Law highlighting the legislation and showing how this should be used more effectively to better protect victims.
- Thursday 23 April: Training We ran a national training day. Training is essential in order to
  identify the behaviours and dynamics of stalking, understand both online and offline risks, the
  typologies of stalkers and legislation. We also highlighted our University Accredited
  Independent Stalking Advocacy Casework Qualification.
- Friday 24th April: Sentencing examining the current landscape regarding charging and sentencing for stalking and what more can be done, as well as why we are calling for serial stalker's register which has already attracted over 125,000 signatures.

We highlighted the findings from our 'Stalking Law Two Years On' Report November 2012 – November 2014 and encouraged followers and professionals to join in the conversation. It also meant that many victims were able to gain information and use our tools that may well be lifesaving. Our research findings were published in the Sunday Mirror, the Independent and Cosmopolitan magazine.

We continue to increase the distribution of our quarterly e-newsletters, which are now downloaded to more than 1500 supporters. It includes updates and news as well as forthcoming training events. We also contribute to other services newsletters such as Safe Lives (formerly known as CAADA) and we regularly use social media and posts to promote our service, campaigns, training and events, as well as blogs in the Huffington Post.





We have also developed advice leaflets for victims, police and other agencies and our new leaflet on cyber and digital stalking has been very well received. We take them to all our events and also send them out to professionals and services. We also have posters, bags and pens to increase our brand awareness and continuously look at new ways of getting the key messages out as well as marketing our service.

Our website has just been updated and refreshed. It includes comprehensive information about our referral process, service information and advice for victims and professionals as well as the leaflets which can now be downloaded.

We have developed a new workplace package for businesses which outlines their legal obligations to support and protect staff and individuals as well as policy, implementation guide, a safety audit amongst other practical tools to assist. More information about this is on our website.

#### C. Provided Training to Professionals

Training is vital to ensure more professionals identify stalking earlier and are able to respond appropriately. Between July 2014-July 2015 Paladin delivered over 40 training sessions to 2500 professionals including police, CPS, IDVAs and specialist support services, probation, magistrates, Victim Support, probation and trade unions. Feedback is consistently positive with 98% of participants rating the training as either 'Good' or 'Excellent'.

Of note we were delighted to deliver:

- 10 training sessions to more than 1200 City of London Police staff and two sessions on DASH risk assessment between January and March
- 5 training sessions to 266 police officers in Devon and Cornwall Police
- 2 sessions to 50 Surrey Police
- 3 sessions to Thames Valley Police
- 150 police staff in Cleveland Police
- 50 Hertfordshire Police
- 70 Magistrates and Judges at Buckinghamshire Magistrates Association
- 50 CPS staff
- 60 safeguarding professionals in the Catholic Church
- 25 Refuge.

We are delighted that our new and pioneering ISACs training course was accredited by the University of Brighton last year. The first course ran between September - November 2014 and was a huge success. 13 new ISACs were accredited from various services across the country. Our next course is planned for September. This training enables Paladin to professionalise the sector and establish a network of accredited ISACs across the UK who are satellites to the national service. This will enable us to reach and assist more victims locally and reduce levels of isolation.

We have been proactive in offering training and due to demand we are growing a network of Associate trainers. Our new Associates, who are already renowned and cutting edge trainers, share our passion and vision and will help us roll out Paladin's key messages.

Paladin were delighted to be asked by the College of Policing to sponsor an award for a police officer who had gone the extra mile for victims of stalking and present it in October 2014 at their awards event as well as deliver a presentation on stalking and harassment. DC David Thomason, Cheshire Police was awarded for his outstanding partnership work keeping victims of stalking and Sharon Stratton, College of Policing for her outstanding dedication and commitment to homicide prevention. The day was opened by DCI Steve Jackson, National Domestic Abuse Co-ordinator at the College of Policing and I also addressed the 50 officers who attended. It was an inspiring day with many individuals receiving recognition for outstanding work on domestic violence and stalking.

#### D. Campaigning on Behalf of Victims

After establishing the All Party Parliamentary Group (APPG) on Stalking and Harassment last year, there have been four meetings. The main focus of the APPG was Paladin's campaign work including cyberstalking, restraining orders, abuse of the Family Courts and assessment and treatment for stalkers. Across this time Paladin has drafted and submitted more than 21 briefings papers on stalking, as well as a paper on the register for serial stalkers and DV.

#### **Our Campaigns**

#### Domestic Violence Law Reform Campaign

Paladin, Women's Aid and Sara Charlton Foundation joined together to campaign for a legal framework that effectively criminalises domestic violence. By criminalising this form of violence and having





specialist legislation, similar to the stalking law introduced in 2012, it sends a message that abusive and coercively controlling behaviour within a relationship is unacceptable and will not be tolerated and signals a much needed cultural change.

Our DV Law Reform Campaign had victim's voices at the heart of it. We campaigned and changed law in less than 12 months. We were told this is the shortest campaign in the history of Parliament. Coercive control has now been criminalised, with the Serious Crime Bill received Royal Assent on March 3 2015, and with the right training and implementation will afford significant protection to victims at a far earlier stage. In a short time we have achieved long lasting and significant change.

#### Register for Serial Stalkers and Domestic Violence Perpetrators

Paladin is calling for a register of serial stalkers and domestic violence perpetrators. The register was a recommendation in the All Party Stalking Law Reform report in 2012 and we know through our work that there is no existing framework to track or monitor serial domestic violence perpetrators and stalkers. Rather than the perpetrator being effectively controlled and managed, often we see that it is the victims who are forced to modify and change their behaviour.

We believe that there should be an order that places a positive obligation on the perpetrator:

- stalking perpetrators (those who have had an intimate relationship and those who have not) as well as domestic violence offenders who meet the criteria;
- protection for potential future victims, through tracking, monitoring/supervision;
- imposing positive obligations and responsibility on the serial perpetrator;

In order to meet the objectives outlined above primary legislation is required to permit the regulation and 'tracking' of serial perpetrators of violence. Notification requirements and prohibitions placed would be akin to that of a Registered Sex Offender. Offenders would be placed on 'VISOR' (Violent and Sexual Offenders Register) and similar to other sexual and violent offenders are subjected to robust proactive supervision, monitoring and management. This would ensure protection to primary, secondary and potential future victims. This would impose positive obligation on a perpetrator creating a much needed cultural change and placing the emphasis and responsibility back on the perpetrator, ultimately saving lives and money.

John Clough and Pam Treloar whose daughters Jane and Kirsty were murdered by a serial stalker are spearheading the campaign for the register. We launched a petition in July 2014 and to date 124, 694 people have signed the petition <a href="https://www.change.org/p/rt-hon-theresa-may-mp-create-a-stalker-s-register">https://www.change.org/p/rt-hon-theresa-may-mp-create-a-stalker-s-register</a> There have also been debates in both Houses and Paladin have written numerous briefings for Parliamentarians. On 28th October 2014, amendments to the Serious Crime Bill, which included strengthening the law around domestic violence and specifically, the need for a serial stalker and perpetrators register were debated in the House of Lords I met with Parliamentarians to advise on this





subject using both Paladin and national data as well as writing briefings. Read the <u>full Hansard paper</u>. The Bill was debated again on the 20<sup>th</sup> January with a powerful speech by Seema Malhotra, MP, including acknowledgments and mentions of Paladin. The Hansard can be read <u>here</u>

On 17<sup>th</sup> December 2014, Mayor Boris Johnson pledged support for the campaign in a meeting at the General London Assembly. He stated that he was "supportive" of adding stalkers and violent spouses onto sex offender register and would consult experts I also was invited on London Live to talk about our campaign. There have been more than 15 newspaper articles on this across this year alone and we will continue to campaign and lobby for this.

#### E. Post Legislation Scrutiny

We continue to scrutinise the use of the legislation through our casework and have published numerous reports including six months, one year and more recently two years on from the stalking law. November 25 2014 marked the two year anniversary of the stalking laws being introduced. We released our report 'Stalking Law Two Years On' to mark International Women's Day in March 2015 and it was highlighted by the Sunday Mirror, Independent and Cosmopolitan who all published detailed articles on our findings and recommendations.

#### Key headlines include:

- Only 1% of stalking cases result in a charge and prosecution by the CPS. Many fail to understand or identify stalking behaviour and without specialist training this will sadly continue.
- Currently there are still no sentencing guidelines for stalking cases in England and Wales despite the law change. We have raised this in Parliament and with the Sentencing Council as a major concern. Consequently this results in unduly lenient sentences.
- There is still a lack of perpetrator programmes and treatment available for stalkers.

We were invited to present our findings and recommendations at a 'roundtable' organised by the CPS. The recommendations have been agreed and we are working closely with the CPS to take them forwards, which is hugely encouraging. We also have been proactively highlighting lessons learned from high risk cases with strategic leaders in agencies when critical issues arise.

#### F. Develop a Victim's Network of Support

During the Stalking Law Reform Campaign, and in the early stages of Paladin, it was clear that there was no arena for victims of stalking to empower and provide mutual support for each other. Therefore, it was one of Paladin's key objectives to develop a network of victims who could offer each other support and should they wish, become more involved in the work of Paladin. Helping to develop the mutual support group was a group of Paladin clients and ambassadors who helped with key issues arising from this project. The first Paladin Victim Network Reference Group meeting was held last year. The objective of this network was to:

- Establish a network of victims who want to work with others, to offer mutual support and empowerment to those also working with Paladin
- Establish national sessions run by the reference group victims who are local to the session, to
  offer empowerment sessions and support/advice in person
- Further develop a network of victims in order for them to become self-supporting and, should they wish, be more engaged in the governance of the organisation.

Two meetings were held this year and an evaluation by the University of Kingston. Following feedback from the group session with clients we are now taking this forward.

We also now maintain a network of clients who are willing to speak out in the media as well as attend training days and many say this is empowering, supportive and validating in itself to be given a wider platform to galvanise momentum trough awareness training.

### 3.Conclusion

It has been an incredibly busy year and it is hard to believe that we are only two years old! The achievements of the service are a real testament to the strength of the Paladin team and Board. Our staff remain committed and focused on assisting, advising and advocating on behalf of victims of stalking and their dedication to this has been unwavering.

We are excited to be growing a new network of associate trainers to meet the training demand and we will continue to deliver training to improve the response to victims of stalking by front line providers. We also continue to grow our ISAC professional network across the UK and will be delivering another accredited course in September. We continue to use a range of high profile national and local media to increase public awareness of our campaigns, the impact of stalking and our unique service.





We are very proud to have been part of the successful Domestic Violence Law Reform Campaign and continue to work with our partners and government to ensure that training and guidance is fit for purpose. The campaign was nominated for Westbourne's Change of Opinion Award in March 2015. Additionally, we were also finalists at the Suzy Lamplugh 'Take Stalking Seriously' Awards. Finally, I was honoured and excited to be voted one of the top ten women in business at the Marie Claire Award in October 2014. Paladin and some of our clients and supporters were featured in both the November 2014 and January 2015 issues of the magazine. This again was fantastic coverage for the service and our work.

Paladin is the only service of this kind in the UK and the world and we must ensure victims have a service of this quality in the future. To this end we have commissioned an independent university evaluation. Early indicators show that we have assisted hundreds of victims and continue to run an effective and quality service. The evaluation will be published in October 2015. We would like to thank and acknowledge all our partners, funders and supporters who have made our invaluable work possible.

We look forward to the next exciting chapter ahead.
