This is the privacy notice of Euro Channel Logistics (U.K.) Ltd. In this document, "we", "our", or "us" refer to Euro Channel Logistics (U.K.) Ltd

Introduction

1. This is a notice to inform you of our policy about all information that we record about you. It sets out the conditions under which we may process any information that we collect from you, or that you provide to us. It covers information that could identify you ("personal information") and information that could not. In the context of the law and this notice, "process" means collect, store, transfer, use or otherwise act on information.
2. We regret that if there are one or more points below with which you are not happy, your only recourse is to leave our website immediately.
3. We take seriously the protection of your privacy and confidentiality. We understand that all visitors to our website are entitled to know that their personal data will not be used for any purpose unintended by them, and will not accidentally fall into the hands of a third party.

7. Except as set out below, we do not share, or sell, or disclose to a third party, any information collected through our website.
8. The term 'website' may refer to any of the internet platforms which are officially established by Euro Channel Logistics (U.K.) Ltd.

The bases on which we process information about you

The law requires us to determine under which of six defined bases we process different categories of your personal information, and to notify you of the basis for each category.

If a basis on which we process your personal information is no longer relevant, then we shall immediately stop processing your data.

If the basis changes then if required by law we shall notify you of the change and of any new basis under which we have determined that we can continue to process your information.

1. *Information we process because we have a contractual obligation with you*

When you create an account on our website, buy a product or service from us, or otherwise agree to our terms and conditions, a contract is formed between you and us.

In order to carry out our obligations under that contract we must process the information you give us. Some of this information may be personal information.

We may use it in order to:

- 1.1. verify your identity for security purposes
- 1.2. sell products to you
- 1.3. provide you with our services

3. *Information we process because we have a legal obligation*

Free speech is a fundamental right, so we have to make a judgment as to whose right will be obstructed: yours, or that of the person who posted the content that offends you.

6. *Information relating to your method of payment*

Payment information is never taken by us or transferred to us either through our website or otherwise. Our employees and contractors never have access to it. Our usual methods of payment are either by electronic transfer or by cheque. Whichever method you choose, we shall not record the details of the sending account.

7. *Information about your direct debit*

When you agree to set up a direct debit arrangement, the information you give to us is passed to our own bank Nat West, Royal Bank of Scotland group for processing according to our instructions. We do keep a copy.

We are registered under the direct debit guarantee scheme. This provides for the customer's bank to refund disputed payments without question, pending further investigation. Direct debits can only be set up for payments to beneficiaries that are approved originators of direct debits. In order to be approved, these beneficiaries are subjected to careful vetting procedures. Once approved, they are required to give indemnity guarantees through their banks.

8. *Job application and employment*

We use that information to resolve your complaint.

Use of information we collect through automated systems when you visit our website

12. *Cookies*

Cookies are small text files that are placed on your computer's hard drive by your web browser when you visit any website. - 12.1. to track how you use our website
- 12.2. to record whether you have seen specific messages we display on our website
- 12.3. to keep you signed in our site
- 12.4. to record your answers to surveys and questionnaires on our site while you complete them
- 12.5. to record the conversation thread during a live chat with our support team

13. *Personal identifiers from your browsing activity*

Requests by your web browser to our servers for web pages and other content on our website are recorded.

We record information such as your geographical location, your Internet service provider and your IP address. We also record information about the software you are using to browse our website, such as the type of computer or device and the screen resolution.

We use this information in aggregate to assess the popularity of the webpages on our website and how we perform in providing content to you.

If combined with other information we know about you from previous visits, the data possibly could be used to identify you personally, even if you are not signed in to our website.
