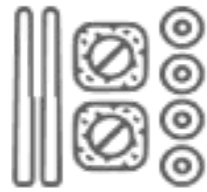

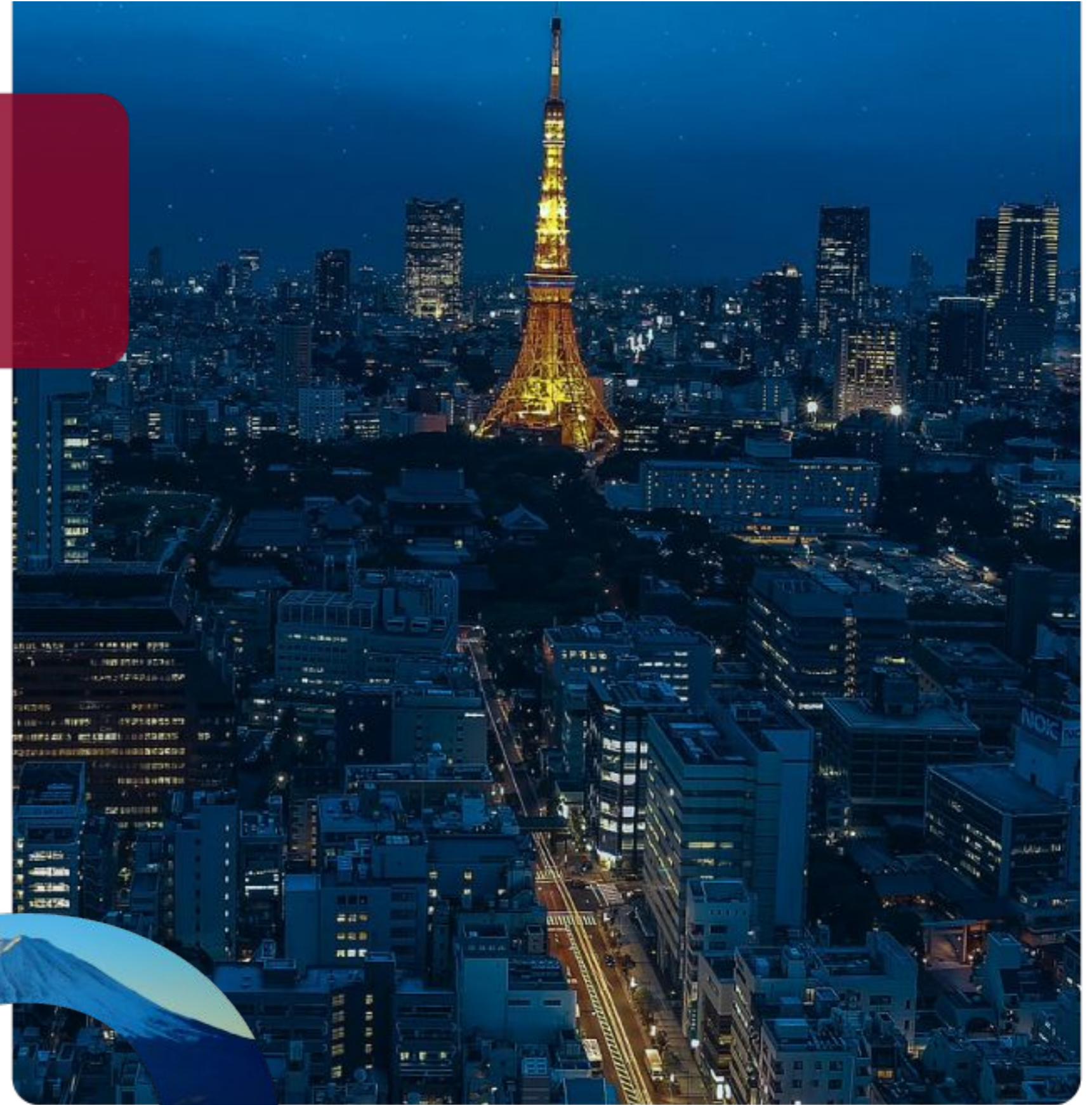

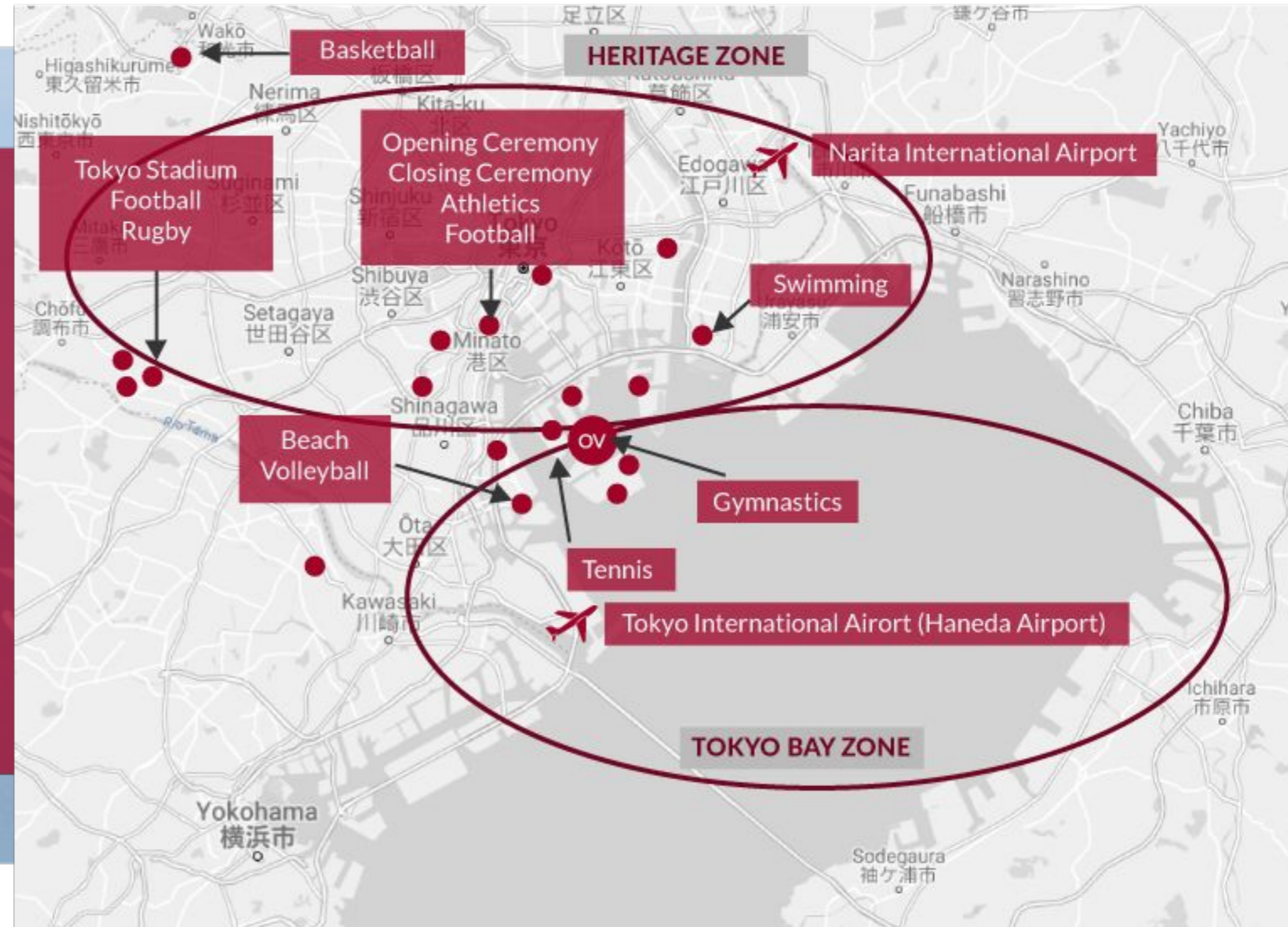


VENUES MAP
