The Home Office publish a comprehensive list of their application fees which it would not be appropriate to publish here, but which can be accessed <u>here</u>.

Please note, the list does not include the Immigration Health Surcharge which we will calculate according to your personal circumstances and include among the disbursements payable.

In addition, where translation and/or interpretation services are required, we will provide you with a quote for you to consider before we engage the third party supplier.

Typical timescales and key stages

In our experience the vast majority of out of country applications are decided within 4 weeks, although some family-based applications can take longer (up to 12 weeks).

Processing times for in-country applications can vary depending on whether they are submitted as standard (up to six months, though usually no more than 3 months) or priority (within a few days, with payment of an additional Home Office fee).
