viscosity.

Brush Apply to recommended film thickness.

Cleaner Thinner No.3

Do not use on surfaces likely to be used by bona fide persons. We recommend applying the product at least 2.3 m. (7 feet) above ground level.

Do not apply other surface coatings over PC99.

To remove this coating use scrapers and wash surface with Thinner No.3
