Founded in 2003, the Health and Environment Alliance (HEAL) is a leading European not-for-profit organisation addressing how the environment affects health in the European Union (EU).

With the support of more than 65 member organisations, HEAL brings independent expertise and evidence from the health community to different decision-making processes. Our broad alliance represents health professionals, not-for-profit health insurers, doctors, nurses, cancer and asthma groups, citizens, women's groups, youth groups, environmental NGOs, scientists and public health research institutes. Members include international and Europe-wide organisations, as well as national and local groups in 25 countries.

Our organisation's vision is a healthy planet for healthier people in Europe and beyond. HEAL's advocacy and awareness-raising work aims to show how environmental action can bring down rates of asthma, obesity, diabetes, cancer and infertility.

HEAL has a strong track record in increasing public and expert engagement in EU and World Health Organization (WHO) debates and decision-making processes on environment and health.
