Safe, level location for erection of roundabout, not liable to subsidence.	Event organisers to allocate safe location for erection of Toy Set Roundabout
Manual Handling	Operators	Back injury. Strains/sprains, Impact injuries.	Fitness for task. Competency in operation of handling equipment and manual handling practices. SSW. Mechanical aids. Test certificate. Inspection of equipment.	None
Slips, trips, falls	Members of Public, operators, users of equipment	Strains/sprains, cuts and abrasions, head injury, dislocation, fracture, unconsciousness.	No food or drink allowed on structure. Safety signage. Regular housekeeping on and around structure. Safe removal of obstructions/trip hazards. Inspections. Correct erection of equipment as per SSW, Monitoring of users behaviour and ability. Restrictions on users height, etc. Discouragement of over exuberant behaviour.	Event organisers to regularly remove any waste which may present slip/trip hazards around equipment during course of event

Hit fixed objects	Members of Public, operators, users of equipment	Strains/sprains, cuts and abrasions, head injury, dislocation, fracture, unconsciousness.	Safe supervision of all users. Safe use of Equipment i.e. use toys, Restrictions on access to underside/outside of structure. Designated walkway around the roundabout. .	None
Hit by moving/flying/falling objects	Members of Public, operators, users of equipment	Strains/sprains, cuts and abrasions, head injury, dislocation, fracture, unconsciousness.	Safety signage. Time limits on use of equipment. Safe erection of structure according to SSW. Designated walkways. Restrictions on number of users allowed on structure . Monitoring of user's ability/behaviour – restrict access of those users who's behaviour is deemed to be inappropriate/impaired/dangerous by Management. Restrict movements of users – ensure no running. Discourage dangerous movements; remove users from equipment who do not comply with Management instructions / rules.	None
Entrapment / entanglement	Users of equipment	Strains/sprains, cuts and abrasions, dislocation, fracture.	Restrict users from wearing of any jewellery, clothing, etc, which may become entangled on structure.	None
Fire	Members of Public, operators, users of equipment	Minor / major burns. Smoke inhalation. Death.	Restrict smoking on structure, and disposal of smoking materials on or around structure. Regular housekeeping. Provision of fire fighting equipment to be kept by any Generators	Event organisers to provide safe means of disposal of smoking materials. Housekeeping of area – provide safe methods for disposal of any waste materials which may burn
