The laws of the state of Ohio shall be applicable to all suits arising under any agreement between the Seller and the Customer. In the event of litigation, venue shall be in Montgomery County, Ohio.

The Seller is authorized to obtain reports to be used in connection with this application and to obtain further credit information from any of the persons or firms set forth in this application and from any other source.
