

Private Dining Room Information & Rental Contract

Capacity:

Our private dining room seats 40 people. The room can be configured in a variety of ways, including: 2 or 3 long tables, groupings of 4 or 6, a T shape, horseshoe, circle, etc...

Room Fees:

Black Sheep Coal Fired Pizza charges a 4% house fee (see House Fee) and food and beverage minimums (see table below) rather than a standard room rental fee.

Menu:

All food and beverage must be purchased and/or prepared by Black Sheep Coal Fired Pizza. There is an exception for dessert brought in for special events. If a dessert is brought into our private dining room, there is a \$10 flat fee plus \$0.50 per person fee for cutting and plating.

Our regular menu is used in the private dining room. We do offer enhancements, such as flowers and linen tablecloths/linen napkins. Please let us know if you would like any enhancements listed or have any of your own ideas. We will do our best to accommodate you.

Food is served "family-style" with ordered selections placed on each table. We also offer a buffet for groups of 25 or less. Please let us know which way you prefer, or if you have an alternative preference.

Please note that your finalized menu and enhancements must be emailed to us at least 48 hours prior to your event.

Room Availability and Seating Times:

Four seating times are available 7 days per week: 2 during the day, and 2 at night. Our private dining room is held on a first come-first serve basis and is reserved only when a deposit is received.

Minimum Food and Beverage Guaranty:

The minimums listed are neither a pricing structure nor do they affect the menu costs; they are simply an amount you agree to spend on food and drink in exchange for the use of the private room. Please note that tax, gratuity, and house fee do not apply toward the minimum.

House Fee:

There is a 4% house fee for our private dining room which is added to your bill at the end of your gathering. This fee goes to the restaurant for supplies and maintenance.

Payment Policy:

A \$100.00 credit card deposit is required to hold the room. It is not charged unless there is a cancellation issue or damage done to the room. To ensure quality service for you and your guests, all food and beverage is on one tab and final payment must be paid in full with no more than 4 combinations of cash/credit cards. Please note that exceptions may be possible depending on your menu choices. We accept Visa, MasterCard, Discover, and American Express.

Cancellations:

For a full refund of your deposit, cancellations must be submitted via regular post or email to a manager of Black Sheep Pizza Minneapolis – North Loop in writing at least 15 days prior to your event. Cancellations within 14 days of your event forfeit deposit. Cancellation within 7 days of your event will result in the full charge of the minimum food and beverage guaranty. If we are able to rerent the space, we will return the difference between the guaranteed minimum and the deposit to

you. You must receive a return email or call confirming cancellation. Thank you for your understanding.

Decorations:

We welcome you to decorate the room. Decorations must conform to fire and safety codes. Please take any decorations with you when you leave. No confetti, please.

Illegal activities:

None allowed.

Parking:

Parking is available through the valet on Washington Avenue across the street from Black Sheep Coal Fired Pizza. If you would like to set up/pay for valet parking for your guests in advance, please contact Class A Valet at 612-865-1747. Metered street parking is also available.

Damage to party room:

Guest will be held liable for any unusual damage to the room or its contents.
