Everyone at HVA and the wider voluntary sector was saddened to hear of the death of Ambrose O'Boyle recently after a brief Illness.


Ambrose was a real force for justice, equality and inclusion. A tireless advocate for LGBT rights and someone who had enormous experience in the field of health and social care.

awareness within the communities of Hastings, Bexhill and Littlestone (Kent) of the changing standards for our sea bathing water quality being brought in by the European Union in 2015 and what we can all do to ensure that we meet the standard.

If we don't meet the standard we will see notices along the foreshore warning residents and visitors that the sea is not safe to bath or paddle in, which could have dire consequences for our tourist and fishing economy for years to come.

#### The Hastings Greenway Project:

Representatives from Hastings Urban Bikes (HUB) and the local Ramblers with Health Service input formed the Hastings Greenway Group in November 2012 to resurrect the drive to create the Greenway network.

This was actually designed in 2003 but very little progress was made in the ensuing years. The Hastings Greenway, which forms a largely trafficfree network of leisure, amenity and utility walking and safe cycling routes, which will also be accessible for people with disabilities, was widely publicised in the Hastings Observer in 2012 attracting support from many individuals and organisations. It would bring huge benefits for sustainable and cheap transport, health and fitness and social opportunities.

The planned routes run from the Town Centre to Ore, Silverhill, Hollington & Mayfield and the Conquest hospital.

The draft Hastings Local Plan includes a network of proposed cycle routes that mostly follow the alignment of the Greenway route and a Cycle & Walking Strategy is currently being drawn up by East Sussex County Council and Hastings Borough Council with HUB and Ramblers involvement.

### **Consultation on Draft Southern** Water Business Plan

This important consultation is now live until 22 September 2013.

The business plan sets out proposals for future services, which would cost in the region of £3 billion to deliver, These proposals include a range of promises about what will be achieved by Southern Water by 2020. Among these promises are the following, which focus on the areas where customers have said they want to make significant improvements:

- Providing customer service which is responsive and tailored to customers' individual needs, with 90 per cent of queries resolved the first time customers get in touch by 2020
- Achieving a 25 per cent reduction in sewer flooding inside homes and businesses by 2020
- Achieving a 15 per cent increase in the number of beaches with excellent bathing water quality in the region

HVA members will be aware of our interest in Hastings achieving the new EU Bathing Water standard in 2015. If you are making a response you may wish to advocate for Hastings to be among those beaches receiving infrastructure support to have excellent bathing water.

Hastings Voluntary Action have convened a meeting of local interest parties including carers groups, local Councillors, the Old Town Residents Association, the Hastings and St Leonards Seniors Forum and Age UK (East Sussex) to discuss the

consultation. The consultation closes on 14 October 2013 and will be of interest to all groups supporting Older People in the local area.

Speaking after the meeting HVA's Director Steve Manwaring said:

"We all appreciate the difficult financial decisions faced by Adult Social Care but cannot over-emphasise the importance of this consultation as it embraces options which could result in the closure or reduction of current services. We will be making our own response together with the Hastings Community Network but would urge all groups to brief themselves on this issue and respond to the consultation."

East Sussex County Council are also running a related consultation on dementia care services, with the same deadline of October 14th. They want views about their proposals for changes to the way longterm residential, respite and emergency care services are provided for people with dementia in the Hastings area.

### Lobbying Bill – Will it affect Charities?

Since the Transparency of Lobbying Bill was introduced to Parliament before Summer Recess, most of the attention has been on the proposals to regulate lobbying and to set up a register of lobbyists. However within the detail of the bill which is a section which introduces new rules on 'nonparty campaigning' during election time, which could be cause for concern for Charities.

Crucially, the bill introduces a definition of 'activities for election purposes' which is so broad and unclear that it could capture a range of the day-to-day activities charities carry out, entirely legitimately, as part of their campaigning and advocacy work. Furthermore, the limits of expenditure for carrying out such activities have been drastically reduced, in some cases by up to 70%.

Staff costs are to be included in these amounts, even though political parties are not expected to do the

same. Charities are already bound by charity law and therefore cannot be party political. But these changes would be likely to put the frighteners on charities that campaign on important issues and may want to use election time as an opportunity to raise awareness.

HVA have written to Hastings MP Amber Rudd asking for the provisions of the Bill to be reviewed very carefully as this legislation could have some unforeseen consequences for the legitimate role of charities to campaign on behalf of their beneficiaries.

replaces the R68(i) Gift Aid and tax repayments claims form. Charities that submitted claims online are usually paid within three working days compared to 26 days using the old paper form. From 30 September 2013, HMRC will stop accepting Gift Aid repayment claims on R68i forms and users will be required to use the Charities Online service to make claims. HMRC is currently writing to all charities who have claimed Gift Aid in the last

three years to encourage them to sign up for the online service.

Charities Online introduced three new options for charities and CASCs to claim payments from HMRC.

- 1 Claim online
- 2 Claim using external software / own database
- 3 Claim using a paper form for charities without access to the internet a new paper form called ChR1 is available replacing the R68(i) form.

## **Funding for Young People**

Sussex Community Foundation have recently secured a donation from the Blagrave Trust to fund grants for activities with young people. This follows their creation of a stream of funding for older people's projects earlier in the year.

#### Switched on Hastings – Save Money this Winter!

Hastings Borough Council is launching a new scheme that could help residents bring down their gas and electricity bills just in time for Winter!

'Switched on Hastings' brings together residents who are interested in finding the best price for their energy. Once a large enough number have registered their interest in the scheme, energy companies then bid their lowest tariff in an auction to gain the new customers. The lowest tariff wins the auction and is offered to the residents.

#### Can anyone register?

Yes, the auction covers customers paying dual fuel

or electricity only, paper billing or online billing and those on pre-payment meter. As long as you pay your own household gas or electricity bills for your property, you can register!

You will need a copy of your latest energy bill to hand so you can enter details online of your current tariff and energy usage. If you are on a prepayment meter, you will need to provide an estimate of how much you spend. This information will help determine how much you could save if you switched to the winning tariff.

If you're not online, it's still possible to register see below for further information.

#### What happens after I register?

Two weeks after the auction date on October 16 2013, personal letters and emails will be sent to each registered resident explaining exactly how much they could save. There is no obligation to accept the offer and it's completely up to residents if they make the final switch.

Once you've accepted your offer, your new energy company will contact you within several weeks to guide you through the process of switching energy suppliers.

#### **Register now!**

Registration for our new scheme is now open and runs until midnight on the October 15 2013 Whilst registration is easiest online, local residents who don't have internet access can sign up at Community Contact Centre, Monday to Friday from 4.30 to 6pm. There will also be registration dropins at the Community Contact Centre, the Town Hall from 10.30am to 12.30pm on the following dates; 10th, 18th, 26th of September and 1st October 2013
